Director of Prevention and Planning, Sara Thode informed the Council that the Municipal Alliance Grant System (MAGS) went live in mid December. All users have received their log on IDs and are participating in webinars on how to use the new system and the FY25 planning process will go through MAGS.

Ms. Levy thanked the Council members for their input and support, the County Coordinators and Alliances for their good work despite the continued challenges and GCSUD staff for their strong work ethic, and to Neil Van Ess for his ongoing leadership.
