**Chapter Historical Note**

Chapter 16, Asbestos Licenses and Permits, was originally codified in Title 12 as Chapter 120, Asbestos Licenses and Permits. Chapter 120 was adopted as Emergency New Rules by R.1985 d.144, effective March 4, 1985, to expire May 3, 1985. See: 17 N.J.R. 741(a). Subchapter 1, General Provisions, Subchapter 3, Administration, Subchapter 4, Licensing of Employers, Subchapter 5, Requirements and Procedures for Obtaining an Asbestos Worker or an Asbestos Supervisor Permit, and Subchapter 7, Standards and Publications Referred to in this Chapter, were adopted as Emergency New Rules by R.1985 d.361, effective June 18, 1985, to expire August 18, 1985. See: 17 N.J.R. 1676(a). The provisions of R.1985 d.361 were readopted as R.1985 d.468, effective August 16, 1985. See: 17 N.J.R. 1676(a), 17 N.J.R. 2275(a).
