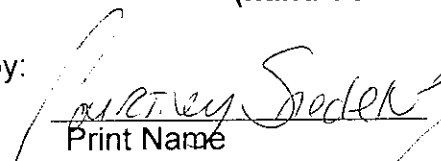

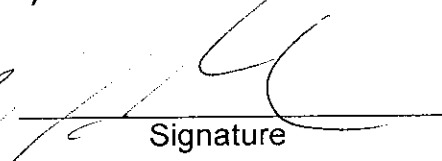

AWARD OF CONTRACTS

240-09-2017

In a document dated September 5, 2017, Recommendation to Award Contract No. T100.421, New Jersey Turnpike, Sparwick Contracting, Inc, Noise Barrier and Miscellaneous Repairs, Milepost 70 to 100, RM-134388, Budget Code: 030C10001, Funding Allocation: \$300,000.00, FY 2017, \$657,795.00 FY 2018, Amount \$957,795.00, was approved.

This Contract provides for repairs to six (6) damaged Noise Barriers and one damaged Mechanically Stabilized Earth (MSE) Wall along the Turnpike. All work is scheduled to be completed by 2018.

Six bid proposals were received on August 29, 2017 for the above publicly advertised contract, as shown on the attached bid summary sheet. The low bid proposal in the amount of \$957,795.00 may be compared to the second low bidder in the amount of \$1,071,413.00. The bids were significantly lower than the Engineer's Estimate in the amount of \$1,430,255.00 due to the Engineer's conservative cost estimate for the limited quantity noise wall work at multiple locations. The low bidder, Sparwick Contracting, Inc. has performed heavy highway construction work for the Authority and is considered competent to complete this contract.

It is, therefore, recommended that Contract No. T100.421 be awarded to the low bidder, Sparwick Contracting, Inc. of Lafayette Township, New Jersey, in the amount of \$957,795.00 which is allocated as follows: \$300,000.00 for 2017 and \$657,795.00 for 2018. This award is contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by the selected awardee, pursuant to Public Law 2005, Chapter 51 (formerly Executive Order 134) and Executive Order 117 (Corzine 2008), and having no objection to same. Bids for this work were procured, and the authorization being sought is to award this contract to the lowest

responsible bidder, in accordance with N.J.S.A. 27:23-6.1, N.J.A.C. 19:9-2.2, and Executive Order No. 37 (Corzine 2006).

The General Consultant, HNTB Corporation, concurs with this recommendation.

In a document dated August 29, 2017, Recommendation to Award Contract No. T600.417, New Jersey Turnpike, M.L. Ruberton Construction Company, Inc., Canopy Strengthening and Sign Installation, New Jersey Turnpike Toll Plazas, Milepost 26.1 to 110.8, RM-134393, Budget Code: 040C08157, Funding Allocation: \$ 840,000.00 FY2017, \$2,316,600.00 FY2018, Amount: \$3,156,600.00, was approved.

This contract will provide for the installation of the flip type canopy mounted signs at eleven (11) NJ Turnpike Interchange Toll Plazas. At Interchanges 3, 4, 7, 8A, 9, 10, 13A, and 15W, canopy structural retrofits are not required, only the additional signs will be installed. At Interchanges 13, 14 and 15X, structural retrofits of the canopy will be completed prior to the sign installations.

Seven bid proposals were received on August 25, 2017 for the above publicly advertised contract, as shown on the attached bid summary sheet. The low bid proposal in the amount of \$3,156,600.00 may be compared to the Engineer's Estimate in the amount of \$2,936,900.00. The low bidder, M.L. Ruberton Construction Company, Inc. has performed similar work for the Authority and is considered competent to complete this contract.

It is, therefore, recommended that Contract No. T600.417 be awarded to the low bidder, M.L. Ruberton Construction Company, Inc. of Folsom, New Jersey, in the amount of \$3,156,600.00 which is allocated as follows: \$840,000.00 for 2017 and \$2,316,600.00 for 2018. This award is contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by the selected awardee, pursuant to Public Law 2005, Chapter 51 (formerly Executive Order 134) and Executive Order 117 (Corzine 2008), and having no objection to same. Bids for this work were procured, and the authorization being sought is to award this contract to the lowest responsible bidder, in accordance with N.J.S.A. 27:23-6.1, N.J.A.C. 19:9-2.2, and Executive Order No. 37 (Corzine 2006).

The General Consultant, HNTB Corporation, concurs with this recommendation.

In a document dated August 29, 2017, Recommendation to Issue Order for Professional Services No. T3629, New Jersey Turnpike, Dewberry Engineers Inc., Supervision of Construction Services for Contract No. T600.417, Canopy Strengthening and Sign Installation, New Jersey Turnpike Toll Plazas, Milepost 26.1 to 110.8, RM-134483, Budget Code: 040C08157, Funding Allocation: \$ 150,000.00 FY2017, \$560,000.00 FY

2018, Amount \$ 710,000.00, was approved.

This Order for Professional Services provides supervision of construction services for Contract No. T600.417, Canopy Strengthening and Sign Installation, New Jersey Turnpike Toll Plazas, Milepost 26.1 to 110.8. Contract No. T600.417 will provide for structural modifications to various toll plaza canopies in order to install new signs at Interchanges 3, 4, 7, 8A, 9, 10, 13, 13A, 14, 15W and 15X.

This assignment is classified as a "Simple Project" based on the scope of work being clearly defined and not likely to change during the course of the project, and the cost not exceeding \$2,000,000.00. The solicitation for Expressions of Interest (EOIs) was posted on the Authority's website and thirty-five (35) engineering firms were prequalified and eligible under Profile Codes: B-153, Roadway Construction Inspection and B-159, Building Construction and Renovations Inspection. Seven firms submitted EOIs by the closing date of August 4, 2017.

Subsequent to the scoring of EOIs by the Review Committee, Fee Proposals were requested from the top three technically ranked firms. The firms in the order of ranking are: 1) Dewberry Engineers Inc.; 2) Boswell Engineering and 3) Gannett Fleming, Inc. The fee submitted by Dewberry Engineers Inc. has been reviewed and is considered to be fair and reasonable for the services to be provided.

It is, therefore, recommended that Order for Professional Services No. T3629 be issued to the firm of Dewberry Engineers Inc. of Bloomfield, New Jersey, in an amount not to exceed \$710,000.00 allocated as follows: \$150,000.00 in FY 2017 and \$560,000.00 in FY 2018. This amount includes reimbursement of direct salaries times a maximum multiplier of 2.35 to cover the cost of fringe benefits, overhead and profit, plus authorized direct non-salary expenses. The award is contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by the selected awardee, pursuant to Public Law 2005, Chapter 51 (formerly Executive Order 134) and Executive Order 117 (Corzine 2008), and having no objection to same. These professional services were procured, and the recommended firm was selected, in accordance with N.J.S.A. 52:34-9.1, et seq., N.J.S.A. 27:23-6.1 of the Authority's enabling legislation, N.J.A.C. 19:9-2.8, promulgated pursuant thereto, and Executive Order No. 37 (Corzine 2006).

In a document dated August 29, 2017, **Recommendation to Issue Order for Professional Services No. T3637, New Jersey Turnpike, AECOM Technical Services, Inc., Investigation, Preparation of Contract Documents and Remediation Oversight at Chromate Site 192, RM-134399, Budget Code: 040E00006, Amount: \$745,000.00**, was approved.

This Order for Professional Services provides for professional services of an environmental consultant to provide remedial activities including completion of pre-design investigations, preparation of construction contract documents and remediation oversight of the

selected contractor at Chromate Site 192 in accordance with current New Jersey Department of Environmental Protection regulations. Chromate Site 192 is located along the mainline just north of Interchange 15E. The term of the OPS is 4 years.

This assignment is classified as a "Simple Project" based on the scope of work being clearly defined and not likely to change during the course of the project, and the cost not exceeding \$2,000,000.00. The solicitation for Expressions of Interest (EOIs) was posted on the Authority's website and 37 engineering firms were prequalified and eligible under Profile Codes: C-195 Soil and Groundwater Remedial Investigation and C-196 Soil and Groundwater remediation design. Four firms submitted EOIs by the closing date of July 26, 2017.

Subsequent to the scoring of EOIs by the Review Committee, Fee Proposals were requested from the top three technically ranked firms. The firms in the order of ranking are: 1) AECOM Technical Services, Inc.; 2) NV5, Inc. and 3) TRC Environmental Corporation. The fee submitted by AECOM Technical Services, Inc. has been reviewed and is considered to be fair and reasonable for the services to be provided.

It is, therefore, recommended that Order for Professional Services No. T3637 be issued to the firm of AECOM Technical Services, Inc. of Piscataway, New Jersey, in an amount not to exceed \$745,000.00 allocated as follows: \$50,000.00 in FY 2017; \$185,000.00 in FY 2018; \$185,000.00 in FY 2019; \$185,000.00 in FY 2020 and \$140,000.00 in FY 2021. This amount includes reimbursement of direct salaries times a maximum multiplier of 2.59 to cover the cost of fringe benefits, overhead and profit, plus authorized direct non-salary expenses. The award is contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by the selected awardee, pursuant to Public Law 2005, Chapter 51 (formerly Executive Order 134) and Executive Order 117 (Corzine 2008), and having no objection to same. These professional services were procured, and the recommended firm was selected, in accordance with N.J.S.A. 52:34-9.1, et seq., N.J.S.A. 27:23-6.1 of the Authority's enabling legislation, N.J.A.C. 19:9-2.8, promulgated pursuant thereto, and Executive Order No. 37 (Corzine 2006).

In a document dated August 29, 2017, **Recommendation to Issue Order for Professional Services No. A3651, New Jersey Turnpike & Garden State Parkway, Mott MacDonald, Underground and Aboveground Storage Tank Compliance, Maintenance and Testing, RM-134400, Budget Code: 010-00-892-446050, Amount: \$685,000.00,** was approved.

This Order for Professional Services provides for professional services of an environmental consultant to provide underground and aboveground storage tank compliance, maintenance and testing services in accordance with current New Jersey Department of Environmental Protection regulations. Varying levels of these services will be completed at the Authority's Service Areas, Maintenance Districts, Toll Plazas and State Police facilities along the

Parkway and Turnpike roadways. The term of the OPS is 4 years.

This assignment is classified as a "Simple Project" based on the scope of work being clearly defined and not likely to change during the course of the project, and the cost not exceeding \$2,000,000.00. The solicitation for Expressions of Interest (EOIs) was posted on the Authority's website and 29 engineering firms were prequalified and eligible under Profile Code: C197 - UST Systems: Operation, Maintenance, and Compliance Monitoring. Only one firm, Mott MacDonald, submitted an EOI by the closing date of July 7, 2017.

Based on language provided in the Authority's Regulation N.J.A.C. 19:9-2.8 which states: "For all projects, if fewer than three EOIs are deemed complete, the EOI solicitation may be rewritten and/or re-solicited, or the procurement may continue with fewer than three firms, as determined by the Executive Director, in consultation with the Director." Authorization was granted to continue with the evaluation of the one EOI received. Subsequent to the scoring of the EOI by the Review Committee, a Fee Proposal was requested from Mott MacDonald. The fee submitted by Mott MacDonald has been reviewed, negotiated and is considered to be fair and reasonable for the services to be provided.

It is, therefore, recommended that Order for Professional Services No. A3651 be issued to the firm of Mott MacDonald of Iselin, New Jersey, in an amount not to exceed \$685,000.00 allocated as follows: \$5,000.00 in FY 2017; \$170,000.00 in FY 2018; \$170,000.00 in FY 2019; \$170,000.00 in FY 2020 and \$170,000.00 in FY 2021. This amount includes reimbursement of direct salaries times a maximum multiplier of 2.80 to cover the cost of fringe benefits, overhead and profit, plus authorized direct non-salary expenses. The award is contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by the selected awardee, pursuant to Public Law 2005, Chapter 51 (formerly Executive Order 134) and Executive Order 117 (Corzine 2008), and having no objection to same. These professional services were procured, and the recommended firm was selected, in accordance with N.J.S.A. 52:34-9.1, et seq., N.J.S.A. 27:23-6.1 of the Authority's enabling legislation, N.J.A.C. 19:9-2.8, promulgated pursuant thereto, and Executive Order No. 37 (Corzine 2006).

In a document dated September 7, 2017, **Recommendation to Issue Supplement A to Order for Professional Services No. T3462, New Jersey Turnpike, Michael Baker Jr., Inc., Design Services for Facilities Improvement Program - Turnpike North, RM-133941, Budget Code: 39005013, Original OPS Amount: \$8,900,000.00, Amount of Supplement A: \$800,000.00, Revised OPS Amount: \$9,700,000.00**, was approved.

This Order for Professional Services was approved at the July 2013 Commission Meeting in the amount of \$8,900,000.00 to provide for final design services for the Facilities Improvement Program.

Supplement A will provide for additional design services related to Turnpike Maintenance District 4 (Hightstown), 6 (Elizabeth) and 9 (Jersey City) for preparation of unanticipated supplemental documents for the New Jersey Department of Community Affairs, environmental testing and analyses due to unforeseen site conditions and post design services for attendance at construction meetings as a result of an extended construction duration and additional shop drawing reviews. Additionally, it will provide extensive coordination related to the installation of the proposed water main at Turnpike Maintenance District 4.

It is, therefore, recommended that Supplement A to Order for Professional Services No. T3462 be issued to Michael Baker Jr., Inc. not to exceed the amount of \$800,000.00 with compensation on the same basis as the original Order for Professional Services. The addition of this amount increases the total authorized fee from \$8,900,000.00 to \$9,700,000.00. The original contract was procured pursuant N.J.S.A. 52:34-9.1 et seq. and N.J.A.C. 19:9-2.8.

In a document dated August 24, 2017, **Recommendation to Issue Supplement B to Order for Professional Services No. P3460, Garden State Parkway, T.Y. Lin International, Design Services for Facilities Improvement Program – Parkway North, RM-133648, Budget Code: 39005013, Original OPS Amount: \$6,200,000.00, Amount of Supplement A: \$580,000.00, Amount of Supplement B: \$830,000.00, Revised OPS Amount: \$7,610,000.00,** was approved.

This Order for Professional Services was approved at the July 2013 Commission Meeting in the amount of \$6,200,000.00 to provide for final design services for the Facilities Improvement Program.

Supplement A provided for design and post-design services to construct a pre-engineered metal building at the Telegraph Hill Maintenance District 5 in Holmdel and a 4,500 ton salt shed facility at Garden State Parkway Montvale Service Area in Montvale, which were not in the original scope of work. These services included building and salt shed design, associated site improvements, utility coordination and permitting as required.

Supplement B will provide for environmental remediation design services required at PMD-7 (Clifton) including the removal and environmental clean-up of three previously unknown underground storage tanks discovered during construction of the maintenance district. Additionally, design services at PMD-5 (Telegraph Hill) are included for the renovation of the existing print shop building and two pre-engineered metal buildings requested by the Maintenance Department. The print shop renovation will repurpose the existing inventory storage area to accommodate the Authority's Trades personnel and facilitate the demolition of Trades existing building, which is approaching its usable life span. Renovation services include building design, associated site improvements, utility coordination and permitting as required. The pre-

engineered metal building efforts include geotechnical and utility design as well as an amended environmental impact statement and New Jersey Department of Environmental Protection Flood Hazard Area Individual Permit. These buildings were not in the original scope of work.

It is, therefore, recommended that Supplement B to Order for Professional Services No. P3460 be issued to T.Y. Lin International not to exceed the amount of \$830,000.00 with compensation on the same basis as the original Order for Professional Services. The addition of this amount increases the total authorized fee from \$6,780,000.00 to \$7,610,000.00. The original contract was procured pursuant N.J.S.A. 52:34-9.1 et seq. and N.J.A.C. 19:9-2.8.

The Authority has completed construction on the Interchange 12 Improvements Project (the "Project") in the Borough of Carteret, Middlesex County. This Project involved improvements to Interchange 12 on the New Jersey Turnpike, including the reconstruction of the Interchange 12 ramp systems at the intersections of Roosevelt Avenue (CR 602) and Industrial Highway, the reconstruction of Roosevelt Avenue (CR 602), and the reconfiguration of the intersections of Roosevelt Avenue (CR 602) with Wedgewood Drive/New Jersey Turnpike Interchange 12 Ramps, Harrison Avenue and Industrial Highway, in order to improve the operation of the interchange and connecting roads.

The Project impacted various roadways owned and maintained by the County of Middlesex ("County"), including Roosevelt Avenue (CR 602), and the Borough of Carteret ("Borough"), including Industrial Highway, Harrison Avenue, and Wedgewood Drive. As a result of the improvements made pursuant to the Project, the Authority has updated the Jurisdictional Limit Maps relative to the Turnpike and these county and municipal roadways.

Therefore, it is recommended that the Authority enter into Maintenance and Jurisdictional Agreement No. 67-13 with the County and the Borough, with the new Jurisdictional Limit Maps attached thereto and incorporated by reference, to set forth the respective rights and responsibilities of the Authority, the County and the Borough with respect to such improvements. Under the Maintenance and Jurisdictional Agreement, the parties shall convey and accept the required property transfers to ensure that each entity becomes the owner of the real property underlying that entity's improved roadways.

Accordingly, it is requested that the Board of Commissioners delegate to the Executive Director the authority to execute Maintenance and Jurisdictional Agreement No. 67-13 with the County of Middlesex and the Borough of Carteret pursuant to the terms outlined above. It is further recommended that the Commissioners authorize the Executive Director to execute any such other documents and take any such other actions as are deemed necessary to effectuate the intent of this authorization.

In a memorandum dated September 14, 2017, **Authorization to Enter into Maintenance and Jurisdictional Agreement No. 124-16 with the County of Middlesex and to Convey Property to the County of Middlesex for its Perrineville Road Bridge Project**, was approved.

In the Fall of 2014, the Authority completed construction on the New Jersey Turnpike Interchange 6 to 9 Widening Program (the "Program"). The Program impacted various roadways in the County of Middlesex ("County"), including Station Road (CR 615), and Prospect Plains Road (CR 614) in Cranbury Township. As a result of the improvements made pursuant to the

Project, the Authority has updated the Jurisdictional Limit Maps relative to the Turnpike and these county roadways.

Therefore, it is recommended that the Authority enter into Maintenance and Jurisdictional Agreement No. 124-16 with the County, with the new Jurisdictional Limit Maps attached thereto and incorporated by reference, to set forth the respective rights and responsibilities of the Authority and the County. Under the Maintenance and Jurisdictional Agreement, the parties shall convey and accept the required property transfers to ensure that each entity becomes the owner of the real property underlying that entity's improved roadways.

The County has also requested that the Authority convey to the County a portion of Block 6, Lot 11 in the Township of Monroe, consisting of approximately 7,641 square feet and two (2) related temporary construction easements ("County Parcel 1"). County Parcel 1, and all of Block 6, Lot 11 on the Monroe Tax Map were part of a 400-acre property known as the "Brookland Site," which was purchased by the Authority in 2010 to partially satisfy the environmental permit requirements for the Program. The County has requested the transfer of County Parcel 1 to enable the County to complete its improvements project for the Perrineville Road Bridge over the Millstone River. As this transfer will not affect the Authority's mitigation requirements, and neither County Parcel 1 nor the remainder of the Brookland Site has any independent utility to the Authority, the Law Department recommends that County Parcel 1 be conveyed to the County at no cost. The Authority's Board of Commissioners recently approved at its August 22, 2017 Meeting the conveyance of the remainder of the Brookland Site to the Township of Monroe.

Accordingly, it is requested that the Board of Commissioners delegate to the Executive Director the authority to execute Maintenance and Jurisdictional Agreement No. 124-16 with, and to transfer County Parcel 1 to, the County of Middlesex pursuant to the terms outlined above. It is further recommended that the Commissioners authorize the Executive Director to execute any such other documents and take any such other actions as are deemed necessary to effectuate the intent of this authorization.

In a memorandum dated September 14, 2017, Authorization to Enter into Maintenance and Jurisdictional Agreement No. 126-16 with the Township of Robbinsville and to Convey Parcel 991 to the Township, was approved.

In the Fall of 2014, the Authority completed construction on the New Jersey Turnpike Interchange 6 to 9 Widening Program (the "Program"). The Program impacted various municipal roadways in the Township of Robbinsville (the "Township"), including West Manor Way, Gordon Road, Sharon Road, Windsor Road, Edgebrook Road and Perrineville Road.

As a result of the improvements made pursuant to the Program, the Authority and the Township have updated the Jurisdictional Limit Maps relative to the Turnpike, West Manor Way,

Gordon Road, Sharon Road, Windsor Road, Edgebrook Road and Perrineville Road. Therefore, it is recommended that the Authority enter into Maintenance and Jurisdictional Agreement No. 126-16 with the Township, with the new Jurisdictional Limit Maps attached thereto and incorporated by reference, to set forth the respective rights and responsibilities of the Authority and Township with respect to such improvements. Under the Maintenance and Jurisdictional Agreement, the Authority and the Township shall convey and accept the required property transfers to ensure that each entity becomes the owner of the real property underlying that entity's improved roadways.

In addition, the Law Department recommends that the Authority donate Parcel 991 (also known as Block 30.03, Lot 39 on the Tax Map of Robbinsville) to the Township. Parcel 991 consists of approximately 50 acres of vacant land that has been used by the Authority to satisfy a portion of the environmental mitigation requirements of the Program. The Authority has encumbered Parcel 991 with a conservation easement for the benefit of the New Jersey Department of Environmental Protection ("NJDEP"), and has been searching for an appropriate conservator to take ownership of the property. The Township has agreed to take Parcel 991 and include it in the Township's Green Acres Program inventory, which has been approved by NJDEP.

Accordingly, it is requested that the Board of Commissioners delegate to the Executive Director the authority to execute Maintenance and Jurisdictional Agreement No. 126-16 with the Township of Robbinsville, and to convey Parcel 991 to the Township, pursuant to the terms outlined above. It is further recommended that the Commissioners authorize the Executive Director to execute any such other documents and take any such other actions as are deemed necessary to effectuate the intent of this authorization.

The Authority has completed construction on the Garden State Parkway Interchange 9, 10 and 11 Improvements Project (the "Project") in the Township of Middle, Cape May County. This Project included improvements to Interchanges 9, 10 and 11, eliminating the at-grade signalized intersections and upgrading this segment of the Parkway to a fully access controlled highway, giving preference to through traffic by providing ramp connections only at selected public roads and prohibiting at-grade intersections and direct private driveway connections with the Parkway.

The Project impacted various roadways owned and maintained by the County of Cape May ("County"), including Shell Bay Avenue (CR 674), Stone Harbor Boulevard (CR 657), Crest

Haven Road (CR 609), and Moore Road (CR 663), as well as various roadways owned and maintained by the Township of Middle ("Township"), including Golf Club Road, Bayberry Drive, Ormond Road, Brighton Road and Holmes Landing Road. As a result of the improvements made pursuant to the Project, the Authority, with the concurrence of the County and the Township, has updated the Jurisdictional Limit Maps relative to the Parkway and these county and municipal roadways.

Therefore, it is recommended that the Authority enter into Maintenance and Jurisdictional Agreement No. 149-17 with the County and the Township, with the new Jurisdictional Limit Maps attached thereto and incorporated by reference, to set forth the respective rights and responsibilities of the Authority, the County and the Township with respect to such improvements. Under the Maintenance and Jurisdictional Agreement, the parties shall convey and accept the required property transfers to ensure that each entity becomes the owner of the real property underlying that entity's improved roadways.

Accordingly, it is requested that the Board of Commissioners delegate to the Executive Director the authority to execute Maintenance and Jurisdictional Agreement No. 149-17 with the County of Cape May and the Township of Middle pursuant to the terms outlined above. It is further recommended that the Commissioners authorize the Executive Director to execute any such other documents and take any such other actions as are deemed necessary to effectuate the intent of this authorization.

In a memorandum dated September 14, 2017, **Authorization to Enter into Maintenance and Jurisdictional Agreement No. 134-17 with the Township of Carneys Point**, was approved.

The Authority's Facilities Improvement Program involves the construction and improvements of various maintenance facilities on the New Jersey Turnpike and Garden State Parkway (the "Program"). Final Design for the \$500 million Program began in 2013 and construction is scheduled for completion in 2018. The Program improvements at the Turnpike Interchange 1 Toll Plaza, including a proposed salt shed, drainage basin, and realignment of the Authority's access driveway, impact various municipal right-of-ways in the Township of Carneys Point (the "Township"), including South Game Creek Road.

As a result of the improvements made pursuant to the Program, the Authority and the Township have updated the Jurisdictional Limit Maps relative to the Turnpike and South Game Creek Road. Therefore, it is recommended that the Authority enter into Maintenance and Jurisdictional Agreement No. 134-17 with the Township, with the new Jurisdictional Limit Maps attached thereto and incorporated by reference, to set forth the respective rights and responsibilities of the Authority and Township with respect to such improvements.

Accordingly, it is requested that the Board of Commissioners delegate to the Executive Director the authority to execute Maintenance and Jurisdictional Agreement No. 134-17 with the Township of Carneys Point pursuant to the terms outlined above. It is further recommended that the Commissioners authorize the Executive Director to execute any such other documents and take any such other actions as are deemed necessary to effectuate the intent of this authorization.

In a memorandum dated September 14, 2017, **Authorization to Enter into Memorandum of Agreement ("MOA") with the State of New Jersey, Department of Health ("NJDOH"), Amount: \$1,024,745.00 (over three years)**, was approved.

The Authority has previously entered into agreements with DOH for the inspection, investigation and related health services for all retail food service facilities located on the New Jersey Turnpike and Garden State Parkway. These services are required by law, and the cost of these services is borne by the Authority. The most recent agreement, approved by the Authority's Board of Commissioners in August 2014 under Agenda Item No. 337-08-2014, was effective from July 1, 2014 to June 30, 2017, at a cost to the Authority not to exceed \$1,007,846.00.

DOH has proposed a new three (3) year agreement that would be effective from July 1, 2017 to June 30, 2020, at a total cost to the Authority not to exceed \$1,024,745.00 over the three-year period. The cost to the Authority represents less than a \$17,000 increase over the prior three-year agreement. The inspection services provided by DOH would include the facilities at twenty (20) Service Areas and all concessions and the main and back stage kitchens at the PNC Bank Arts Center.

Accordingly, it is requested that the Board of Commissioners delegate to the Executive Director the authority to execute the Memorandum of Agreement with DOH pursuant to the terms outlined above. It is further recommended that the Commissioners authorize the Executive Director to execute any such other documents and take any such other actions as are deemed necessary to effectuate the intent of this authorization.

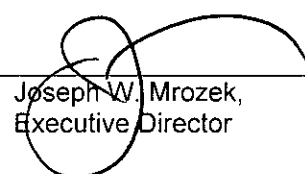
