The Atlantic Area Psychiatric Group serves clients in Atlantic and Cape May Counties, both ambulatory and non-ambulatory cases.

The Camden Area Psychiatric Group serves clients in Burlington, Camden, Cumberland, Gloucester and Salem Counties, both ambulatory and non-ambulatory cases.

Appointments for clients are to be made with the Director of the appropriate Area unit by the County Welfare Boards.

The Area Directors have been instructed by Dr. Brancale and the Bureau concerning processing of records and billing procedures. The procedures operate in the same manner as for clients examined by the Psychiatric Diagnostic Group at Menlo Park.
