


#### Enrollment by Gender

This graph displays the percentage of students by gender for the past three school years.




#### Enrollment by Ethnic/ Racial Subgroup







This graph presents the percentage of students who met or exceeded expectations for the past two years.














#### Absenteeism




#### Enrollment by Gender

This graph displays the percentage of students by gender for the past three school years.




# Enrollment by Ethnic/ Racial Subgroup

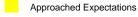







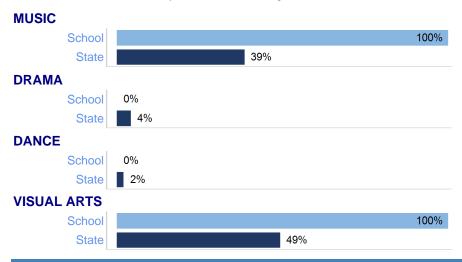


### Visual and Performing Arts








#### Chronic Absenteeism Trend
