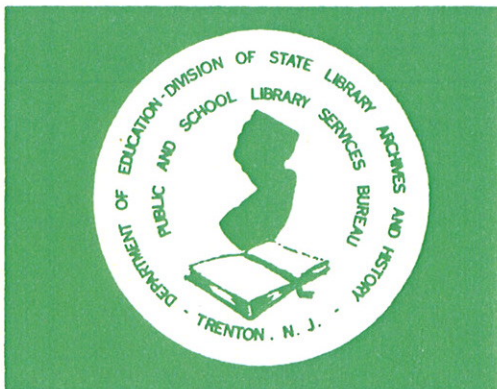

LEGAL BASIS FOR PUBLIC LIBRARY SERVICE IN NEW JERSEY

AREA LIBRARY:

A headquarters library under contract with the State for specialized services to libraries within a given geographic area. There are 17 Area Libraries.

ASSOCIATION LIBRARY:

One established, governed and supported by an association of citizens. Such an association is incorporated, forms its own constitution, appoints or elects its own board and is responsible for operation of the library. It may receive tax support from the local governing body. There are 150 association libraries. Only those association libraries whose services are free to the use of the public are included in this publication.

COUNTY LIBRARY:

One established by law following a county-wide referendum passed by a majority of voters. It is supported by taxes and governed by a board known as the county library commission composed of 5 members appointed by the Freeholders. There are 13 county libraries.

FEDERATION:

Any number of independently established libraries voluntarily united to develop cooperative free public library services. Each member library retains complete institutional independence but enters into contracts or service agreements with other members to achieve the joint services agreed upon by the governing bodies of the respective libraries. There are two federation of libraries in New Jersey whose members retain identity as municipal libraries.

JOINT LIBRARY:

One established by law following a referendum in two or more municipalities in which the majority of voters vote to establish such a library. It is governed by a board appointed by the mayors of the participating municipalities. There are three joint libraries.

MUNICIPAL LIBRARY:

One established by law following a referendum in which the majority of voters vote to establish such a library. It is supported by taxes and is governed by a 7 member board appointed by the mayor which must include the mayor and the superintendent of schools. There are 189 municipal libraries.

REGIONAL LIBRARY:

One established by law following resolution adopted by the boards of chosen freeholders of 2 or more counties. It is governed by a board of trustees appointed by the boards of freeholders of the participating counties. There are no regional libraries to date.

NOTES ON STATISTICS

These statistics are compiled from reports submitted by individual libraries for calendar year 1968. Additional data and processing has been supplied as indicated below. Where a library is supported by more than one municipality, figures shown represent combined municipalities.

<u>Column</u>	<u>Explanation</u>
Library Name	Generally the municipality name identifies a public library. Where a library name differs from that of the municipality, the library name is inserted in parentheses under the name of the municipality.
Estimated Population Served	Source: <i>New Jersey Population Estimates — 1968</i> by New Jersey Department of Conservation and Economic Development. Total population of New Jersey as of July 1, 1968 was estimated at 7,203,510. Population served by libraries is somewhat less or 7,099,640. This is due to unserved municipalities in counties without a county library.
Type	The following letters are used to indicate type of library: A — Association; J — Joint Library; and M — Municipal Library. County Libraries are identified by name but not indicated in this column.
Equalized Valuation	Source: <i>Table of Equalized Valuation</i> by New Jersey Department of the Treasury, Division of Taxation — 1968 Conformed Copy. Figures are shown to the nearest thousand.
Local Tax Support	Tax support is shown as reported by individual libraries. Figures for tax support of County Libraries represent 1968 Library Dedicated Tax; these were not included in the report for 1967.
Per Capita State Aid	Amounts shown represent State Aid sent to municipalities in October 1968. County totals include the entire amount of State Aid in return for official support of libraries. Therefore, some county totals are larger than the sum for the libraries listed.
Per Capita Expenditures	Derived from total expenditures divided by the estimated population served — less any population for which no report was received. For County member libraries, also shown are per capital expenditures including library dedicated tax.
Staff	Figures appearing under column Professional With Degree represent individual librarians who hold a fifth year degree in library science. Figures appearing under Professional and Clerical staff F.T.E. (Full Time Equivalents) represent employment in job for at least one-half full-time. Where less than half-time employment was reported no credit is given under F.T.E.
Volumes in Library	Figure represents books reported as owned at end of 1968. In the case of county member libraries books reported as supplied by the County Library on extended long term loan are included here.
Periodical Titles	Figure represents number of magazines and newspapers subscribed to during 1968.
Hours Open Per Week	Figure represents the number of hours the main library was open for public service during the major part of 1968. Figures appearing under <i>Totals</i> represent averages to the nearest one-tenth of an hour.
Per Capita Volumes In Library	Derived from volumes in library divided by estimated population served, less any population for which no report was received.
