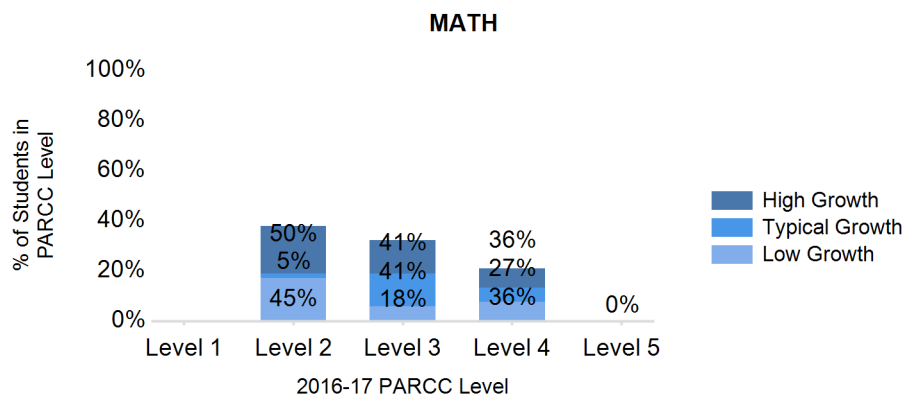
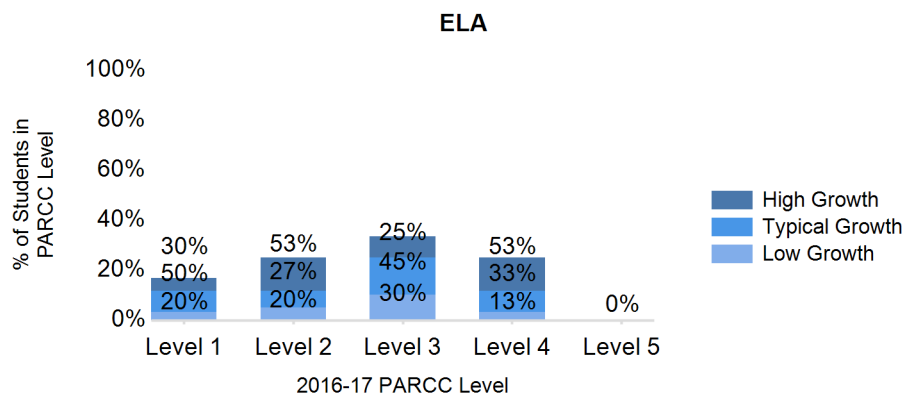

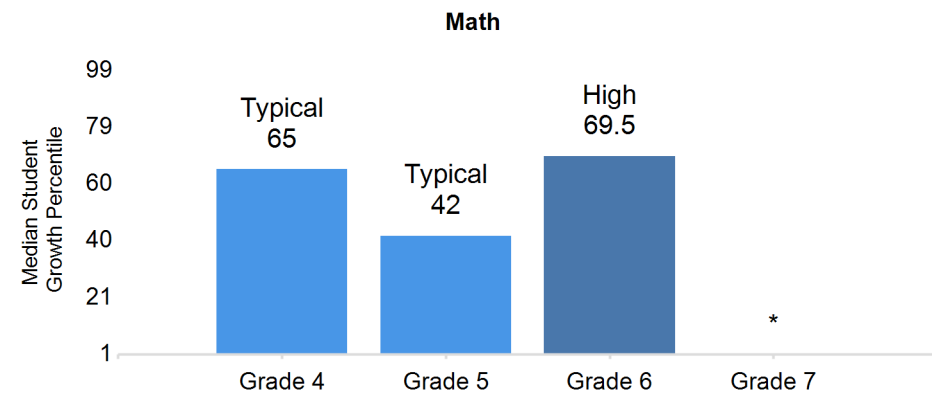
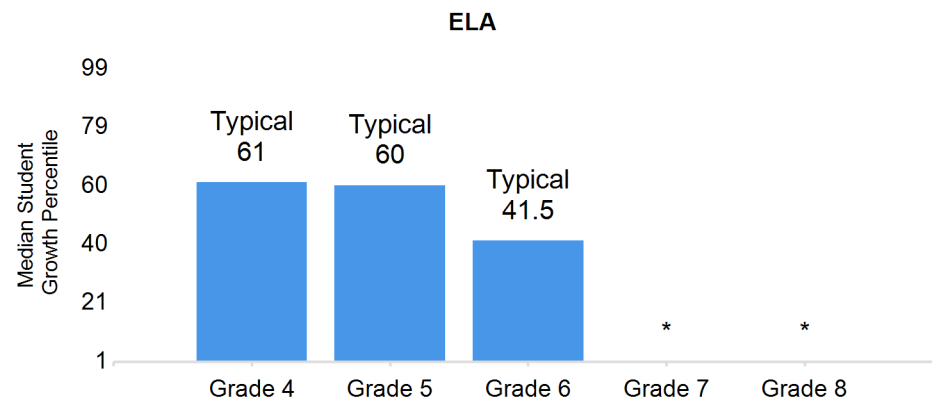
Student Growth by Performance Level

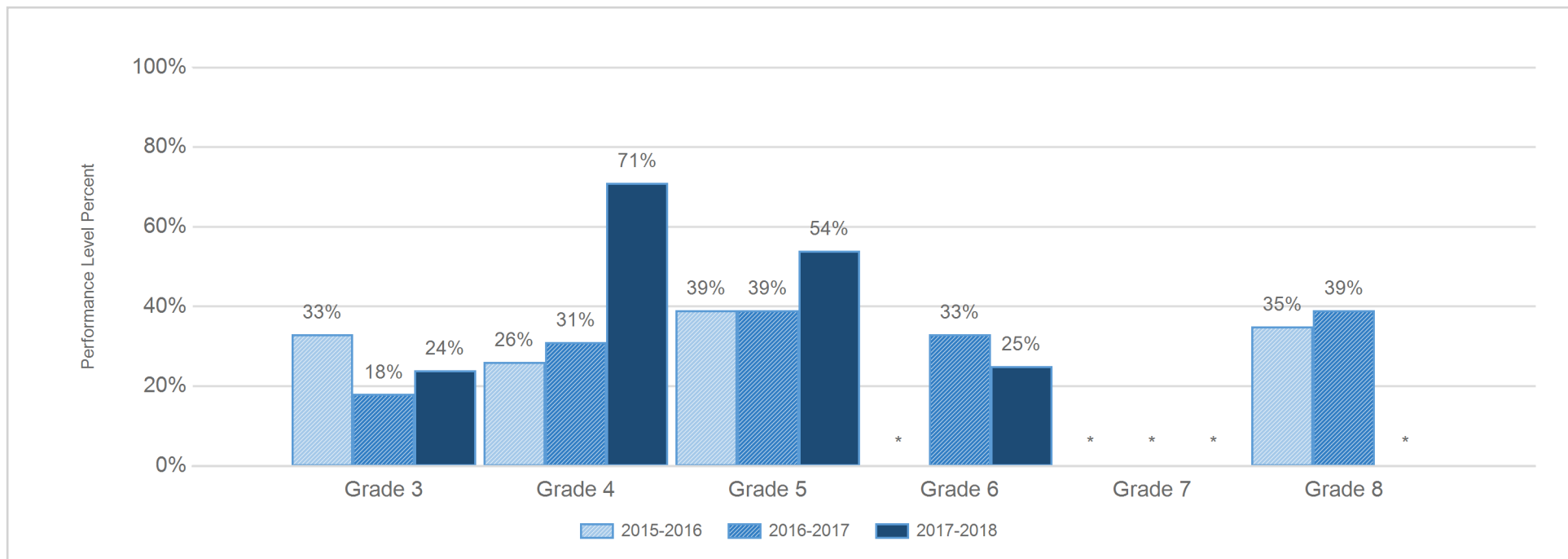

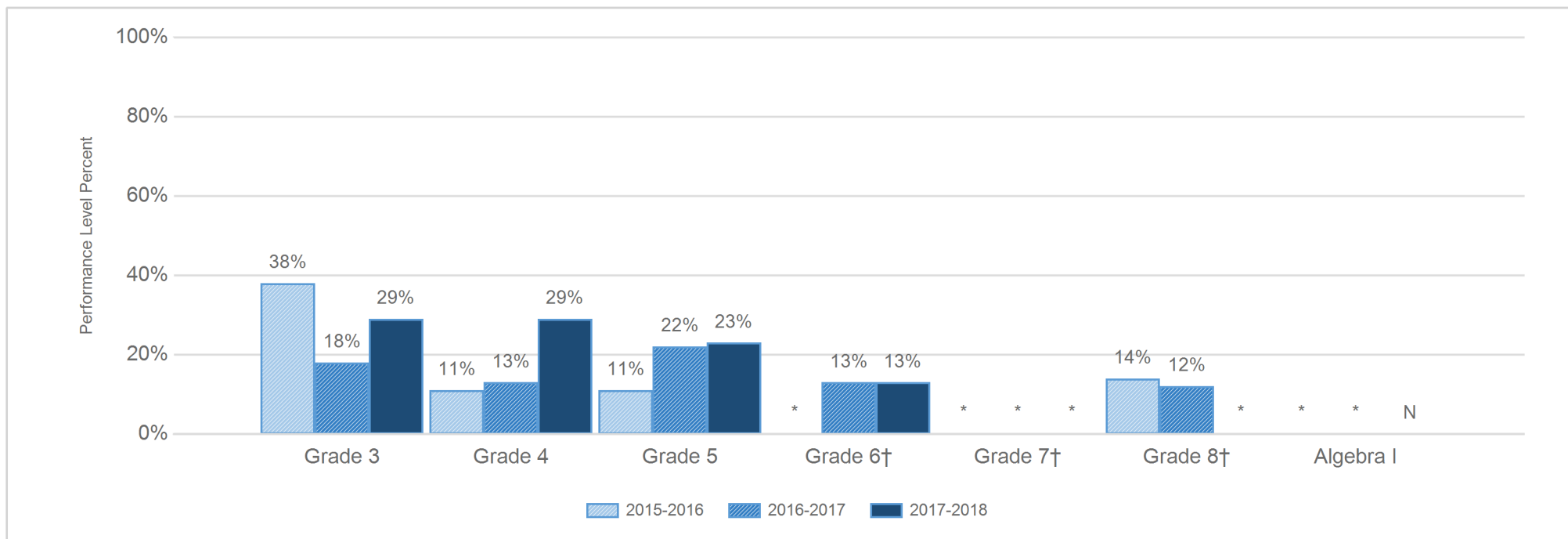

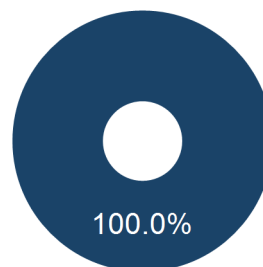

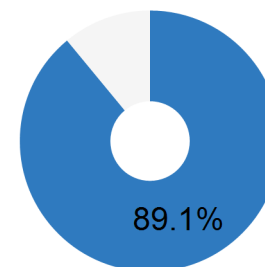

Students enrolled in one or more **visual and performing arts** classes

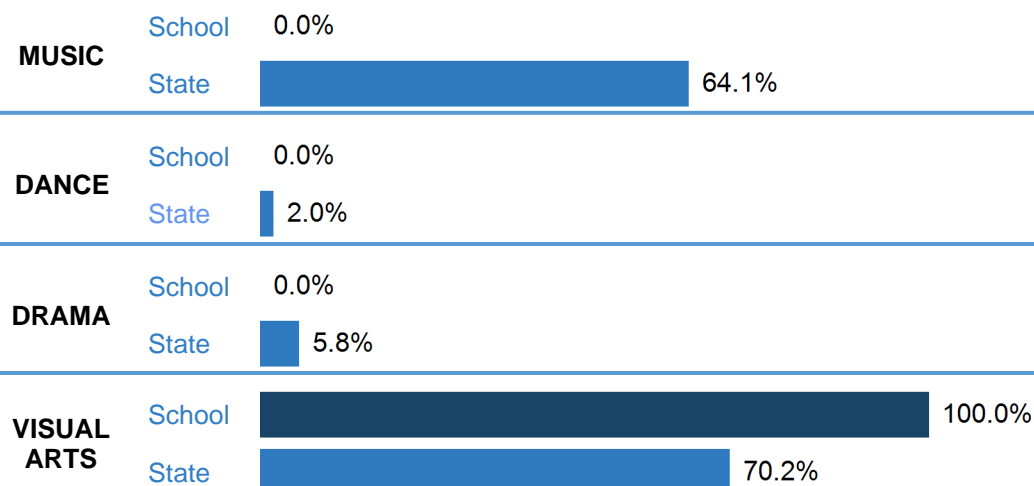

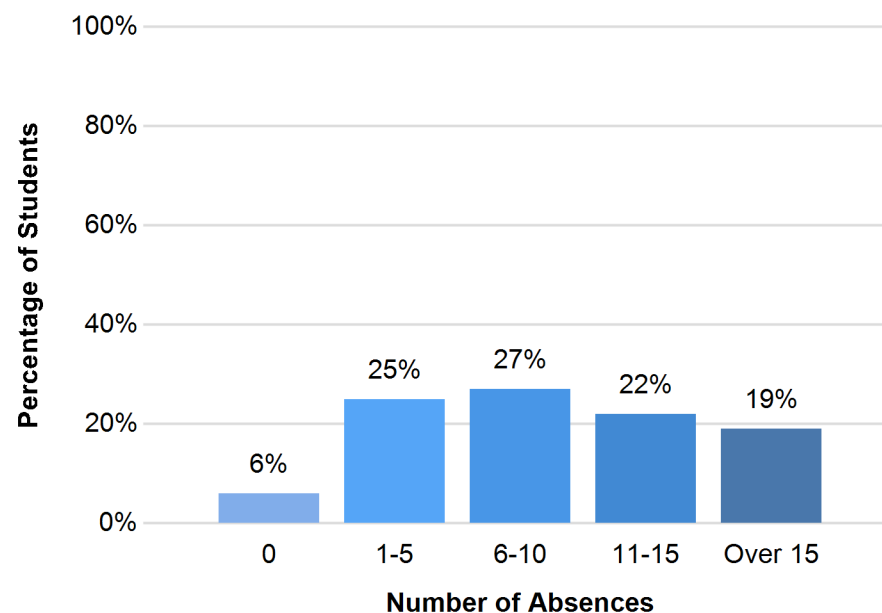

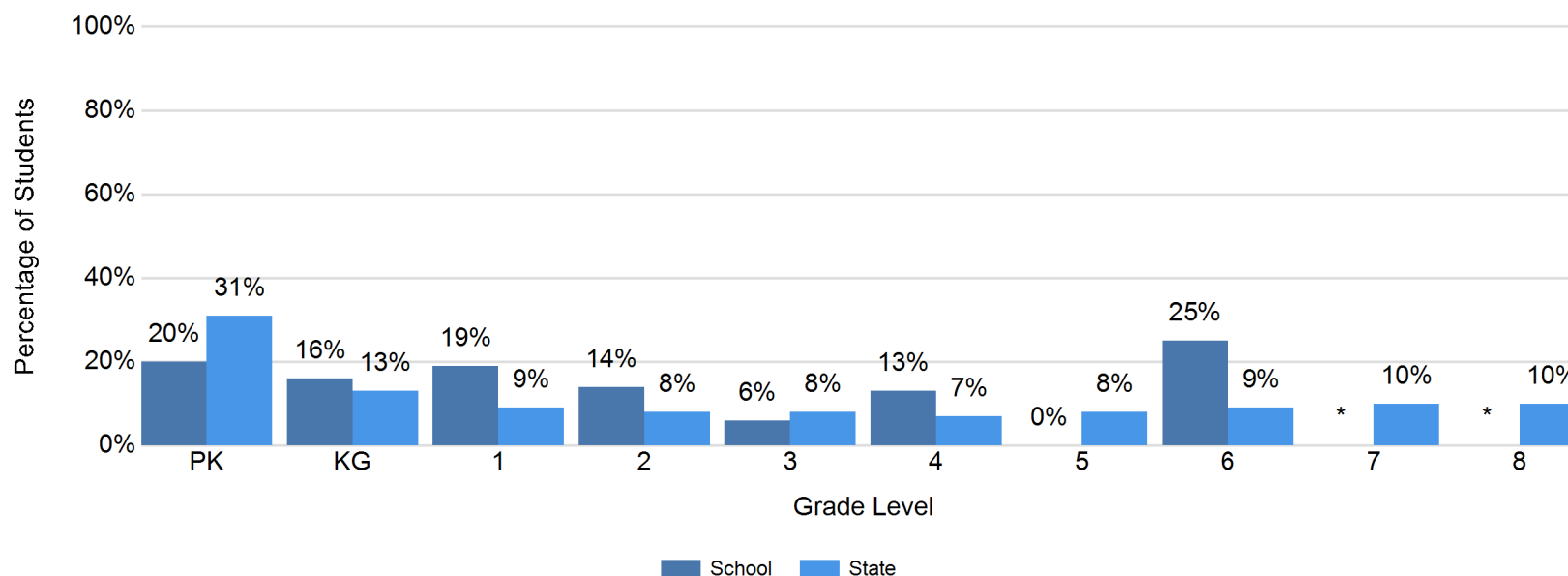

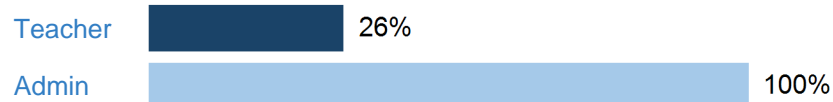

Woodbine Elementary School is a walking school district. The school day at Woodbine Elementary begins at 8:20 am and ends at 2:30 pm. On early dismissal days, students leave school at 1:00 pm. The school uses a global all-call system in addition to Thursday Blue Folders to provide communication. In addition, the district maintains a website and facebook page. We currently offer 4 preschool classrooms funded by the State of New Jersey. The uniform policy includes: black, navy or khaki pants and white, gold, navy or pale blue golf or dress shirts. Sneakers, shoes and boots are permitted footwear. Skirts, jumpers, capri pants and shorts are permitted for girls in addition to pants. Woodbine Elementary is a choice school with four approved seats for the district. Our high school students attend Middle Township, Cape May County Vocational High School or private/parochial school. Woodbine Elementary offers latchkey services before and after school.
