SUBJECT: CURRENT PROGRAM STATISTICS

Attached please find *Current Program Statistics* for August 2004. Included are TANForiented and Food Stamps data, General Assistance data, and the WFNJ Statistical Summary.

Some items of interest include:

- The TANF caseload is increasing. Since August of 2003 there has been an increase of 4.5%.
- Food Stamp households increased by 15,699 since August 2003.
- For GA, recipient figures reported are for August 2004, which are 16.7% above August 2003.
- Erratum: An inadvertent error was previously reported in Table 4 (WFNJ Statistical Summary) of the December 2003 Current Program Statistics Report for Salem and Middlesex Counties with respect to "Employment Directed Activities-All Other Training". These values are corrected in the attached revised table to that report.

### PLEASE NOTE:

As mentioned in the May 2004 issue of The *Current Program Statistics* (CPS), CPS reports are now prepared in the new format. Offered in this issue are three reports covering Summer 2004, including the months June 2004 through August 2004. Readers should refer to the most recent August version for a 24-month retrospective view of the primary program counts.



# WFNJ/TANF (See pages 6-7 for additional information)

- As can be seen from figure 1 (page 6), during the month of August 2004, the overall TANF caseload in the state expanded by 341 cases representing a 0.8% increase from last month. Additionally, the 3-month statewide caseload demonstrated a 2.0 percent modest growth while growing 4.5% since August 2003.
- The one-year rolling statewide caseload changes are also shown, and the rates of change have steadily increased since mid-2003 (e.g., positive 1.4% for the May 2002 to May 2003 period as compared to the August 2003 to August 2004 period having the 4.5% increase mentioned above) although more recently there is a small declining trend, dropping from the Spring 2004 5.7% crest in April. Thus, the decline in the total number statewide cases observed in 2002 from 2001 levels has been eliminated during the mid-2003 to 2004 timeframe.
- Of interest, counties having the highest caseload percentage increase since Aug 2003 include counties of all three population density types: Warren County (26.0% †), Gloucester County (19.0% †), as well as high-density (HD) Bergen County (18.6% †) [figure 2 data-page 7].
- In contrast, Cape May (LD), Ocean County (MD), and Camden County effectively controlled caseload increases (-2.9%, -9.2%, and -0.6%, respectively) during this one-year period. Among HD counties, Camden County stands out in this stratum for consistently controlling its caseload between 2003 and 2004.

# TANF PARTICIPATION RATE (See pages 8-9 for additional information)

- From figure 3 (page 8), we see that the TANF participation rate (PR) for Aug 2004 was 29.4% for the State as a whole. This represents an 11.4 percent change (negative) from levels in Aug 2003 (29.44% PR currently versus 33.21% PR).
- Higher and lower performing counties over the year ending Aug 2004 are displayed below. For example, Hunterdon County (low population-density stratum) residents were the least likely to participate (15.4% PR) in the program, although this level significantly increased from the very low 12.5% PR reported in Aug 2003:

• Counties with participation rates above and below the State average are in figure 4 (page 9). Only the top tenth of counties (2) in the State had participation rates above 44 percent. In contrast, a new trend of counties having lower participation rates is continuing with five counties participating less than 20 percent in August compared to one county three months prior. Nearly all of the counties (19) have diminished participation from one year ago (figure 3).

# FOOD STAMP PROGRAM (See pages 10-12 for additional information)

- Figure 5 (page 10) reveals that during the month of Aug 2004, 165,496 households and 347,698 persons (including 171,827 adults and 175,871 children) participated in the Food Stamp Program representing increases of 10.5 and 8.9 percent, respectively, over one year ago (Aug 2003).
- The one-year rolling statewide changes are also shown, and the rates of change that were lower during late 2002, e.g., ~4.9% for households and 2.9% for total persons (primarily due to a decrease in the number of WFNJ/TANF households and persons at that time over 2001 data), have steadily increased (e.g., rising to 7.9% and 7.8% in Aug 2003, respectively) reaching levels nearly two to three times higher (10.5% and 8.9%, respectively) by Aug 2004. This change appears in part to be a result of a reemergence of WFNJ/TANF participants to levels above late 2001 levels (figures 5 & 6- pages 10-11). Another important observation is that the rates of change initially favoring households over persons during late 2002 and early 2003, equalized by mid-2003 through June 2004, but appears to be trending recently towards households again.
- In differentiation from the dip and subsequent increase for WFNJ/TANF households and persons described above, other low income households and persons have steadily increased since 2001 reaching over 129 thousand households and about 239 thousand persons in Aug 2004.
- Notably, counties reflected in figure 7 (page 12) having the highest total household caseload percentage increase since Aug 2003 were among the mid-density (MD) and high-density (HD) strata including Gloucester (18.5% <sup>↑</sup>), Morris (24.5 % <sup>↑</sup>), and Passaic (17.3% <sup>↑</sup>) counties while Hunterdon (LD), Warren (LD), and Monmouth (MD) counties had lighter household caseload increases in the state.

# EMERGENCY ASSISTANCE (See pages 13-14 for additional information)

- In Aug 2004, Emergency Assistance (EA) payments were made for over 6,700 eligible TANF families (figure 8-page 13) and 1,054 SSI recipients (figure 9-page 14) in New Jersey. For TANF families, this represents a sharp 66 percent increase since Aug 2003 (and 132% since Aug 2002).
- The one-year rolling statewide caseload changes are also shown, and the rates of change for total EA payments have increased 2.75-fold since late 2002-early 2003 (~24% versus 66% currently).
- This increase since mid-2003 appears to be primarily due to a significant increase in Temporary Rental Assistance (TRA) for 3,023 families.
- Statewide, TRA has dramatically risen 234 percent (~ 1.5-fold higher rate) since Aug 2003 while other TANF-EA families (including back rent, back utilities, security deposits, furnishings, clothing, and food allowance, or transitional housing) have increased much less (25.8 percent; less than the 2003 rate) over the same time period. This contrasts with emergency shelter placements that have modestly decreased over four percent from one year ago and motel placements for 483 families that have also decreased in a similar fashion (0.4%) from their Aug 2003 levels. This finding would be in agreement with desired goals to reduce motel residence for this population.

# GENERAL ASSISTANCE (See pages 15-16 for additional information)

- A review of figure 10 (page 15) data demonstrates that there has been a 16.7% growth in the total number of general assistance (GA) persons aided (36,168) in New Jersey compared to the prior year ending Aug 2003 (30,984 GA people).
- However, beginning in December 2002, one can see a divergence appear between the number of employable and unemployable persons aided. This is revealed by the one-year rolling statewide changes which show that the rates of change for employable persons have at times nearly tripled those of unemployable persons (e.g., 23% vs. 8.5% in May 2003, respectively). However, beginning in early Spring 2004 this disparity in rates of change significantly diminished, and rates between the two groups were similar at about 13-15 percent. This gap in rates may be reemerging again this month. Despite the closer rates seen in 2004, this trend has resulted in 5,754 more employable than unemployable persons assisted statewide in Aug 2004 compared to 1,635 [4,078] more employable persons aided in Aug 2002 [2003].

At the county level, figure 11 (page 16) shows that the low and medium-counties including Burlington (MD), Cape May, and Hunterdon (both LD), respectively, showed the highest rates of change providing general assistance to all total (unemployable and employable) persons while counties having low and medium density including Cape May and Salem (both LD), as well as Burlington (MD) had the highest gains in one-year rates of change for employable persons aided. Among HD counties, Bergen County stands out in this stratum for consistently controlling its GA caseload between 2003 and 2004. It is also of interest to note the difference in pattern between employable and unemployable persons for Salem (LD) and Somerset (MD) counties.

CHILD SUPPORT AND PATERNITY (See pages 17-19 for additional information)


- Figure 12 (page 17) discloses that through the third quarter of FFY 2004, the total collection of the Child Support and Paternity Program was over 717 million dollars, an increase of 7.2 percent over the same period for FFY 2003.
- Although total distributions increased over 6 percent for the year, there was a slight decrease in the percent of collections distributed from 95.3 percent in the same period last year to 94.7 percent currently. This pattern is further illustrated by an equivalent rate of 96.0% for the first three-quarters of FFY 2002.
- Further analysis reveals that there was a mild reduction in collections from state residents (8.7% ↓ in state tax) resulting in a loss of over 360 thousand dollars for the first nine months of the fiscal year. This was balanced by a simultaneous 4.0 percent increase in collections from other states gaining 1.3 million dollars, as well as a 25% gain in federal taxes collected. The reason for this finding is unclear. One potential explanation in part, among many possibilities, would be to investigate whether adults supporting their children have lost employment within the state and moved out of state.
- At the county level, figure 13 (page 18) exhibits modest improvement for two low-density counties (Cape May and Salem) and one high-density county (Hudson) to reduce the number of open cases from one year ago by more than one percent. Hunterdon County had the highest percentage increase (13.3% †) in caseload within New Jersey. Paradoxically, Hudson County demonstrates the best reduction (4.4% ↓) in the state while another neighboring high-density county, Essex County (5.3% †), had the fifth-highest percentage rise. Overall, the statewide level increased 2.2 percent (currently over 421 thousand open cases) since the second quarter 2003 (see figure 14-page 19).













Figure 8	NUMBE	R OF ELIC	GIBLE FAMI	LIES RECE	IVING EM	RGENCY	ASSISTA	NCE PAYN	ENTS	-







# ACRONYMS

ACSES: Automated Child Support Enforcement System

CASS: Consolidated Assistance and Support System

**EMERGENCY ASSISTANCE (EA)** - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if the eligible individual or family is in an imminent or actual state of homelessness.

**FOOD STAMP PROGRAM (FS)** - Authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

**OMEGA:** Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

**WFNJ:** Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA establishes Temporary Assistance to Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. The emphasis is on achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.

# **EXPLANATORY NOTES**

The Department of Human Services Division of Family Development provides basic income and an opportunity to achieve self-sufficiency for individuals and families served by the Division's programs. The Division provides leadership, direction and supervision to those public agencies responsible for administering those programs and plans for and develops policies to promote self-sufficiency.

Subsets of process evaluation data for the above report were calculated using data from four evaluation strata prepared by county density including: Media Market, High-density, Medium-density, and Low-density county types.

In this summary report, New Jersey county strata were prepared by equally dividing the state into three groups: Low, Medium (Mid), and High-density. County population density was determined by dividing county population (2000 census) by its area in square miles. High-density counties include Bergen, Camden, Essex, Hudson, Middlesex, Passaic, and Union Counties. Medium-density counties consisted of Burlington, Gloucester, Mercer, Monmouth, Morris, Ocean, and Somerset Counties. Atlantic, Cape May, Cumberland, Hunterdon, Salem, Sussex, and Warren Counties represented low-density counties. Population density in the High-density stratum ranged from 2289 people per square mile in Camden to 12,957 in Hudson County. Mid-density counties had a population density ranging from 526 (Burlington County) to 1552 in Mercer County. The less dense counties ranged from 190 (Salem County) to 450 people per square mile in Atlantic County.
