A proficiency rate is calculated by summing the count of students who scored either proficient or advanced proficient on the assessment and dividing by the count of valid test scores.

College and Career Readiness

This school outperforms 24% of schools statewide as noted by its statewide percentile ranking and 35% of schools educating students with similar demographic characteristics as noted in its peer school percentile ranking in the performance area of College and Career Readiness. 

This graph presents the count of students who were 'on roll' by grade in October of each school year.



Enrollment Trends by Program Participation






Enrollment by Ethnic/Racial Subgroup












NJASK Proficiency Trends - Math - Grade Level - 04



Students in both elementary and middles schools begin to demonstrate college readiness behaviors long before they even enter high school. Among the behaviors that research has shown to be indicative of success and college and career readiness are regularly attending school and challenging themselves with rigorous course work. 



This graph presents the count of students who were 'on roll' by grade in October of each school year.




Total School Enrollment Trends












