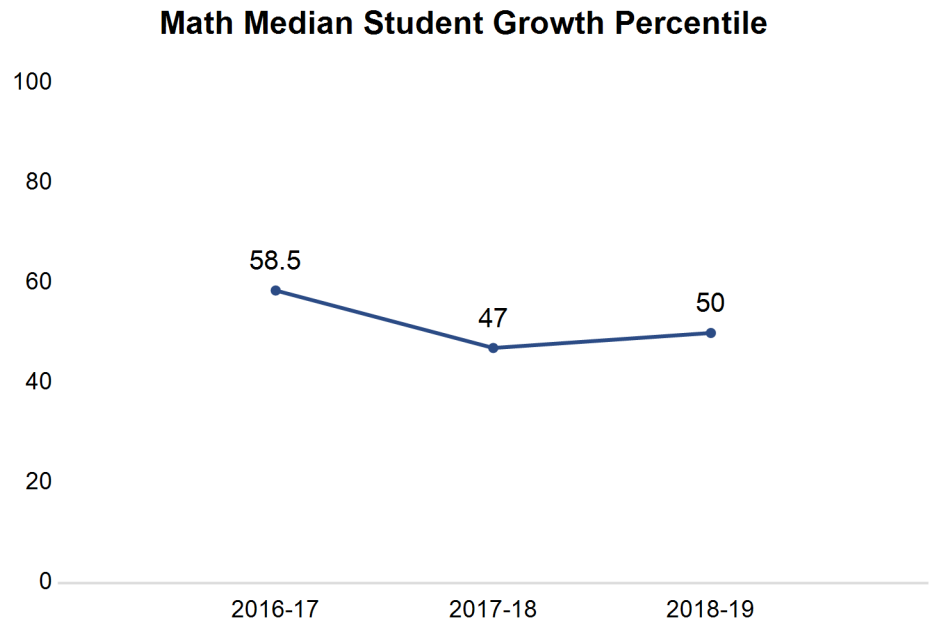
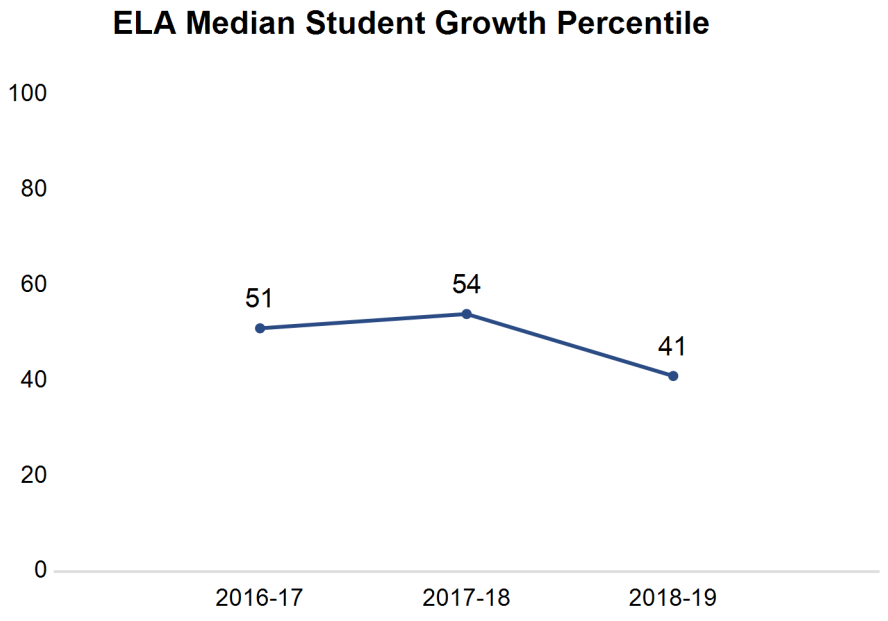

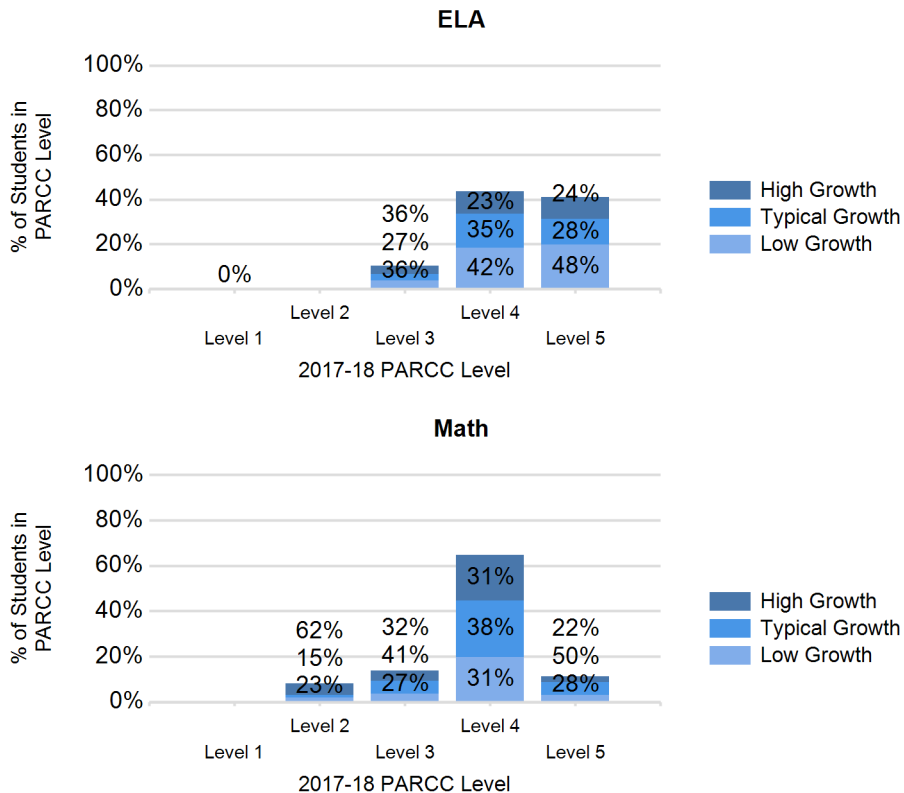

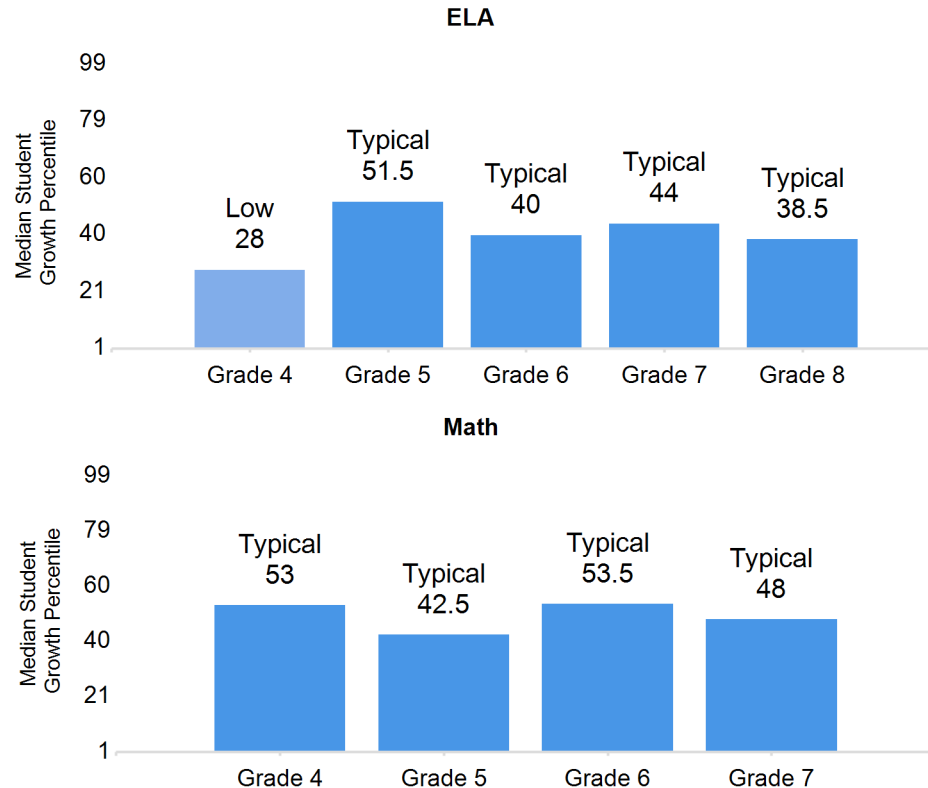
Student Growth by Performance Level

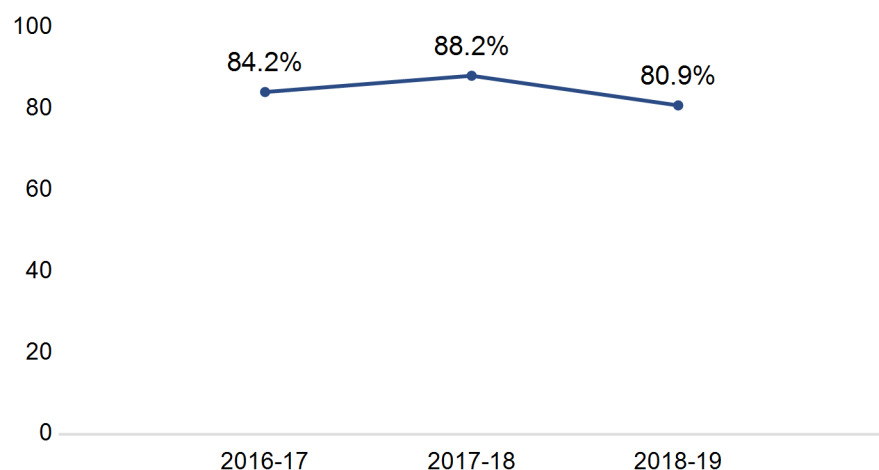

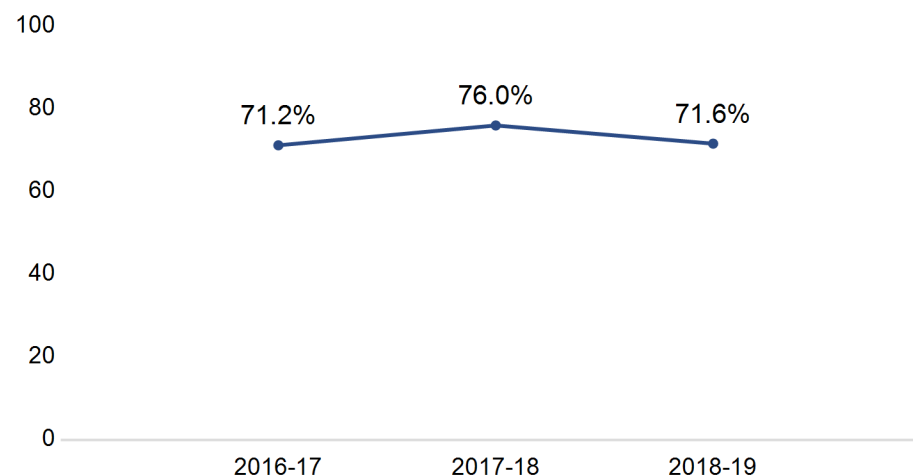
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

English Language Arts Assessment - Participation and Performance

This table shows performance on statewide assessments for English Language Arts both overall and by student group. It includes the results of students taking both the NJSLA and DLM assessments. NJSLA results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. A student is considered to have met or exceeded expectations if he/she scores at Level 4 or 5 on the NJSLA assessment or at Level 3 or 4 on the DLM assessment.

This table shows both the percentage of students that met or exceeded expectations and a proficiency rate used for federal accountability. The proficiency rate for federal accountability will be lower if the participation rate is below 95%. This table also shows progress towards meeting the state's long term goal of 80% proficiency by 2030. Annual targets are specific to each subgroup, school, and district and represent the expected proficiency needed to stay on track to meet the state's long term goal. Student groups where the annual target fields are grayed out are not required to meet annual targets under ESSA accountability. 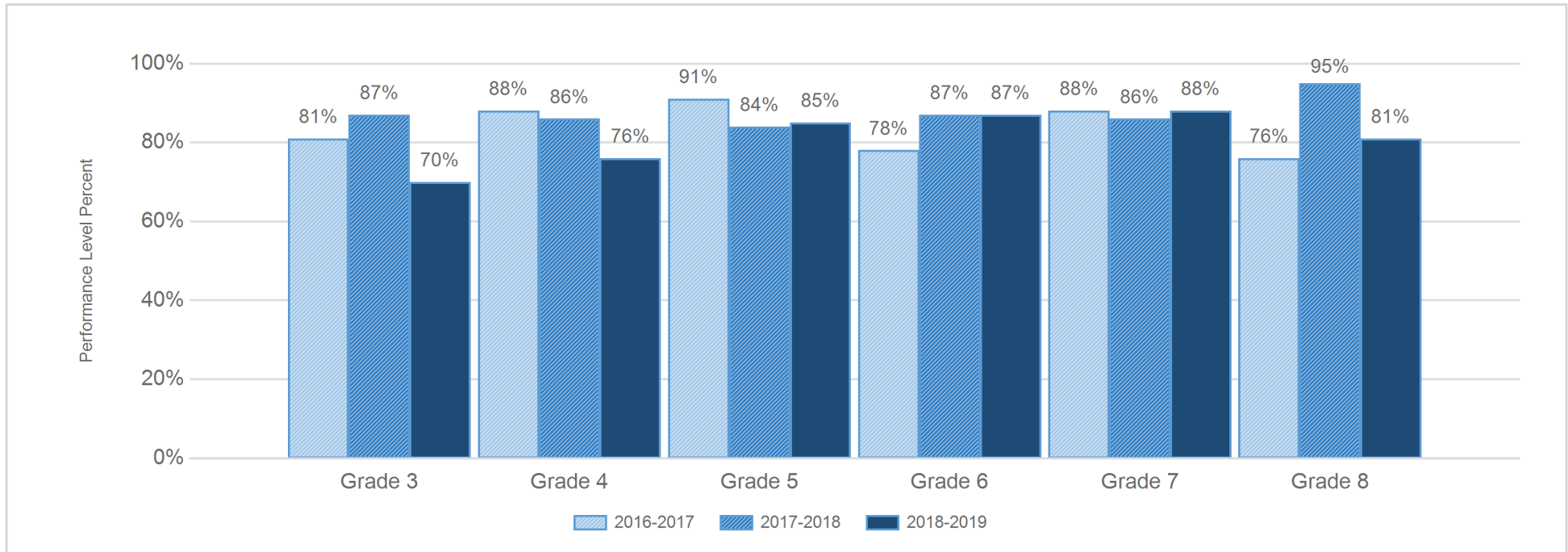

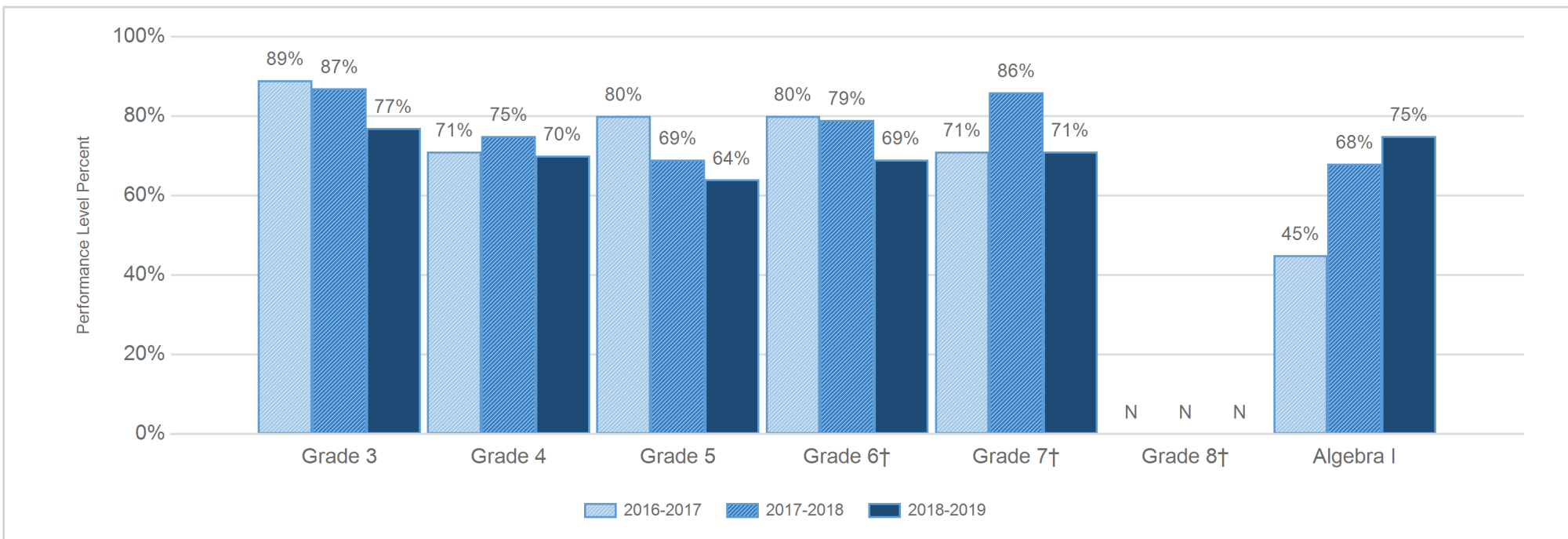

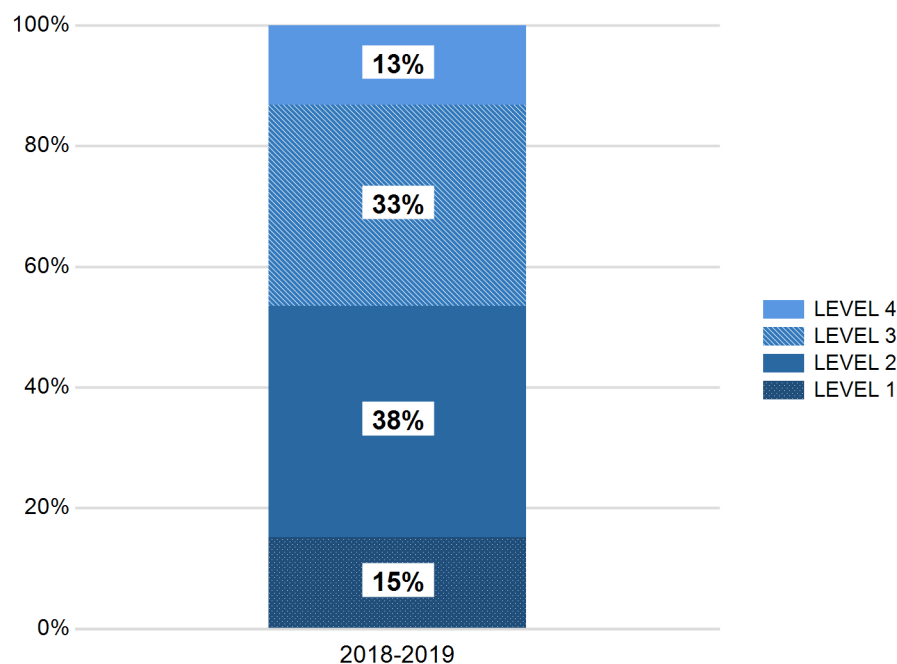

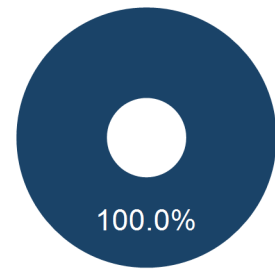

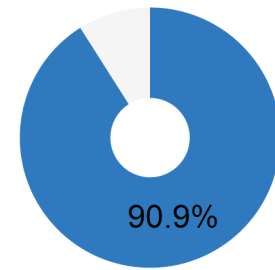

Students enrolled in one or more **visual and performing arts** classes

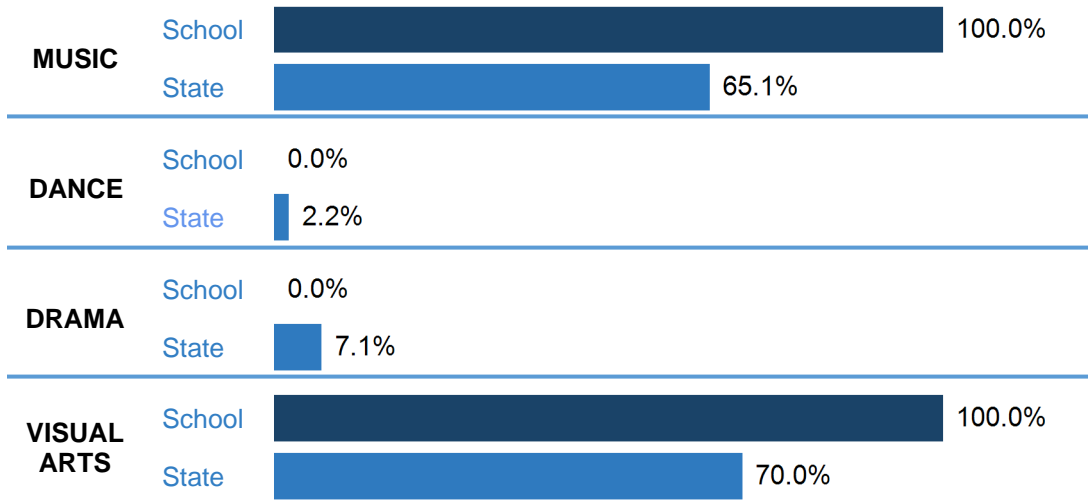

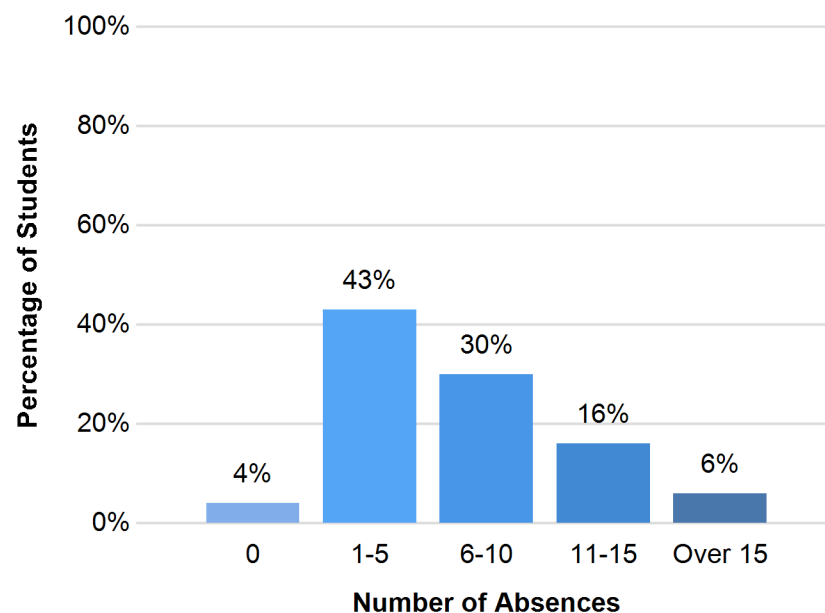

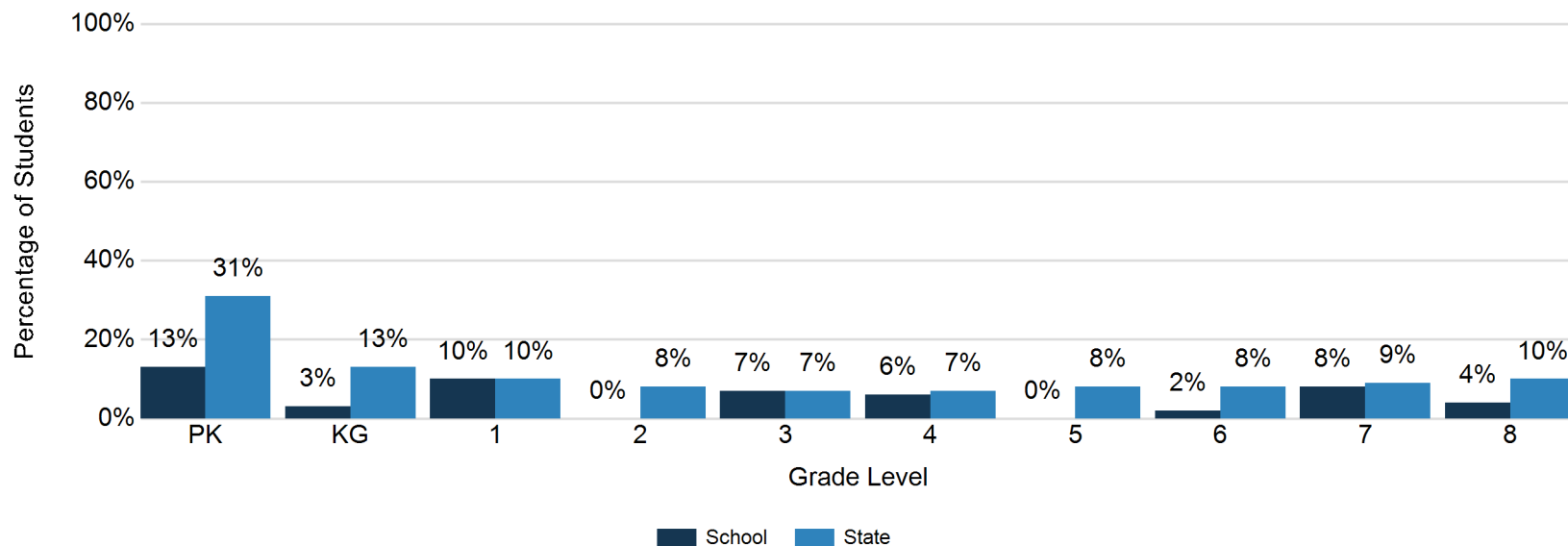

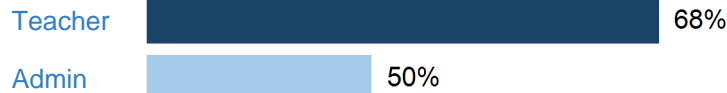

Student Supports and Services:

Rockaway Valley School offers numerous supports for students who struggle. The Child Study Team works with teachers and parents to identify students and craft Individual Educational Programs that meet the requisites of each child's identified needs. In addition, all teachers offer two extra-help periods before and/or after school to any child with questions, wanting to bolster their understanding of a topic or who may have missed a concept when it was initially taught. Students who fall behind in homework are referred to Homework Club to catch up and boost organizational and time management skills.



Student Health and Wellness:

Rockaway Valley School offers a comprehensive Health and Physical Education Program with all students participating in PE classes for 80 to 120 minutes per week. All students in K-8 participate in 20 minutes of recess daily. The school has a playground with up-to-date equipment and a fitness park as well. The school takes part in DARE, Jump Rope for Heart, the Healthy You program (good eating habits), Fatal Vision goggles and more. A student liaison group meets monthly with school administration to discuss various topics that impact their academic and social lives.



Parent and Community Involvement:

Many parents can be found supporting the school through the Home and School Association and/or the Education Foundation. These two organizations provide enrichment programming and funding for programs and equipment outside of the district's normal budget. Technology and STEM:

Students are offered a variety of academic programming options that embed technology and technological applications throughout the curriculum. Students in grades 6 - 8 have access to individual Apple MacBook devices to complement instruction using Google Suite for Education. Teacher lesson plans reflect monthly STEAM activities that expose students to valuable concepts indicative of 21st century learning skills that enable them to problem solve and think critically about relevant topics.



Early Childhood Education:

Rockaway Valley School offers an Integrated Preschool Program with both learning disabled and typically developing students studying and discovering together under the guidance of two teachers and the requisite number of classroom aides for a given year's cohort of learners. Families of typical students apply for available spots and are responsible for tuition with options for 3-, 4-, or 5-day enrollment. Busing is available.
