- 178 The appropriation of \$18,000,000 for Kean University Capital Improvements is eliminated because it is duplicative of amounts appropriated from federal State Fiscal Recovery Fund funds for the same purpose and to maintain consistency with the comprehensive budget deal struck between the Governor and Legislature.

#### 82 DEPARTMENT OF THE TREASURY

- 218 This language provision is deleted because it is the subject of separate legislation and to maintain consistency with legislative intent to fund a Parole Revocation Defense Unit with State funds.

#### GENERAL PROVISIONS

- 275 The appropriation is reduced by \$15,000,000 because it is duplicative of amounts appropriated from federal State Fiscal Recovery Fund funds for the same purpose and to maintain consistency with the comprehensive budget deal struck between the Governor and Legislature.
