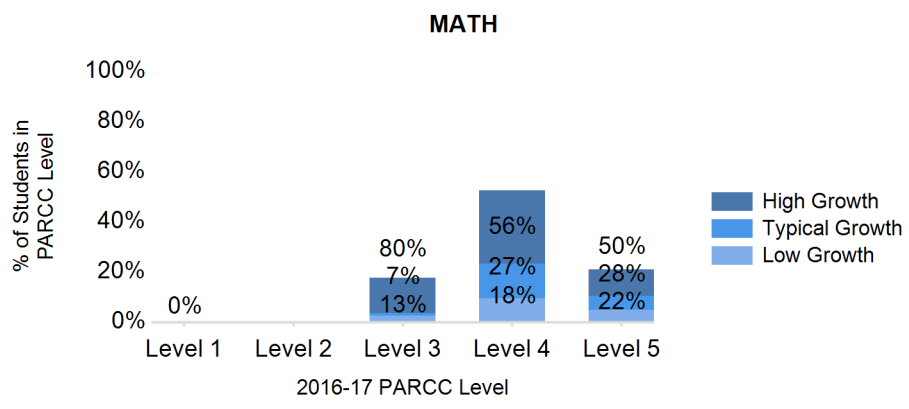
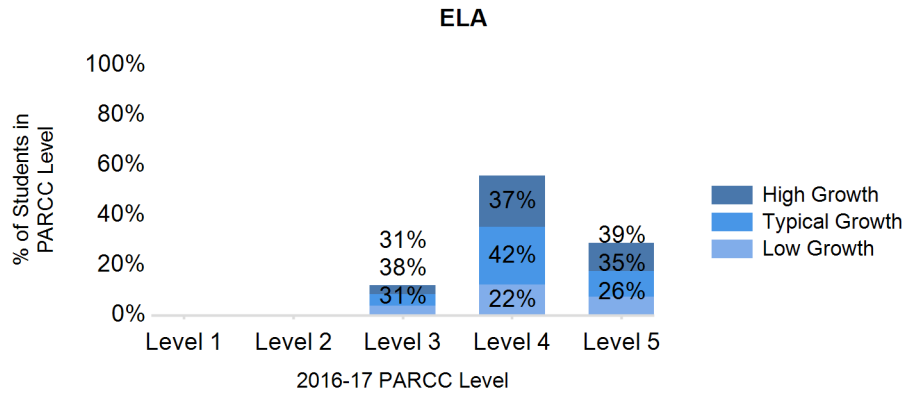

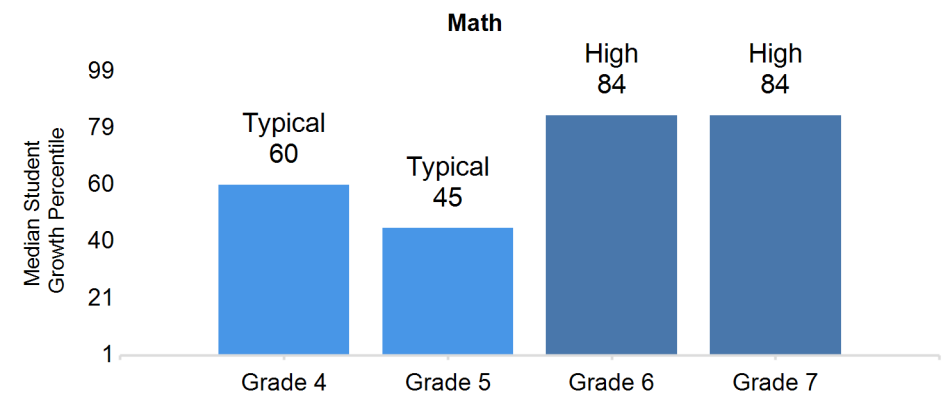
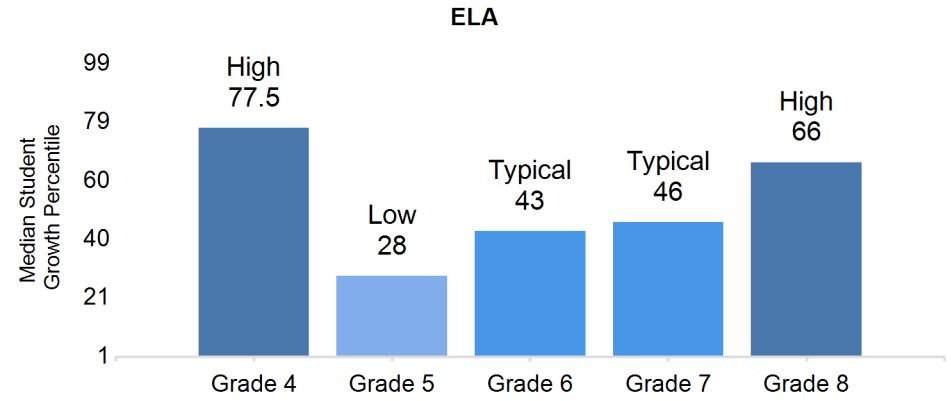
Student Growth by Performance Level

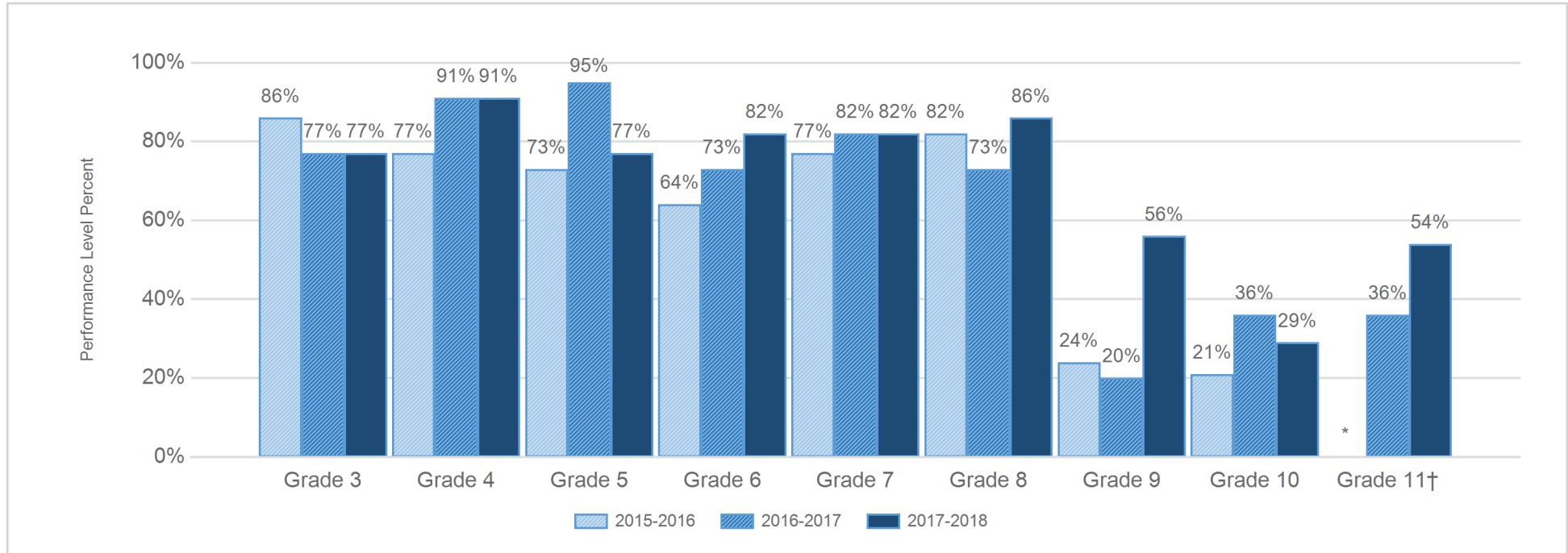

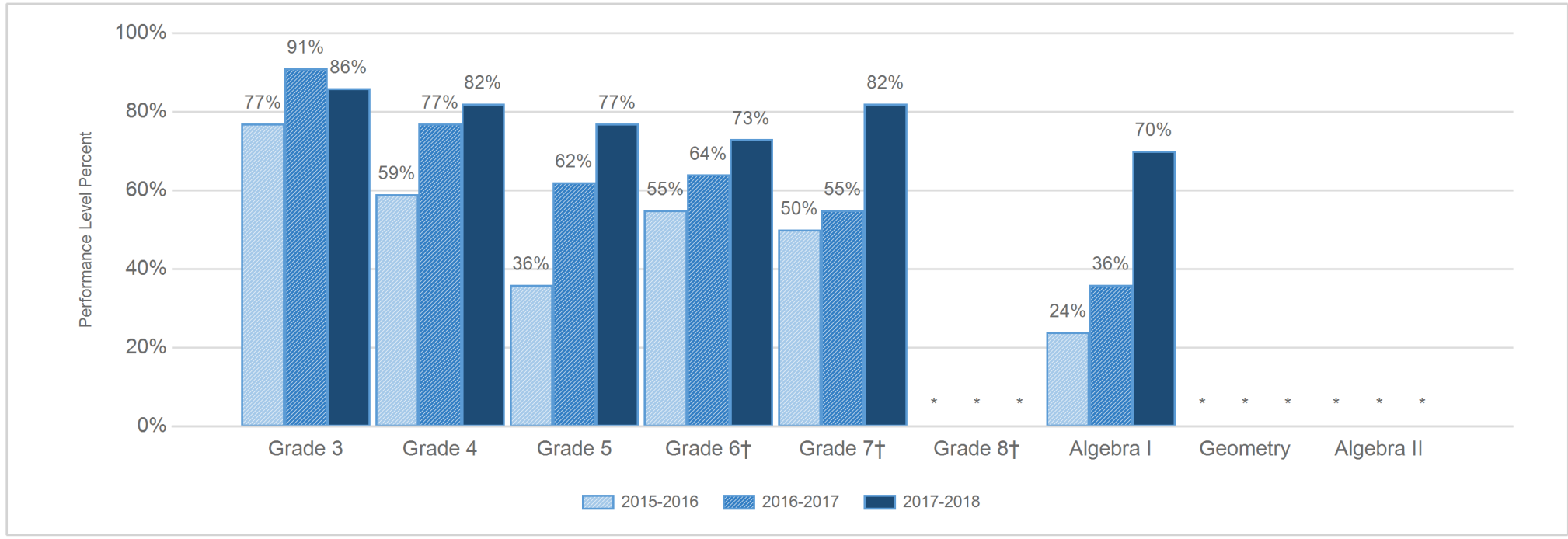

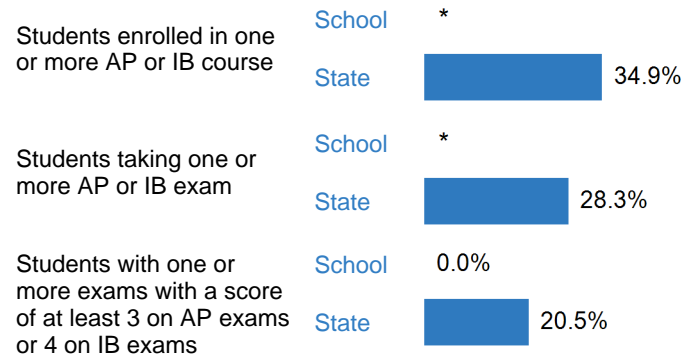

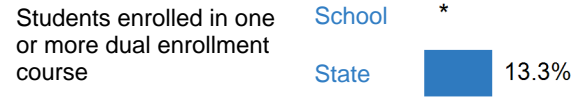

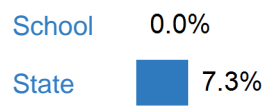

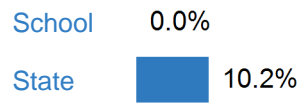
CTE Participants

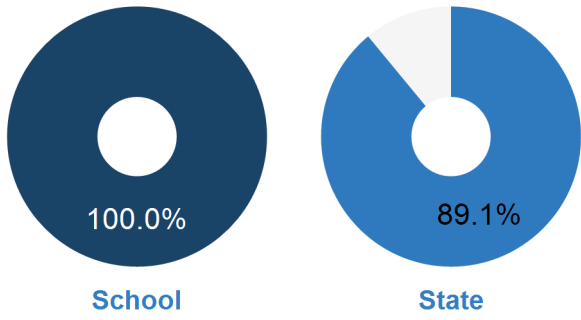

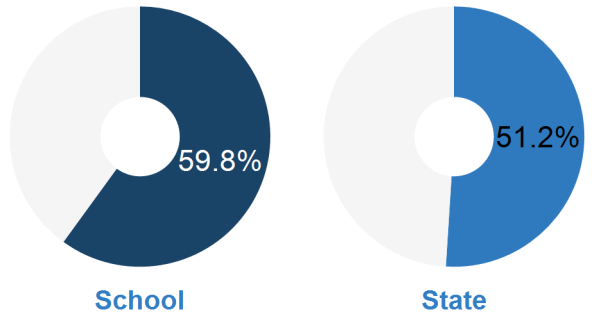

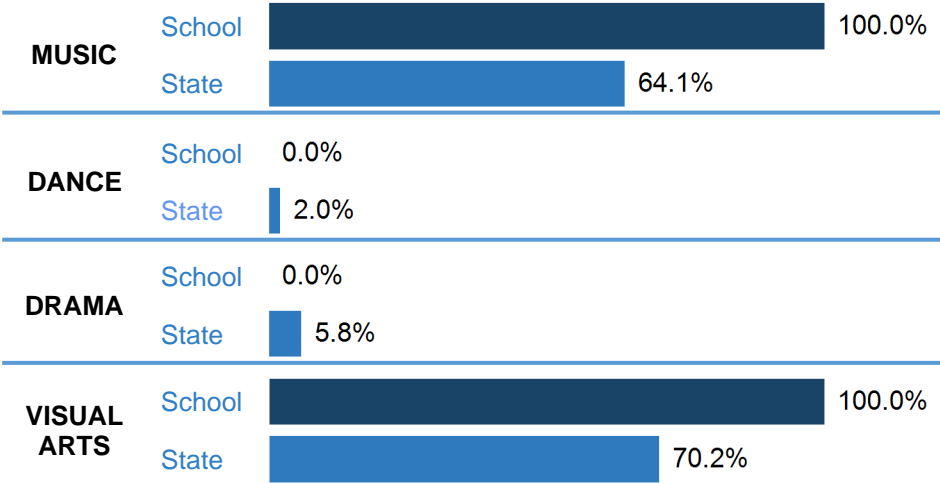

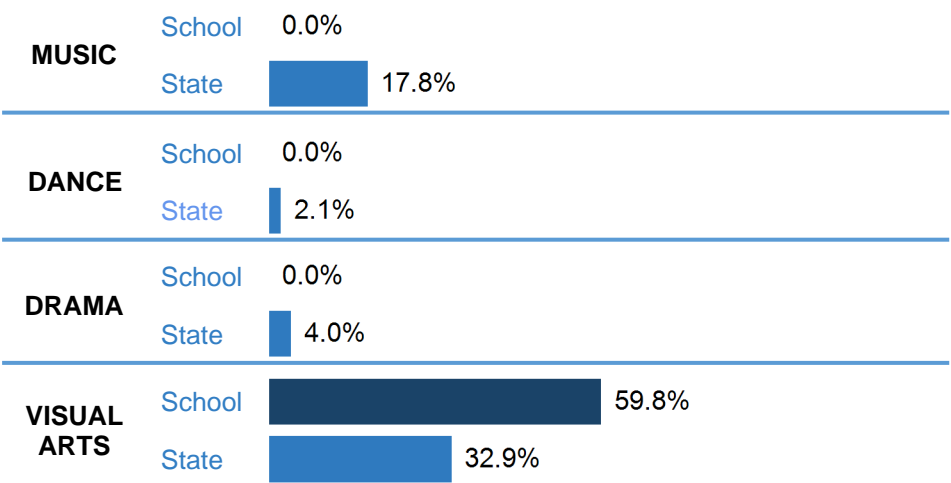

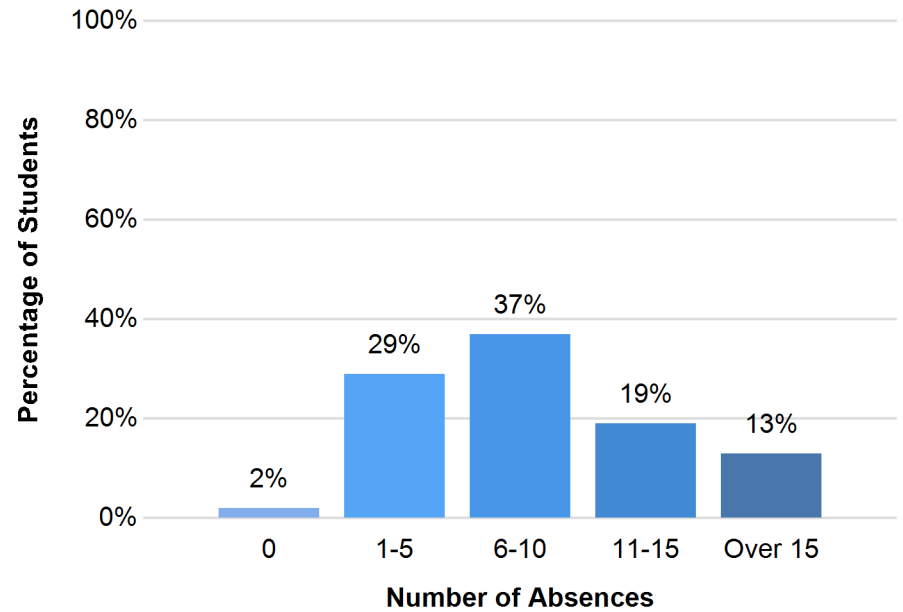

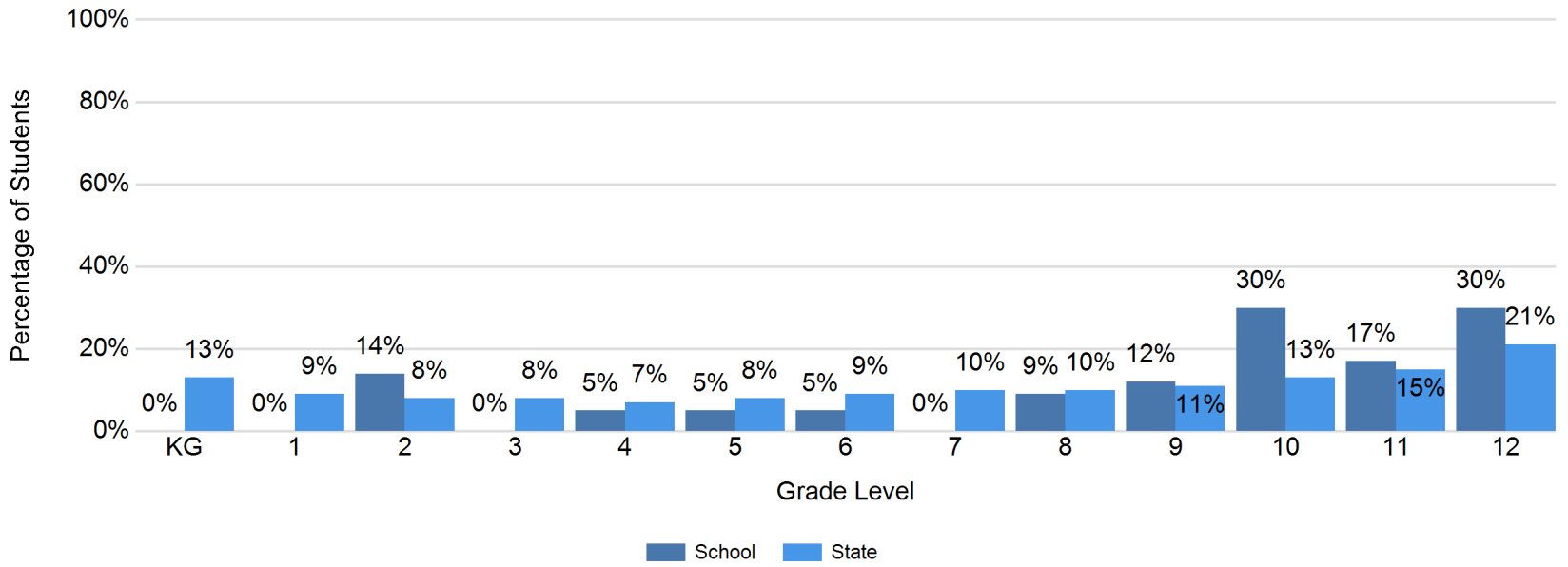
