JOHN MAYHEW, Samuel Randolph, Peter Haring, James Linn, John Condit, John Lambert, Samuel Ogden and Abraham Kitchel, Esquires, severally produced Certificates of their being duly elected Members of this House, which were read and approved, and they thereupon took and subscribed the Oaths required by Law before Thomas Henderson, Esquire, one of the Members returned for this House, and took their Seats in Council.

Thomas Henderson, Esquire, produced a Certificate of his being duly elected a Member of this House, which was read and approved, and he thereupon took and subscribed the Oaths required by Law before Samuel Ogden, Esquire, and took his Seat in Council.

John Black, Esquire, produced a Certificate of his being duly elected a Member of this House, which was read and approved, and he (being one of the People called Quakers) took and subscribed the Affirmations required by Law before Thomas Henderson, Esquire, and took his Seat in Council.

The Honourable Thomas Henderson, Esquire, was elected Vice-President of the Council, pursuant to the Constitution, and he thereupon took the Oath of Office, and was seated in the Chair.

Bowes Reed was unanimously elected Clerk of the Council, and took the Oath of Office accordingly.

John West was appointed Door-keeper.

*Ordered*, That Mr. Haring do wait on the House of Assembly, and acquaint them that a sufficient Number of Members of this House have met, elected the Honourable Thomas Henderson, Esquire, Vice-President, and proceeded to Business.

Mr. Haring reported, that he had obeyed the Order of the House.

Mr. Benson, from the House of Assembly, acquainted this House that a Quorum of the House of Assembly had met, elected the Honourable Silas Condict, Esquire, their Speaker, and proceeded to Business.

The House adjourned until ten o'Clock To-morrow Morning.

*Wednesday, October 23, 1793.*

The House met—Present as before.

The House adjourned until three o'Clock P. M.

The House met.

His Excellency the Governor came into Council.

Mr. Blackwood, from the House of Assembly, acquainted this House that the House of Assembly had appointed Messrs. Kitchel, Camp, Ward, Southard, Ryerson, Ridgway, Blackwood, Stillwell, Mayhew, Fithian, Whilldin, Vredenburg and Wyckoff a Committee to confer with a Committee of Council, and report what Business was essentially Necessary to be done at this Sitting; and requested Council would appoint a Committee to join the said Committee for that Purpose.

*Ordered*, That Messrs. Linn, Condit and Kitchel be a Committee to join the Committee of the House of Assembly for the above Purpose, and make report; and that Mr. Condit do wait on the House of Assembly and acquaint them therewith.

Mr. Condit reported, that he had obeyed the Order of the House.

The Governor laid before the House a Letter from Samuel Adams, Esquire, Lieutenant-Governor of Massachusetts, with sundry Resolutions respecting the Propriety or Expediency of a Sister State commencing a Suit against the State at large, and requesting this State to join in an Application for an Amendment of the Constitution in that Respect; which were read and ordered a second Reading.

The House adjourned until ten o'Clock To-morrow Morning.

Mr. Linn, from the Committee appointed Yesterday to join a Committee of the House of Assembly, made the following Report:

**T**HE Joint-Committee of the Council and Assembly, appointed to confer on the Subject of what Business is essentially Necessary to be done at this Sitting, beg Leave to report, as their Opinion, That an Act for the Support of Government ought to be passed, and a Joint-Meeting, appointed for the Purpose  
of

of choosing Officers of Government, ought to take Place before the Rising of the Legislature.

Which Report being read, *Resolved*, That the House approve thereof.

Mr. Camp, from the House of Assembly, acquainted this House, that they were ready to go into Joint-Meeting, and requested Council to appoint the Time and Place of Meeting; and also, acquainted this House that Messrs. Van Cleve, Fithian, Lloyd, Newton, Imlay, Rattoon and Welsh were appointed a Committee to join a Committee of this House for the Purpose of examining and settling the Treasurer's Accounts, and requested this House to appoint a Committee to join the said Committee for that Purpose.

*Ordered*, That Messrs. Ogden, Condit and Randolph, or either of them, be a Committee to join the Committee of Assembly for the above Purpose; and that Mr. Randolph do wait on the House of Assembly and acquaint them therewith.

The House adjourned until three o'Clock P. M.

The House met.

Charles Beardslee, Esquire, produced a Certificate of his being duly elected a Member of this House, which was read and approved, and he thereupon took and subscribed the Oaths required by Law before the Vice-President, and took his Seat in Council.

Mr. Beardslee having given his Reasons for Non-Attendance until this Day, *Resolved*, That they are satisfactory.

Mr. Clement, from the House of Assembly, acquainted this House that they had appointed Messrs. Marsh, Sinnickson and Clement a Committee to join a Committee of Council for the Purpose of counting and burning the cancelled Money now in the Treasury, and requested that this House would appoint a Committee to join the said Committee for said Purpose.

*Ordered*, That Messrs. Black and Kitchel be a Committee to join the said Committee for the foregoing Purpose; and that Mr. Randolph do wait on the House of Assembly and acquaint them therewith.

*Ordered*, That Mr. Randolph do wait on the House of Assembly, and acquaint them that this House will be ready to go into a Joint-Meeting this Afternoon, five o'Clock, in the Assembly-Room.

Mr. Randolph reported, that he had obeyed the several Orders of the House of this Day.

A Petition from Samuel Sharp and Edward Sharp, of the County of Suffex (Overseers of Iron-Works) praying an Exemption for their Labourers employed at said Works from Militia Duty, was read, and ordered a second Reading.

The House withdrew to attend a Joint-Meeting; after some Time the House returned and adjourned until ten o'Clock To-morrow Morning.

Mr. Lloyd, from the House of Assembly, acquainted this House that the  
 House of Assembly have concurred in the Resolution on the Memorial of  
 the Honourable Thomas Henderson, Esquire.

The Bill, intituled, ‘ An Act for defraying incidental Charges,’ was read  
 a third Time, and, on the Question, Whether the same do pass? It was  
 carried in the Affirmative; Nem. Con.

*Ordered*, That the President do sign the same.

*Ordered*, That Mr. Randolph do wait on the House of Assembly, and ac-  
 quaint them that the said Bill is passed by this House without Amendment.

Mr. Randolph reported he had obeyed the Order of the House.

The Honourable Silas Condict, Esquire, Speaker of the House of Assem-  
 bly, came into Council, and acquainted the President that the House of  
 Assembly had gone through their Business, and adjourned sine Die.

Whereupon Council adjourned sine Die likewise.
