### **College and Career Readiness**

Additionally, this school is meeting 0% of its performance targets in the area of College and Career Readiness.





This graph presents the count of students who were 'on roll' by grade in October of each school year.






### **Enrollment by Ethnic/Racial Subgroup**
























### **Enrollment by Ethnic/Racial Subgroup**
















