






Student Growth by Performance Level

These graphs show the median Student Growth Percentile for students in each grade.





English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the statewide assessment (NJSLA for 2018-19 and PARCC for 2016-17 and 2017-18) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures the percentage of students that met or exceeded expectations on the assessments (NJSLA/PARCC or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA/PARCC results include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. 













This graph shows the percentage of K-12 students by the number of days they were absent during the school year.


















Student Growth by Performance Level

These graphs show the median Student Growth Percentile for students in each grade.











This graph shows the percentage of K-12 students by the number of days they were absent during the school year.









Wolf Hill School has an Intervention and Referral Service (I&RS) committee. Identified students participate in Basic Skills Instruction (BSI) and English Language Learner (ELL) programs. Students may also receive accommodations and/or modifications required by the ADA through a 504 Plan. Referred students are evaluated by the Child Study Team. Students found eligible for Special Education and related services are provided with a full array of special education programs, as per the Individualized Education Program (IEP). Speech, occupational therapy, and physical therapy are also available. Counseling services are available to all students through school guidance staff.



Student Health and Wellness:

The health curriculum promotes health and wellness. Students participate in gym/health three days a week. All students have outdoor recess every day (weather permitting).
