Motor Vehicle Commission Presents at DDHH Advisory Council Help is available for deaf and hard of hearing driver's license applicants

On July 27, the staff from the New Jersey Motor Vehicle Commission, or the MVC, attended the **DDHH Advisory Council** meeting and gave a presentation on the written road test requirements and interpreter services for those tests. According to the MVC, it will secure an interpreter for a deaf and hard of hearing applicant who is unable to read nor understand English concepts and needs an interpreter to translate in their primary mode of communication, American Sign Language.

For example, when a deaf and hard of hearing applicant takes the written test, they should use the interpreter on the monitor screen. If this applicant fails, then they can request an on-site- interpreter. Applicants should call (609) 292-6500 if there are any issues with requesting an interpreter and/or to request an interpreter for the next test.

As for the road test, deaf and hard of hearing applicants can request an interpreter for communication before and after the test. This means that when a deaf and hard of hearing applicant arrives for the test, the applicant will have opportunity to use an interpreter to ask questions and receive instructions through American Sign Language.

Morris County Domestic Violence Agency Provides Text Access

The **Jersey Battered Women's Service** in Morris County is a domestic violence agency that provides various services to those who live or work in Morris County and have experienced domestic abuse.

The services include a 24-hour helpline, counseling, safe house, transitional living, children's services, life skills education, vocational counseling, batterers' intervention, legal assistance, teen dating violence services, and professional training, education and youth prevention programs. They have launched a 24-hour Texting Helpline in an effort to ensure the accessibility of their services. The Text Helpline number is 973-314-4192, which is also listed at http://www.jbws.org/. Although they serve individuals who live or work in Morris County, they can provide information and referrals for the other domestic violence agencies in the state or other community resources.
