






























Student Growth by Performance Level







Other Information:

Irene E. Feldkirchner School has two Integrated PreSchool classrooms. One is full-day and the other is full-day with an optional half-day. Regular Education Students pay tuition. Class openings are for Green Brook residents, as well as neighboring communities. Students in Grades 3 and 4 have chromebooks available in their classroom setting. Students in Grades K-2 have IPADs for interactive learning via apps. All students receive one period of Art, Music, Spanish, and Technology (K-4 only) and two periods of Physical Education per week. In Language Arts, we subscribe to a balanced literacy approach. Specifically, Readers/Writers Workshop, FUNdations, and Interactive Read Alouds. For Mathematics, we used Envision Math to teach critical-thinking and problem-solving strategies as a basis for instruction. Typically, students spend 120 minutes per day on Language Arts and 60 minutes on Math Instruction. For science and social studies, 30 minutes per day is built into the schedule. Finally, students have a lunch/recess period to feed their bodies, as well as their social/emotional development. Routinely, the guidance counselor offers friendship groups, social skills, and playtime supports as students navigate sharing, caring, and understanding actions and reactions. Every teacher is equipped with a MacBook Air to use as an instructional tool in the classroom. For example, with the use of dongles, teachers can project onto a smartboard videos, passages, and visuals.
