REPORT.

OFFICE OF THE STATE LIBRARIAN,
TRENTON, N. J., November 1st, 1879. }

To his Excellency George B. McClellan, Governor of New Jersey :

I have the honor to submit the following report for the year ending October 31st, 1879.

The additions to the Library have been as follows :

It will be seen by the above that the additions, both to the Law and Miscellaneous departments, have been much larger, during the past year, than usual, and yet many books are needed to make the Library what it should be, as a State Library. In 1872 an appropriation was made of two thousand dollars per year, for five years, and the Library has heretofore received (by a law of the State) eight hundred dollars per year, paid by the United States Government for rent of Court room. The former having expired, and the latter being no longer received, the income of the Library is not sufficient for the purchase of such books as are needed. I would respectfully advise a new appropriation, sufficient to keep up the necessary purchases.
