Science curriculum was revised to include Next Generation Science Standards. The district implemented STEM in all grades and enhanced the language arts curriculum. TES implemented Open Circle, a social and emotional program for students in grades K through 5. Qualifying students meet with our teacher of gifted and talented each week for enrichment, emphasizing creativity and critical thinking. Character education is integrated throughout the curriculum.

Courses, Curriculum, Instruction:

Some of our students participate in Odyssey of the Mind, a creative problem-solving competition. Girl Scouts and Boy Scouts meet at TES after school. Students, staff members, and parents volunteer to plant, maintain, and harvest our Victory Garden. Historically we raise 300 pounds of fresh food for the Open Cupboard Food Pantry.
