Chapter Historical Note

Chapter 73, Reduced Fare Transportation Program for the Elderly and Handicapped, was originally adopted as N.J.A.C. 16:51-4, Delegation of Powers for Senior Citizens Half-Fare Bus Program, by R.1975 d.113, effective April 30, 1975. See: 7 N.J.R. 63(b), 7 N.J.R. 280(b). N.J.A.C. 16:51, Reduced Fare Transportation Program, was adopted as R.1977 d.224, effective June 23, 1977. See: 9 N.J.R. 97(a), 9 N.J.R. 349(a). N.J.A.C. 16:51, Reduced Fare Transportation Program, was recodified to N.J.A.C. 16:73, and N.J.A.C. 16:51-4 was repealed by R.1982 d.40, effective February 16, 1982. See: 13 N.J.R. 881(a), 14 N.J.R. 209(a).

SUBCHAPTER 1. INTRODUCTION

16:73-1.1 Definitions

The following words and terms, when used in this chapter, shall have the following meanings unless the context clearly indicates otherwise.

“Carrier” means any individual, copartnership, association, corporation, joint stock company, public agency or public authority, trustee or receiver operating or controlling motor buses or rail passenger service on established routes within the State or between points in this State and points in adjacent states.

“Commissioner” means the Commissioner of Transportation, or his or her designee.

“Established routes” means all regular intrastate routes of the participating carriers authorized by the Office of Regulatory Affairs of the Department of Transportation, NJ TRANSIT, municipality, or any other regulatory agency and interstate routes authorized by the Interstate Commerce Commission, NJ TRANSIT, or any other regulatory agency. “Established routes” does not include those trips to and from Atlantic City locations when the user receives from any source, money or other gratuities in addition to the transportation purchased.

“Interstate” means between points in this State and points in adjacent states.

“Intrastate” means points within the State of New Jersey (State).

“Motor bus” means “autobus” as defined in N.J.S.A. 48:4-1, and includes those autobuses, commonly called jitneys, as described in N.J.S.A. 48:16-23.

“NJ TRANSIT” means the Executive Director of the New Jersey Transit Corporation or his or her designee.

“Off-peak times” means the hours between 9:30 A.M. to 4:00 P.M. and from 7:00 P.M. to 6:00 A.M. during the weekdays, and all day on Saturdays, Sundays and State holidays.

“Person with a disability” means any individual who, by reason of illness, injury, age, congenital malfunction or other permanent or temporary incapacity or disability, is unable without special facilities or special planning or design to utilize mass transportation facilities and services as effectively as persons who are not so affected.

“Reduced Fare” means one half rounded down to the nearest nickel of the regular adult one way fare as set forth in the tariffs of the carrier filed with the Office of Regulatory Affairs of the Department of Transportation, NJ TRAN-

SIT, Interstate Commerce Commission, a municipality or any other regulatory agency.

“Round trip excursion fare” means a rail passenger fare offered to NJ TRANSIT passengers at a discounted rate. Its specific applications and use are governed by NJ TRANSIT revenue procedures as set forth in internal documents and on published rail timetables.

“Senior citizen” means any individual 62 years of age or over regardless of residence.

“Senior citizen age 65 and over” means any individual who has attained the age of 65 years or more, regardless of residence.

16:73-1.2 Purpose

(a) The “Reduced Fare Transportation Program” is designed to provide intrastate and interstate autobus and rail passenger service for senior citizens age 62 through 64 during off peak times on regular routes of the participating carriers at one-half of the regular adult one way fare as set forth in the tariffs of the carrier filed with the Office of Regulatory Affairs of the Department of Transportation, NJ TRANSIT, Surface Transportation Board of the United States Department of Transportation, a municipality or any other regulatory agency.

(b) The Reduced Fare Transportation Program is also designed to provide intrastate and interstate autobus service for senior citizens age 65 and over and people with disabilities at all times on regular routes of the participating carriers at one-half of the regular adult one way fare as set forth in the tariffs of the carrier filed with the Office of Regulatory Affairs of the Department of Transportation, NJ TRANSIT, Surface Transportation Board of the United States Department of Transportation, a municipality or any other regulatory agency.

(c) The Reduced Fare Transportation Program is further designed to provide intrastate and interstate rail passenger service for senior citizens age 65 and over and people with disabilities at most times. The New Jersey Transit Corporation may decline to offer the discounted fare on trains denoted in its published timetables as ineligible for its round trip excursion fare.

16:73-1.3 Exclusions

Senior citizens or people with disabilities are not permitted to ride at a reduced fare on intrastate and interstate school, charter, demand activated, special or excursion motorbus or rail passenger services and trips to or from Atlantic City locations when the user receives, from any source, money or other gratuities in addition to the transportation purchased.

SUBCHAPTER 2. IDENTIFICATION AND REGISTRATION

16:73-2.1 Registration of senior citizens for NJ TRANSIT Reduced Fare Identification Card

(a) A valid Medicare Card in the possession of the person to whom it has been issued shall be a valid NJ TRANSIT Reduced Fare Identification Card (Identification Card). No further registration is necessary.

(b) A senior citizen who does not have a Medicare Card will need an Identification Card. Individuals may obtain an Identification Card application by writing or calling the NJ TRANSIT Reduced Fare Program at:

Applications for the Identification Card are available at most banks, savings and loan associations, County Offices on Aging and State offices providing services for senior citizens and people with disabilities. The applicant should bring proof of age to the application center. Any valid legal document will serve as proof of age. Examples are: driver's license, birth certificate, passport, military discharge papers (DD214), etc.

(c) Authorized personnel of the application centers will examine the required documents and application. The application centers will then forward the completed application to NJ TRANSIT for processing.

(d) NJ TRANSIT shall issue an Identification Card to each qualified applicant. The Identification Card shall be valid until age 65, at which time most individuals receive a Medicare Card. NJ TRANSIT will not establish an automatic renewal procedure. If a senior citizen does not hold a Medicare Card and wishes to renew the Identification Card, he or she may contact NJ TRANSIT's Reduced Fare Program or complete a new application at one of the locations listed in (b) above.

16:73-2.2 Registration of people with disabilities for NJ TRANSIT Reduced Fare Identification Card

(a) Persons must write or call the NJ TRANSIT Reduced Fare Program for an application form for people with disabilities.

(b) Individuals may obtain an Identification Card application by writing or calling the NJ TRANSIT Reduced Fare Program at:

(c) Applicants will fill out the first part of the application form and give it to a registered physician, doctor of osteopathy or other designee of NJ TRANSIT who will complete the application and mail to NJ TRANSIT. The final decision on eligibility will be made by NJ TRANSIT.

(d) NJ TRANSIT will process the application, and mail an Identification Card to the person with disability. The Identification Card will be valid for four years from date of issue, unless it has been determined that the applicant has a temporary disability in which case the length may be less than four years.

16:73-2.3 Use of Medicare and Identification Cards

(a) Senior citizens or people with disabilities must present a properly validated Medicare or Identification Card to the motorbus or rail passenger operator or ticket agent as proof of being qualified to participate in the "Reduced Fare Transportation Program."

(b) Presentation of a validated Medicare or Identification Card together with the proper Reduced Fare is all that is required for rail passenger travel and all motorbus passenger travel; provided, however, that on motorbus routes run by certain carriers, NJ TRANSIT may, upon consultation with such carriers, continue to require presentation of Reduced Fare Tickets.

(c) The Identification Card, which is not transferable, may be used only by the person to whom it is issued, and must be kept in that person's possession during the entire ride.

(d) If the Identification Card is lost or stolen, an application for a replacement card may be made as prescribed in N.J.A.C. 16:73-2.1 and 2.2.

16:73-2.4 Reduced fare tickets

NJ TRANSIT does not sell books of reduced fare tickets. Senior citizens or people with disabilities who want to ride NJ TRANSIT buses or trains may pay their fare on the bus or train or purchase one way reduced fare tickets prior to their travel at NJ TRANSIT ticket windows or ticket vending machines or from commissioned ticket agents (who are contracted by NJ TRANSIT to sell NJ TRANSIT tickets). For reduced fare interstate travel on lines run by private bus companies, NJ TRANSIT distributes special voucher booklets at banks, County Offices on Aging and State offices providing services for senior citizens or people with disabilities. In addition to paying a reduced cash fare, senior citizens or people with disabilities shall present to the bus operator a "voucher" torn from these booklets along with his or her Reduced Fare Identification Card or Medicare Card. The Atlantic City Jitney Association does sell ticket books that offer a discount off the senior citizens or people with disabilities reduced rate.

SUBCHAPTER 3. AGREEMENTS WITH CARRIERS FOR SERVICES AND PAYMENTS

16:73-3.1 Agreements with carriers

(a) NJ TRANSIT may enter into contractual agreements with a carrier which desires to participate in the Reduced Fare Transportation Program. Each contract shall contain conditions, terms and provisions as NJ TRANSIT may require, including but not limited to, provisions permitting or relating to:

1. Terms and method of payment;
2. Auditing and settlement of payments;
3. Data and recordkeeping;
4. Service to be performed pursuant to the contract;
5. Applicable tariffs and schedules;
6. Any such other matters as NJ TRANSIT deems to be in the public interest.

16:73-3.2 Method of payment to carriers

Reimbursement to the participating carriers shall be an amount equal to the senior citizens or people with disabilities reduced fare, multiplied by the number of eligible trips by senior citizens or people with disabilities participating in the Reduced Fare Transportation Program, provided that the total payments to the carrier do not exceed the budget of NJ TRANSIT for this program. In cases where the carrier has rounded down the reduced fare to the nearest nickel, NJ TRANSIT shall reimburse an additional nickel per each qualified senior citizen or people with disabilities. For bus service, eligible trips may be determined by the number of reduced fare tickets submitted by bus carriers, or such other reasonable method as shall be determined by NJ TRANSIT, including, but not limited to, the use of historical payment data. For rail service, eligible trips are determined by special tickets provided by the rail carriers under their existing tariff rules.
