In accordance with the amendment to "New Jersey First Act" N.J.S.A. 52:14-7 (S.1730 P.L. 2011, c. 70) The Richard Stockton College of New Jersey is a public educational institution and therefore the New Jersey residency requirement applies to all employees hired after September 1, 2011. However, the bill provides some flexibility to institutions of higher education to ensure they are able to compete with similarly situated colleges and universities in other states. Exemptions will be granted, such as for visiting college professors and other employees "requiring special expertise or extraordinary qualifications in an academic, scientific, technical, professional, or medical field or in administration." Based on this provision of the law, we are submitting a report of the titles that should be exempt from the residency requirement (attachment 1). In addition to the exempt titles we are providing the State with those titles that should be required to abide by the New Jersey primary residency requirement (attachment 2).
