# Governor Murphy Nominates Zenon Christodoulou and Maria Rodriguez-Gregg as New Jersey Board of Public Utilities Commissioners

**TRENTON** – Governor Phil Murphy today announced his nominations of Zenon Christodoulou and Maria Rodriguez-Gregg as Commissioners on the New Jersey Board of Public Utilities (NJBPUB). Their nominations will go to the Senate for confirmation.

Maria Rodriguez-Gregg currently serves as Director of Government Relations and Community Affairs at Montclair State University. A former member of the General Assembly, Rodriguez-Gregg represented the 8th Legislative District from 2014 to 2018. She also served on the Board of Trustees at Burlington County College and on the Board of Directors of Habitat for Humanity. Rodriguez-Gregg is a graduate of Rutgers University-Camden, where she received a degree in economics.
