Governor Murphy Takes Action on Legislation

TRENTON – Today, Governor Phil Murphy absolute vetoed the following bills:

A-3813/S-2292 (Burzichelli, Schepisi, Lampitt/Cardinale, Beach) - Permits use of virtual or remote instruction to meet minimum 180-day school year requirement under certain circumstances

A-3841/S-2300 (Pintor Marin, Bramnick, Chiaravalloti/Diegnan, Sarlo, A.M. Bucco) - Automatically extends time to file gross income tax or corporation business tax return if federal government extends filing or payment due date for federal returns

A-3842/S-2282 (Greenwald, Taliaferro, Quijano/Ruiz, T. Kean) - Establishes Bridging the Digital Divide in Schools Grant Program in DOE to provide and expand access to technology and equipment for students in certain school districts

A-3846/S-2293 (Sumter, Chaparro, Quijano/Madden, Lagana) - Creates "Temporary Lost Wage Unemployment Program;" allows persons to claim for lost wages due to coronavirus disease 2019, and employers to pay wages to workers ordered under quarantine by licensed healthcare practitioner; appropriates \$20,000,000
