## 177th FW holds active shooter exercise

In 2007, a group of six radical Islamist men conspired to attack United States military personnel stationed at Fort Dix, New Jersey.

On November 5, 2009, a mass shooting took place on, at Fort Hood, Texas — the most heavily populated American military base in the world.

“Military personnel take it for granted that we are targets when we deploy – it comes with the duty,” said 177th Fighter Wing Commander Col. Robert C. Bolton. “Sometimes we forget that the battlefield is here at home also.”

To combat the growing threat, the 177th Fighter Wing held a base-wide active shooter exercise on May 5 involving 177th Security Forces and elements of the New Jersey State Police and Egg Harbor Township Police, along with observers from various state and federal agencies.

The exercise involved a single gunman who after successfully gaining access to the base was cornered by a 177th Contact Team – the Wing’s first responders in such an event – and neutralized.

“We can guard against this; but the key is to have a plan in place and be prepared,” said Bolton.

The exercise served to test and validate the Wing’s ability to alert Airmen to take cover, notify first-responders, to neutralize the threat and finally, to assess the unit’s ability to deal with the consequences of such an event, as well as to interact with multiple law enforcement agencies.

Unlike an attack by enemy soldiers, active shooter is essentially a criminal act and, because there is usually no criminal objective involved, other than pure violence, these scenarios are dangerous



and require specialized training on the part of all members of the base population.

“In most cases active shooters have only one goal; to kill as many people as possible,” said Master Sgt. Joseph A. Iacovone Jr., 177th Security Forces and member of the Exercise Evaluation Team.

“The plan held up well under the test of the actual exercise,” said Chief Master Sgt. Jack Dever, 177th Fighter Wing Anti-terrorism Officer. “It will require some minor modifications prior to publication, but that is expected within a week.”

“I am already getting inquiries and requests for guidance on this program from other units,” said Maj. Jan. J. Burgess, 177th Security Forces Commander.

## State Direct Deposit pay stubs are on the Web

State employees, do you currently have Direct Deposit? Are you tired of the hassle of keeping track of your pay stubs? Just think; the shredding, the filing, the lack of space, the unnecessary mess. You can eliminate all of that (and save a tree or two) with New Jersey's *Pay Stub on the Web*! The State of New Jersey is making payment history available to state employees with electronic funds transfer (EFT), commonly known as direct deposit, with "Pay Stub on the Web." This newest feature is an online application that enables a New Jersey state employee to access his/her pay stubs, beginning with 2005 payment history, via the web. Now when you want to see your pay stub, you simply view it online. You can print it out if you wish, save it to your computer, do neither or both! It's all up to you. Any time you need your pay stub, it is available for you to view, right on the web! And if you try it out and decide it's not for you, you can cancel this feature at any time and go back to receiving your paper pay stub. There's no risk, so why not try it out?

Want to know a little more about how it works and how you can benefit from Pay Stub on the Web? Check out the attachment on DMAVA INTRANET under Human Resources (*PayStubOnTheWeb.pdf*) which is a simple tutorial that explains how you can use "Pay Stub on the Web" to view, print, and save your current and past pay stubs for your personal records. Remember, this feature is only available to employees with direct deposit. As we mentioned in the past, direct deposit is offered to all state employees and it is encouraged that our employees consider taking advantage of direct deposit with all that it has to offer.

It's slowly warming up and tempting some of us to run on the old AC to cool down our houses. I would bet that a number of readers grew up in homes without air conditioning and we have lived to tell the tale! How did we survive? Here are a few tips to keep your home cooler without flipping the AC switch.

Fans can be a big help. Ceiling fans can reportedly make you feel 3-8 degrees cooler. Just make sure the fan is turning the correct way. Most fans have a switch to change direction and you want the fan to blow the air down. Make sure your fan is turned off when you flip the switch so you don't damage the motor. Make sure your filter has been cleaned and clean it every month while using it.

Don't block your outdoor condenser with grass and other debris.

Make sure the insulation in your attic is up to code.

Plant shade trees.

Make sure your doors and windows are well-sealed.

Close the drapes, curtains and shades to block the sun and heat.

Keep the kitchen cool and don't use the oven to cook – microwave, grill outdoors, or best of all, go out to eat and enjoy the restaurant's AC.

Girls items (make-up, brushes, mirrors, stuff for hair, etc.)

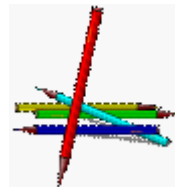

## La. Army Guard helps N.J. Air Guard to get the job done

CAMP LIBERTY, Iraq - For soldiers in an ever-changing combat environment, the only consistency is change itself. "Improvise, adapt and overcome," is a common military phrase, but more than just a phrase, it is the current way of life for U.S. service members.

A group of soldiers from the Headquarters and Headquarters Company, 199th Brigade Support Battalion, Louisiana Army National Guard, not only implemented that phrase after their mission changed from convoy escort to force protection, but were recognized by another branch of service for their ability to improve operations when they assumed the security responsibility of an entry control point here.

Air Force Lt. Col. Paul E. Novello, commander of the 447th Expeditionary Civil Engineer Squadron, and his Airmen were grateful when the Louisiana Guardsmen took over an ECP on Victory Base Complex. They presented the Soldiers with certificates for helping complete projects that would otherwise be hindered due to the demands of contractors gaining access to the base.

To ensure the safety of the multi-national coalition forces on the installation, all personnel must complete an in-depth process before entering the complex. Since one of the gates secured by the 199th soldiers is primarily used by national contractors, the process can be very time-consuming.

According to the 199th first sergeant, Scott Corley, the contractor convoys ECP is only open for a pre-determined amount each day. Larger contractors often had the smaller contractors experiencing a difficult time receiving supplies. This hindered the ability to complete projects as the U.S. sets the conditions for the responsible drawdown of its forces in Iraq.

"The Soldiers not only recognized the issue, but also found a way to balance the flow of traffic between the contractors," Corley explained.

"We have many construction projects at the Air Base," added Novello. "These guys worked together to find a way to help ensure that the contractors delivering the materials had everything they needed to get through the gate as quickly as possible so that we could complete the necessary projects before the drawdown."

Novello explained that because of these soldiers' efforts, the Air Force was able to continue and complete a project that had already been delayed more than three months.

"It really says a lot anytime that there is inter-service recognition, but for my guys to only be on mission for about a month and to already be presented with this honor is indicative of their hard work and ability to adapt to any given mission," said Corley.

## N.J. Bar offers free legal assistance to military

Eligibility for the program is not income based. The program was created to meet the expected demand of military reservists in the current operational tempo and offers assistance in four primary areas:

- Family Law
- Employment Law
- Debtor-Creditor Law
- Medical Evaluation Boards (MEBs)
