

Aside from Pino living an entire century what is significant about this date? Well, it's also Veterans Day and Pino knows all about being a veteran.

This man has lived through WWI, served during WWII and the

Korean War, and seen thousands of brave men and women fight in the Vietnam War, Persian Gulf War and the current war on terrorism.

He was presented with a congratulatory plaque from NJ DMA-VA for his military service and longevity, as well as a centenarian birthday greeting from the White House, which was signed by President Obama.

Pino served in the Army as a cook during WWII and during the Korean War.

Present at his birthday celebration were his wife, Mary; his two sons, Jack and Michael; grandson, Nicholas; and great-grandson, Jake, as well as other family members of the Pino clan.

As members of the 177th Fighter Wing, New Jersey Air National Guard, make their way to Afghanistan, I will be profiling them in episodes of "Devils in the Fight." It is fitting that the first person I will be covering is Col. John DiDonna, 177th Operations Group commander, who is deployed as one of two deputy operations group commanders at Bagram Airfield, Afghanistan. DiDonna is also one of the first flyers to arrive here, and has been on station for several months.



"Upon my arrival, I was truly amazed at the size of and makeup of the Operations Group; 11 combat squadrons including over 1,000 Airmen, Sailors, and Marines," said DiDonna. "In comparison, the 455th Expeditionary Operations Group is approximately the size of the entire 177th Fighter Wing. I am amazed at the work ethic, individual commitment, selfless service, and team effort of all Bagram warriors, including those Airmen currently deployed from the 177th."

"The flying here is like none other than I have experienced in my career," said DiDonna. "The terrain in Afghanistan is ominous; rugged, mountainous, presenting unique tactical challenges. The missions can be intense, solely focused on providing Coalition forces close air






support. I am truly amazed by Coalition forces and their brave dedication and relentless commitment to this counterinsurgency effort."

"I routinely inquire about family members supporting this operation from afar. I am equally astounded, hearing stories of their commitment, support, and sacrifice," said DiDonna. "Without their understanding, the intense focus required to accomplish this difficult mission would not be possible."

The men and women of the 177th who are currently supporting Operation Enduring Freedom are contributing greatly to the effort here, and I will be covering more areas in future "Devils in the Fight!"

Veterans right's awareness seminar

The New Jersey Attorney General's (AG) Office, in partnership with The American Legion, will conduct a regional Veterans' Civil Rights seminar on Nov. 18, from 9 a.m. - 12 p.m., at Post 414, 100 Berwyn Place in Lawrenceville.

All veterans, active duty, Reservists, National Guard, family members, and veteran service organizations are invited to attend. You do not have to belong to The American Legion to participate.

The AG's office, Division on Civil Rights (DCR), has proactively noticed a rise in veterans' discrimination claims in the areas of employment, housing, and other subjects. Veterans are entitled to employment-related protection under the New Jersey Law Against Discrimination (LAD). This law also provides substantial protection of those who seek to gain or continue employment with a disability. DCR has a special interest in any veterans with disabilities having discrimination complaints in employment, housing, public accommodations. They are also concerned about military reservists that have lost their employment or assigned to different positions following their return from military leave.

The DCR's office has suggested, and subsequently produced an education seminar to inform all veterans of their civil rights. They will explain the process to file a claim, and the locations of their offices that are available to assist veterans in need of these services.

The American Legion will host this and further seminars across the state.
