# REPORT.

Office of the State Library, Trenton, N. J., Nov. 1, 1885.

To His Excellency Leon Abbett, Governor of New Jersey:

SIR—I have the honor of submitting the following report of the condition of the State Library for the fiscal year ending October 31st, 1885:

According to the last annual report the whole number of books in the library was 29,701. During the past year 1,283 volumes have been added to the Library by exchange, donation and purchase, as follows:

By purchase, miscellaneous books	83
By purchase, law books	375
By subscription, papers and magazines	20

Making the whole number now in the Library	30,984

It will be observed that the number of law books has increased about four hundred per cent. This is chiefly attributable to the fact that, by the consent of the Commissioners, an exchange was made with the British Museum, of 411 copies of our surplus Legislative Minutes, Journals and Documents, for 195 volumes of English Law Reports, much needed upon our shelves.

In the Miscellaneous Department, an effort to fill up the broken sets of our standard historical and biographical works has been partially successful, although it is feared that in a few important

instances the loss of several volumes, some years ago, will necessitate the purchase of entirely new editions. There are also many works in this department that require rebinding to preserve them, but as yet the appropriation has been insufficient to cover such an outlay, and they are only protected by tender care.

Speaking of the appropriation suggests the fact that ever since 1883, when \$1,500 were annually appropriated "for the improvement and increase of the State Library," to be expended in the "repair, preservation and purchase of useful books," only about half of the fund has been available for any one fiscal year; as the Library was in debt about \$750 at the time of the appropriation, and has had to anticipate it to about that amount yearly. In other words, the creditors of the Library are annually compelled to await payment until the appropriation for the succeeding year becomes available. If the annual appropriation was increased \$1,000, it is thought it would be ample for the necessities of the Library.

Since the last report the capacity of the Library has been materially increased by the construction, under the authority of the State Treasurer and Comptroller, in the attic of the State House, of a new Document Room, 16 feet by 35 feet in size, with 875 feet of shelving, and the placing of 120 feet of shelving around the Library room, thereby making space for 7,960 books. This has proved of great benefit, as the masses of books, heretofore necessarily piled upon the floor of the old Document Room, have been placed upon shelves in the new room, where they are more readily accessible, while the alcoves of the Library Room have been relieved of 1,000 books of only occasional use, making ample room for the natural increase of the Library for many years.

During the year there were 1,920 enrolled visitors at the Library, exclusive of members of the legal profession, State officials and legislators.

The following Appendix presents an itemized statement of the additions made to the Library.
