Permit Descriptions

CAFRA - A Coastal Area Facility Act permit is required to construct residential, commercial, public, transportation, utility and energy-related facilities in the coastal area as defined by the Act.

Federal Consistency Activity: Certain federal permits, not limited to the U.S. Army Corps of Engineers Dredge and Fill Permits, require certification by the DEP prior to the issuance of the permit by the federal agency.

Freshwater Wetlands: A Permit (Letters of Exemption, Letters of Interpretation, Statewide General Permit, Open Water Fill, Individual, Transition Area Waiver, Water Quality Certificate) is needed prior to engaging in a regulated activity in or around freshwater wetlands and associated transition areas. A Flood Hazard Area Permit, an U.S. Army Corps of Engineers Dredge and Fill Permit, and a Water Quality Certification may also be required.

General Groundwater Petroleum Products Cleanup: This general permit authorizes the surface water discharge of treated groundwater previously contaminated with petroleum products.

NJPDES permits: A permit is required for the discharge of pollutants to surface and groundwater, a discharge from an indirect user or the land application of municipal and/or industrial residuals. (A more comprehensive definition of activities, which require a permit, may be found at N.J.A.C. 7:14A-2.4)

Solid Waste Facility: A permit is required to conduct or operate any solid waste facility as defined under the Solid Waste Management Act, N.J.S.A. 13:1E-1 et seq., and N.J.A.C. 7:26-1 et seq.

Tidal Wetlands: A Coastal Wetlands Permit is needed to excavate, dredge, fill or erect structures on coastal wetlands.

Treatment Works Approval: A TWA permit is required for the construction, modification or operation of a treatment works, including sanitary/industrial sewage pretreatment or treatment systems, sewage conveyance systems, sewer extensions and subsurface sewage disposal systems.

Waterfront Development: A permit is required for any project involving the development of waterfront near or upon any tidal or navigable waterway in the State.

Coastal Wetlands: A permit authorizing disturbances to Mapped Tidal Wetlands under the Wetlands Act of 1970, N.J.S.A. 13:9A”

General Information

The DEP Bulletin is an information service provided by the New Jersey Department of Environmental Protection. In compliance with the Rules and Regulations Governing 90 Day Construction Permits (NJAC 7:1C-1.1 et seq.) this semi-monthly publication contains a list of construction permit applications recently filed or acted upon by the DEP. Using the Application Milestone Codes located on the inside front cover, interested persons can determine the status of Coastal Area Facility Review Act (CAFRA) permits, Federal Consistency Activity permits, Freshwater Wetlands Individual and Statewide General permits, General Groundwater Petroleum Products Cleanup permits, Open Water Fill permits, Solid Waste Facility permits (SWF), Flood Hazard Area (FHA) permits, Tidal Wetlands permits, Waterfront Development permits and Treatment Works Approvals (TWA).

In addition, a calendar of Events of Interest and a Schedule of Public Hearings is provided. The public hearings listed do not, however, constitute an official notice. Environmental Impact Statements acted upon during the period are also shown. Additional information concerning the permit applications can be obtained by calling the project manager at the appropriate office listed on the inside back cover.

Public Hearings are held for the purpose of obtaining input and reaction to a proposed rule, regulation, or new program. Some hearings may be mandated by law. Generally their scope of impact is statewide or of broad general interest and open to the public.

Contested Case Hearings are held between the State and a particular party involving an application, enforcement violation or an appeal. Interest in these hearings is generally limited to those directly involved.

DEP Events of Public Interest include public hearings, council meetings, workshops, public information meetings, and exams.

TAKE NOTICE THAT THE DEPARTMENT OF ENVIRONMENTAL PROTECTION has entered into a Settlement Agreement (the "Agreement") that anticipates issuance of the grant of an exemption under the New Jersey Highlands Water Protection and Planning Act, N.J.S.A. 13:20-1 et seq., for reconstruction of the Darlington Schoolhouse consisting of a proposed addition, expanded parking and access trails (the "Project") located on the entirety of Lots 6, 7, the Unnumbered Lot and the easement on Lot 8 all within Block 19 on the official tax map of Mahwah Township, Bergen County, New Jersey (the "Site"). The Project activities subject to this Agreement are shown correctly on Sheet 2 of 3 of a plan signed and sealed by Tibor Latincsics, P.E., of Conklin Associates, entitled "SITE PLAN DARLINGTON SCHOOLHOUSE LOT 6, 7, 8 – BLOCK 19 DARLINGTON AVE & RAMAPO VALLEY ROAD IN THE TOWNSHIP OF MAHWAH BERGEN COUNTY, NEW JERSEY FOR NY-NJ TRAIL CONFERENCE AND TOWNSHIP OF MAHWAH", dated April 1, 2009 and last revised January 12, 2010. However, that plan's depiction of the "TOTAL PROJECT SITE AREA" is inconsistent with the terms of the Agreement. Despite the plan being cited in the Agreement, the parties entered into the Agreement based importantly on the Project Site as defined in the terms of the Agreement as including all of Lot 6 and not the partial portion of Lot 6 as depicted on the plan. Therefore, the Project Site as defined in the terms of the Agreement shall prevail and be applicable in the anticipated grant of exemption.

The New Jersey Department of Environmental Protection (the Department), Solid and Hazardous Waste Management Program, hereby gives notice that it has tentatively approved a Solid Waste Facility (SWF) Permit renewal with modification application regarding the operation of the existing Mercer County Improvement Authority (MCIA) Solid Waste Transfer Station located 0.6 miles south of North Olden Avenue Extension, opposite Arctic Parkway, on Lots 3, 10, 16, 17 and 37, Block 13 in the Ewing Township, Mercer County, New Jersey.

The application for a Solid Waste Facility Permit renewal with modification was submitted in accordance with the requirements established at N.J.A.C. 7:26-2. The facility is a public facility (subject to tariff), operated by the Waste Management of New Jersey, Inc. except that the scale house activities are operated by MCIA (the applicant). The facility is currently permitted to accept approved solid waste materials (Municipal Waste Type 10) within the facility building for processing and transfer with an approved capacity of 1000 tons per day.

This facility is also a designated in-district weighing facility, authorized to perform weighing of collection vehicles transporting solid waste types 10 (Municipal waste), 13 (Bulky waste), 13C (Construction and demolition waste), 23 (Vegetative waste), 25 (Animal and food processing wastes), 27 (Dry industrial waste), 27A (Asbestos or Asbestos containing waste) and vehicles carrying source separated recyclable materials. All solid waste generated within Mercer County is directed to this facility as MCIA Transfer Station facility is a designated in-district weighing facility.

Under the SWF permit renewal with modification application, currently permitted facility operations (specifically, days of operation, acceptance and processing hours of operations and waste types accepted at the facility) will remain the same.

Proposed modification of the SWF Permit includes increase in daily capacity from 1000 tons to 1500 tons of approved solid waste materials (Municipal Waste Type 10) but not to exceed a weekly maximum of 6000 tons over a six day operating period (Monday to Saturday). It also includes installation of the new air pollution control devices (air curtains) in all truck bay openings to maintaining constant negative pressure in the facility building. Once these air curtains are installed and are certified to be fully operational, the facility will be allowed to

increase its daily maximum capacity (waste accepted within the facility building) to 1500 tons of on any operating day with a weekly maximum as noted above.
