SUBCHAPTER 1. GENERAL PROVISIONS

13:8-1.1 Definitions

The definitions set forth in N.J.S.A. 10:5-1 shall obtain to this Chapter.

13:8-1.2 Display of employment poster

All labor organizations, employment agencies and employers of employees covered by the Law Against Discrimination (N.J.S.A. 10:5-1, et seq.) shall display the official employment poster of the Division in places easily visible to all employees and applicants for employment.

13:8-1.3 Display of housing poster

(a) All real estate brokers and all persons who engage in the business of selling or renting their own real property shall display the official housing poster of the Division in places easily visible to all prospective tenants and purchasers.

(b) For the purpose of this Section, a person is not engaged in the business of selling real property solely because he sells or attempts to negotiate the sale of his own residence.

13:8-1.4 Display of public accommodation poster

All places of public accommodation shall display the official public accommodation poster of the Division in places easily visible to all persons seeking or using the accommodations.

13:8-1.5 Violation

Failure to comply with this Chapter shall constitute a violation of N.J.S.A. 10:5-12(j).

"All persons shall have the opportunity to obtain employment without discrimination because of race, creed, color, national origin, ancestry or age, subject only to the conditions and limitations applicable alike to all persons."

THIS OPPORTUNITY IS RECOGNIZED AND DECLARED TO BE A CIVIL RIGHT

N.J.S.A. 10:5-1 et seq. and 10:2-1 et seq.

- **A QUALIFIED PERSON** can **not** be denied employment because of race, color, religion, place of birth, age, ancestry, or liability for military service.
- T] • **EMPLOYERS** can **not** discriminate in employment interviews, hiring, upgrading, setting working conditions or discharging.
- **LABOR ORGANIZATIONS** can **not** deny membership to qualified persons or discriminate in apprentice training programs.
- **EMPLOYMENT AGENCIES** can **not** discriminate in job referrals, ask pre-employment questions or circulate information which limits employment because of race, color, religion, ancestry, place of birth, age or liability for military service.
- **NEWSPAPERS** can **not** publish discriminatory employment advertisements.

If you have experienced discrimination report it immediately to one of the offices listed below.

Reprisals can not be taken against you for making a complaint. Continued willful violation of the law may result in a fine, imprisonment, or both.

Rules on back of poster

The official public accommodation poster of the Division on Civil Rights is to be posted in such a manner as to be easily visible to all patrons of your establishment. The placement of the poster, as described above, is required under the "Rules and Regulations Governing the Display of Official Posters of the Division on Civil Rights," promulgated by Attorney General Arthur J. Sills and filed with the New Jersey Secretary of State, January 17, 1967. Sections 5 and 6 of said rules state:

"5. All places of public accommodation shall display the official public accommodation poster of the Division; a copy of which is attached, in places easily visible to all persons seeking or using the accommodation.

"6. Failure to comply with these rules and regulations shall constitute a violation of N.J.S.A. 10:5-12j." (formerly Section 18:25-12j—renumbered in 1968.)
