ELLIS COOK, Samuel Randolph, Charles Beardfley, John Lambert, John Condit, Samuel Ogden, John Mayhew, and Elisha Lawrence, Esquires, severally produced Certificates of their being duly elected Members of this Houle, which were read, and approved; and they thereupon took and subscribed the Oaths required by Law, before the Honorable James Kinsey, Esquire, one of the Members returned for this House, and took their Seats in Council.

James Kinfey, and Joseph Ellis, Elquires, feverally produced Certificates of their being duly elected Members of this House, which were read and approved, (and they being of the People called Quakers) took and subscribed the Affirmations required by Law, before the Honorable Elista Lawrence, Esquire, and took their Seats in Council.

The Honorable *Elisha Lawrence*, Esquire, was elected Vice-President of the Council, pursuant to the Constitution; whereupon, he took the Oath of Office, and was seated in the Chair.

Bowes Reed was unanimoufly elected Clerk of the Council, and took the Oath of Office accordingly.

John West was appointed Doorkeeper.

Ordered, That Mr. Condit do wait on the Houle of Affembly, and acquaint them, that a fufficient Number of Members of this Houle have this Day met, elected the Honorable *Elisha Lawrence*, Esquire, Vice-President, and proceeded to Business.

The House adjourned until Ten o'Clock, To-Morrow Morning.

### Wednesday, October 26, 1791.

#### The Houle met. --- Present as before.
