INELIGIBLE IN-HOUSE COUNSEL;
AND INELIGIBLE PRO HAC VICE ATTORNEYS**

Foreign legal consultants, in-house counsel, and pro hac vice attorneys are subject to the same requirements as licensed members of the New Jersey Bar under a number of Court Rules. Among these are the requirements to pay the annual assessment. The Supreme Court has entered an Order declaring ineligible in New Jersey those foreign legal consultants, in-house counsel, and pro hac vice attorneys not in compliance with the 2006 annual assessment. Those Orders and the associated Ineligible Lists follow. The last known contact address is given in each list; please contact the Fund if you have knowledge of a more current mailing address.

Foreign legal consultants, in-house counsel, and pro hac vice attorneys will be removed from the 2006 Ineligible Lists without further order of the Court upon filing with the Fund the annual registration statement for 2006 together with payment of ALL of the following: the 2006 annual payment of \$182, the \$40 late fee, any arrears due from prior years, and a reinstatement fee of \$50 if being removed from one calendar year's Ineligible List or \$100 if being removed from two or more calendar years' Lists.

SUPREME COURT OF NEW JERSEY

Foreign Legal Consultant Ineligibility Order Pursuant to *Rule 1:28-2*

Pursuant to *Rule 1:28-2*, the Trustees of the New Jersey Lawyers' Fund for Client Protection have reported to the Supreme Court the names of those foreign legal consultants who have failed to make full payment to the Fund, the Disciplinary Oversight Committee, and the Lawyers Assistance Program for the calendar year 2006;

And the Court having had the Trustees send notice to each such foreign legal consultant that unless all reporting and financial obligations were fully satisfied on or before August 25, 2006, his or her name would be published in the *New Jersey Law Journal* and the *New Jersey Lawyer* together with an Order of the Court declaring him or her ineligible to render legal services pursuant to *Rule 1:21-9*;

And notwithstanding the fact that every reasonable effort has been made by the Trustees to notify all foreign legal consultants of their obligations to file an annual registration statement and make payment to the Fund, the foreign legal consultants whose names appear on the attached Ineligible List have, as of the date of this Order, failed to make full payment;

IT IS ORDERED that pursuant to *Rule 1:28-2*, each foreign legal consultant whose name appears on the attached Ineligible List shall be ineligible to render legal services in New Jersey, effective December 18, 2006; and it is further

ORDERED that each foreign legal consultant whose name is included on the attached Ineligible List shall remain ineligible to render legal services in New Jersey until the annual registration statement for the current year is filed together with payment of **ALL** of the following: this year's annual assessment, the late fee, any arrears due from prior years, and a reinstatement fee of \$50 if being removed from one calendar year's Ineligible List or \$100 if being removed from two or more calendar years' Lists; and it is further

ORDERED that this Order and the attached list of foreign legal consultants are to be posted on the Judiciary's website and published in the *New Jersey Law Journal* and the *New Jersey Lawyer* on December 18, 2006, and that a copy of this Order be mailed to each foreign legal consultant whose name appears on the attached list at the address shown thereon; and it is further

ORDERED that any amendments or corrections to this Order shall be posted and published as soon as may be practicable.

In-House Counsel Ineligibility Order Pursuant to *Rule 1:28-2*

Pursuant to *Rule 1:28-2*, the Trustees of the New Jersey Lawyers' Fund for Client Protection have reported to the Supreme Court the names of those in-house counsel who have neither made full payment to the Fund, the Disciplinary Oversight Committee, and the Lawyers Assistance Program for the calendar year 2006, nor demonstrated to the Fund that no payment is due;

And the Court having had the Trustees send notice to each such counsel that failure to pay on or before the November 17, 2006 deadline would result in ineligibility and assessment of additional fees;

And notwithstanding the fact that every reasonable effort has been made by the Trustees to notify all counsel of their obligations to file an annual registration statement and make payment to the Fund, the counsel whose names appear on the attached Ineligible List have, as of the date of this Order, failed either to make full payment or to demonstrate why no payment is due;

IT IS ORDERED that pursuant to *Rule 1:28-2*, each counsel whose name appears on the attached Ineligible List shall be ineligible to act as in-house counsel in New Jersey, effective December 18, 2006; and it is further

ORDERED that each counsel whose name is included on the attached Ineligible List shall remain ineligible to act in-house counsel in New Jersey until all fees due have been paid in full or until it has been demonstrated to the Trustees that no fee is due; and it is further

ORDERED that this Order and the attached list of counsel are to be posted on the Judiciary's website and published in the *New Jersey Law Journal* and the *New Jersey Lawyer* no later than December 18, 2006, and that a copy of this Order be mailed to each counsel whose name appears on the list at the address shown thereon and to the employer of each counsel whose name appears on the list; and it is further

ORDERED that any amendments or corrections to this Order shall be posted and published as soon as may be practicable.

Pursuant to *Rule 1:28-2*, the Trustees of the New Jersey Lawyers' Fund for Client Protection have reported to the Supreme Court the names of those pro hac vice attorneys who have neither made full payment to the Fund, the Disciplinary Oversight Committee, and the Lawyers Assistance Program for the calendar year 2006, nor demonstrated that they are not obligated to make such payment;

And the Court having had the Trustees send notice to each such pro hac vice attorney that unless all reporting and financial obligations were fully satisfied on or before October 20, 2006, those who failed to pay or certify that payment was not required would be declared ineligible for admission or continued appearance pro hac vice by Order of the Court;

And notwithstanding the fact that every reasonable effort has been made by the Trustees to notify all pro hac vice attorneys of their obligations to file an annual registration statement and make payment to the Fund, unless not obligated to do so, the pro hac vice attorneys whose names appear on the attached Ineligible List have, as of the date of this Order, failed either to make full payment or to demonstrate that they are not obligated to make such payment;

IT IS ORDERED that pursuant to *Rule 1:28-2*, each pro hac vice attorney whose name appears on the attached Ineligible List shall be ineligible to appear pro hac vice in New Jersey, effective December 18, 2006; and it is further

ORDERED that each pro hac vice attorney whose name is included on the attached Ineligible List shall remain ineligible to appear pro hac vice in New Jersey until such attorney files the annual registration statement for the current year AND either demonstrates no obligation to pay or pays ALL of the following: this year's annual assessment, the late fee, any arrears due from prior years, and a reinstatement fee of \$50 if being removed from one calendar year's Ineligible List or \$100 if being removed from two or more calendar years' Lists; and it is further

ORDERED that this Order and the attached list of pro hac vice attorneys are to be posted on the Judiciary's website and published in the *New Jersey Law Journal* and the *New Jersey Lawyer* on December 18, 2006, and that a copy of this Order be mailed to each pro hac vice attorney whose name appears on the attached list at the address shown thereon; and it is further

ORDERED that any amendments or corrections to this Order shall be posted and published as soon as may be practicable.
