Mr. Janick was Chairman of the Governor's Task Force on Services for Disabled Persons and a member of the New Jersey Job Training Coordinating Council. He has long been dedicated and committed to and an ardent spokesman for causes that are beneficial to disabled citizens. Through his many activities he brings to the DVRS a great deal of expertise and experi-His tireless efforts and deep commitment to disabled citizens make him perfectly suited to lead the Department of Labor's efforts on behalf of the disabled.

As a Sloan fellow at Massachusetts Institute of Technology, Cambridge, Massachusetts, Mr. Janick received a Master of Science degree in management in 1968.

His activities on behalf of the disabled community include membership on many boards including Spectrum for Living, where he served as a member of the advisory committee and chairman of the building committee for a new 48-bed independent living center for multiply handicapped children in Bergen County, and the Easter Seal Society of New Jersey where he served as Director from 1983 to 1988.

Mr. Janick replaces Mr. George R. Chizmadia who has recently become an Assistant to the Commissioner and will act as his advisor on DVRS matters.

In addition to Mr. Janick, Mr. Alexander Kirk and Ms. Sharon Caldwell, long-time employees of the Department have been promoted to Assistant Directors.

Rehabilitation is now in a of progressive change. While this change has produced increased expectations for rehabilitation services and competitive employment opportunities, and decreased satisfaction with traditional roles and service programs of facilities, is there a departure from old values centering around work and meeting the true needs of others who are less fortunate than ourselves? The current trend does focus on new directions for services including a concentration on supportive participation, building on capabilities, adapting environments to individual needs, increasing employment options, and empowering consumers in their decision-Since 1919, these "trends" making! have been the core elements of Vocational Rehabilitation!

Although we have been moving toward serving persons with more severe disabilities and providing services within less restrictive

environments, we have only begun. In 1986, Harris and Associates indicated that two-thirds of Americans with disabilities, tween the ages of 16 and 64, were not working but wanted to have a job! # What Kind of Work Can a Blind Person Do?

The above question is often asked by employers who are unaware of the employment possibilities that now exist because of technological advancements.

Today, equipment is available that allows visually impaired people to write messages in Braille and print simultaneously. The employer then has a print copy while the visually impaired employee has a Braille copy. In most instances, New Jersey's Commission for Blind & Visually Impaired (CB&VI) can provide the required adaptive equipment for its clients. For the employer, this means that the cost of hiring a blind or visually impaired person is the same as hiring a person without a visual impairment.

Personal Computers can now be utilized by visually impaired persons by either large print adaption or through voice synthesizers which enable the user to hear everything that appears on the CRT screen.

A device called a VersaBrailler permits a visually impaired employee to do word processing by using a Braille keyboard to imput into an IBM computer.

Using a device called a Closed Circuit TV (CCTV), a person with limited vision is able to read printed materials. The CCTV magnifies the standard print on the TV monitor. The employee can complete forms, work with charts, etc., as if there was no visual problem.

These are just a few examples of the possibilities which now exist for blind and visually impaired persons. The CB&VI is the place to contact for more information about these and other types of adaptive equipment. The Commission has consultants available who can evaluate jobs and recommend appropriate job accommodations.

In addition to linking employers with qualified job applicants who are blind or visually impaired and providing the technical expertise to enable these employees to perform their jobs effectively, the CB&VI can help prevent an employer from losing a valuable, trained employee who has recently experienced a loss of vision due to an accident or disease. The CB&VI can intervene and in many cases provide services which make it possible for the employee to continue in his or her job.
