After Nearly Two Years Of Delay And Inaction, It Is Time For The Legislature To Move Forward On Governor Christie's Common-Sense Reforms To Improve The Lives Of Middle-Class New Jerseyans

TAX RELIEF FOR NEW JERSEY FAMILIES

Last year, Governor Christie proposed an income tax cut of 10 percent across the board. Following negotiations with the legislature, the Governor agreed to a compromise plan to offer New Jersey families direct property tax relief through an income tax credit.

Under Governor Christie's compromise plan, New Jersey taxpayers will be able to claim an income tax credit of up to 10 percent of their property tax bill.

This plan will provide a savings of \$775 for the average family.

The 10 percent credit is capped at \$10,000 of property taxes paid and all New Jersey homeowners with up to \$400,000 in income will be eligible for relief.

Renters will receive a \$200 year in property tax deduction, up from \$50 under current law.

Governor Christie's bipartisan tax relief also increases the Earned Income Tax Credit to 25 percent of the federal tax credit:

This increase will make New Jersey one of the most generous programs in the country, with an average eligible family will receive a \$550 annual benefit.

Despite Governor Christie's willingness to compromise, and in a fit of political partisanship, the legislature decided to deny New Jerseyans the tax cut they so desperately need and deserve. Governor Christie remains committed to delivering tax relief and will fund tax relief if the Legislature reverses its partisan course to make good on its promise to New Jerseyans.

THE PROPERTY TAX REFORM TOOL KIT

In May 2010, Governor Christie laid out a series of common-sense reform proposals to rein in the high cost of property taxes in New Jersey. Since then, the Legislature has allowed only six of bills to become law:

A-1646/S-1781: Directs that one sample ballot shall be delivered to each residence address where at least one resident thereof is registered to vote.

A-2951/S-2174: Eliminate eligibility for State retirement systems for non- government groups and associations.

A-2958/S-2012: Allows gross income tax refunds to be credited against a taxpayer's delinquent local property taxes.

A-2953/S-2024: Permits layoff plans as substitute for employment reconciliation plans for joint meetings or shared service agreements under certain circumstances.

A-2955/S-2135: Employee Discipline Reform. Limits right of appeal of disciplinary action taken by employer against certain public employees.

The Local Unit Alignment, Reorganization and Consolidation Commission determined that civil service seniorityprotection rules are among the most significant barriers to shared services between municipalities.
