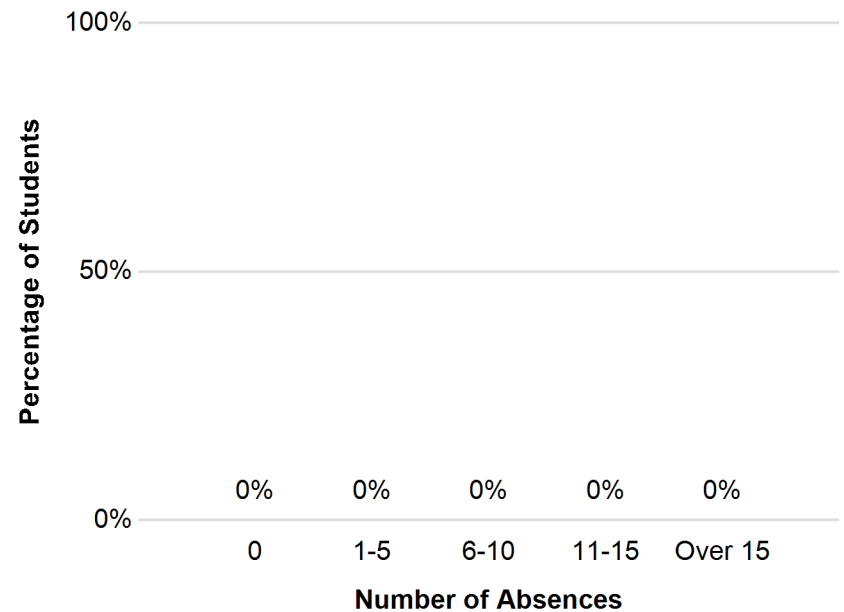

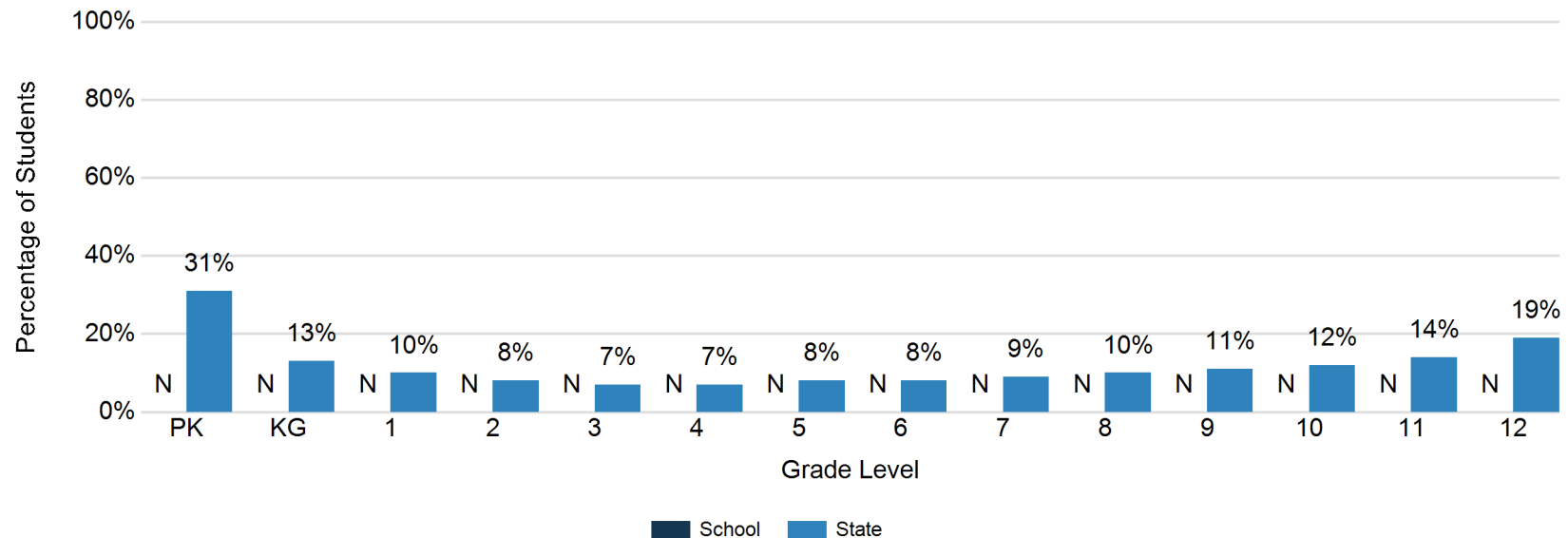

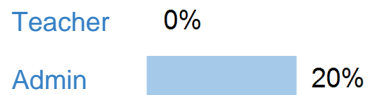
Bachelor's Degree

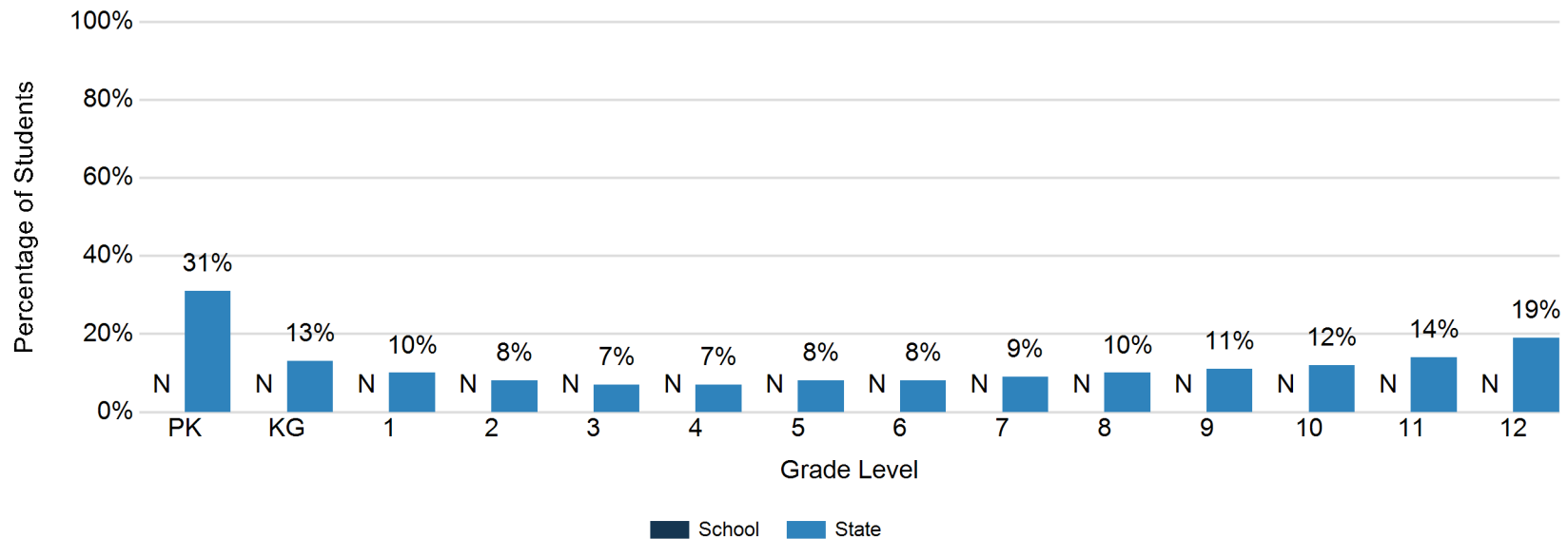

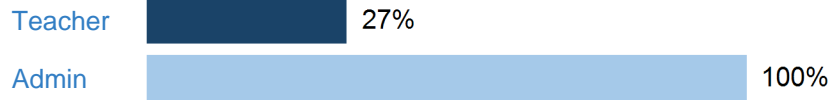

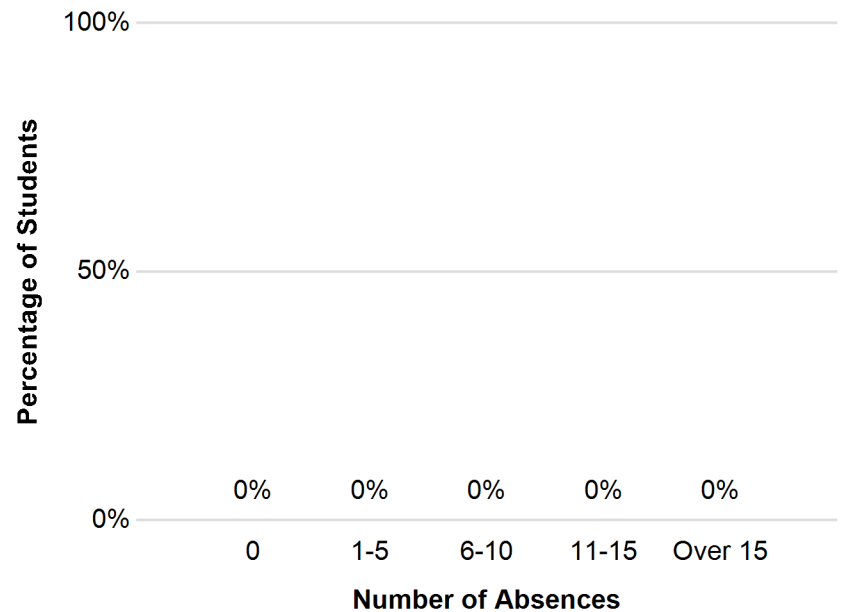

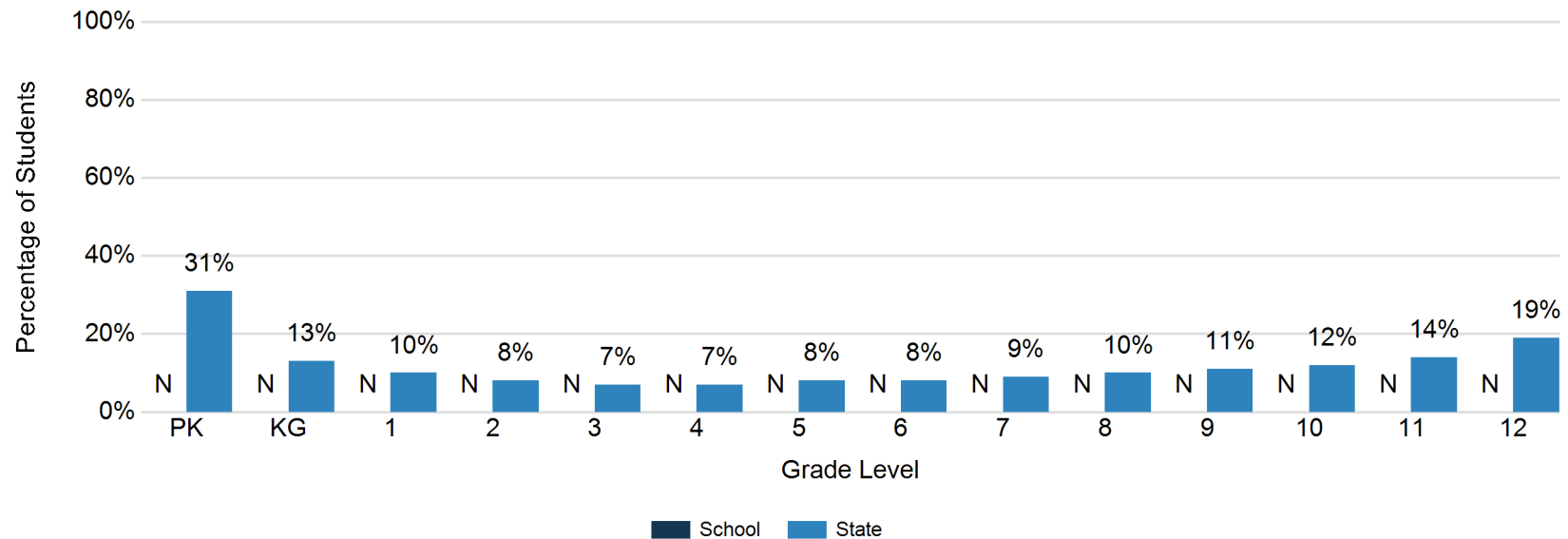

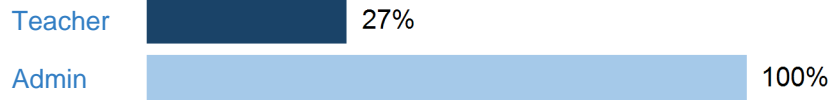

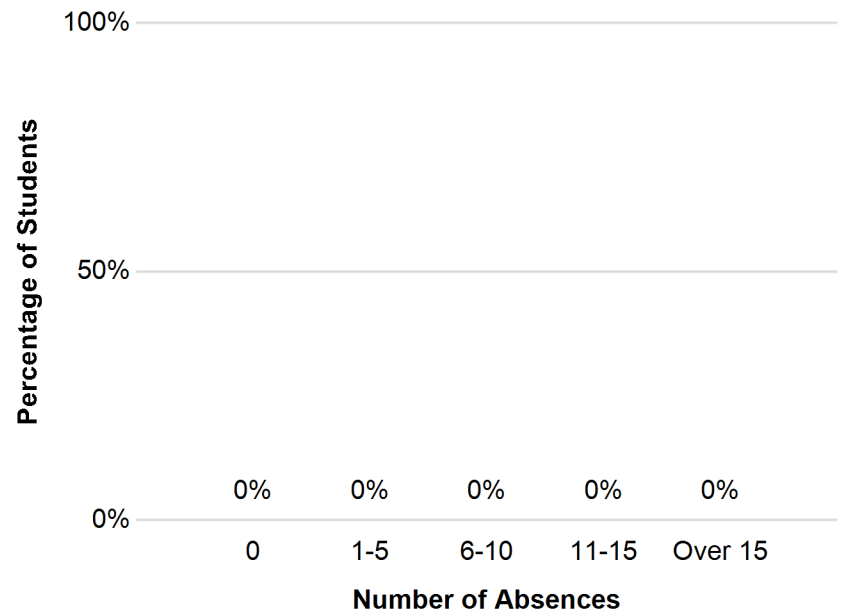

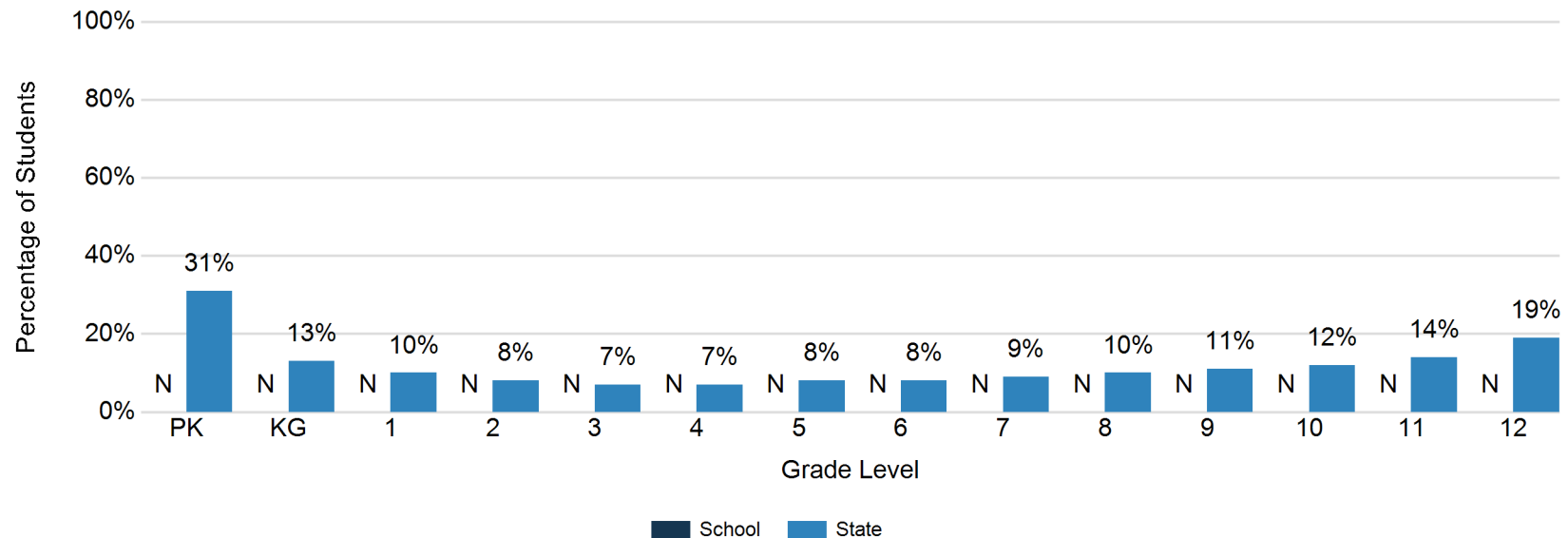

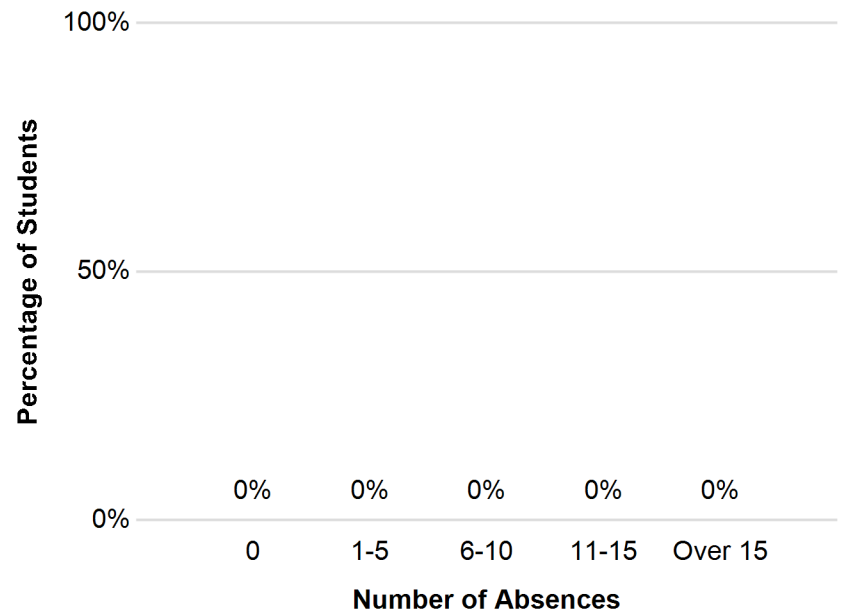

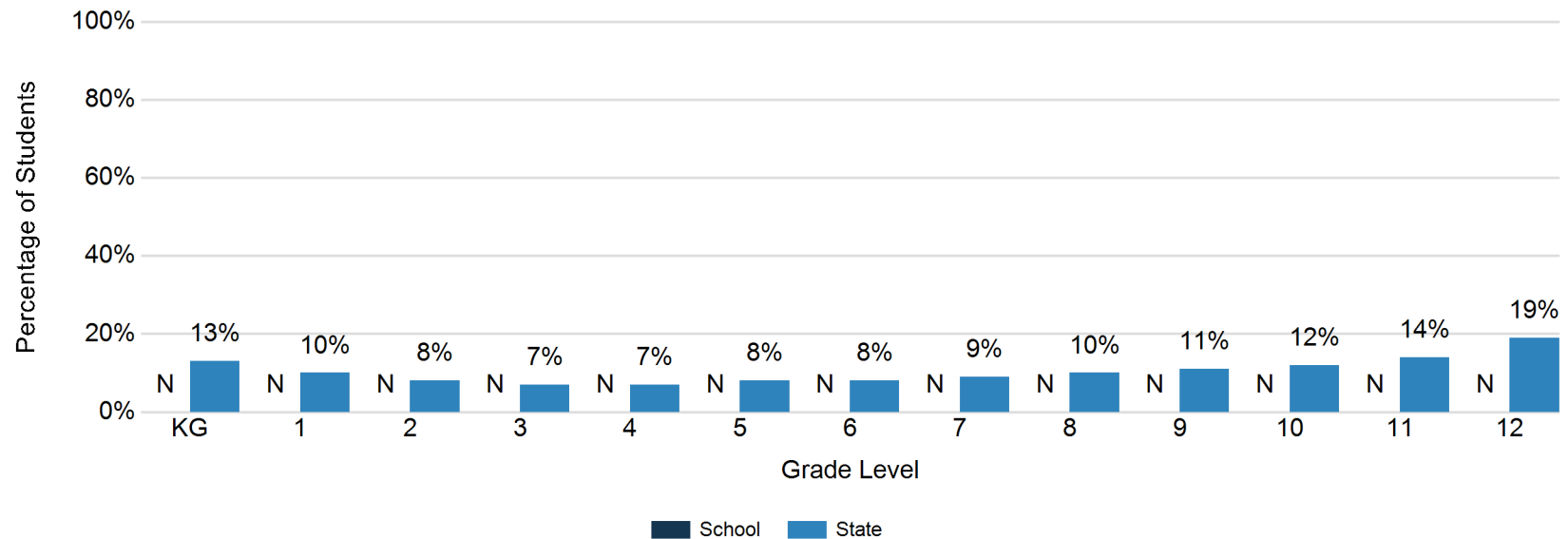

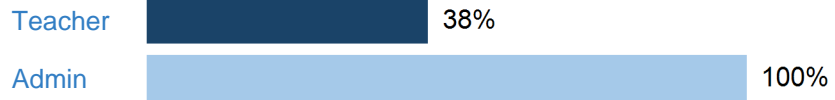

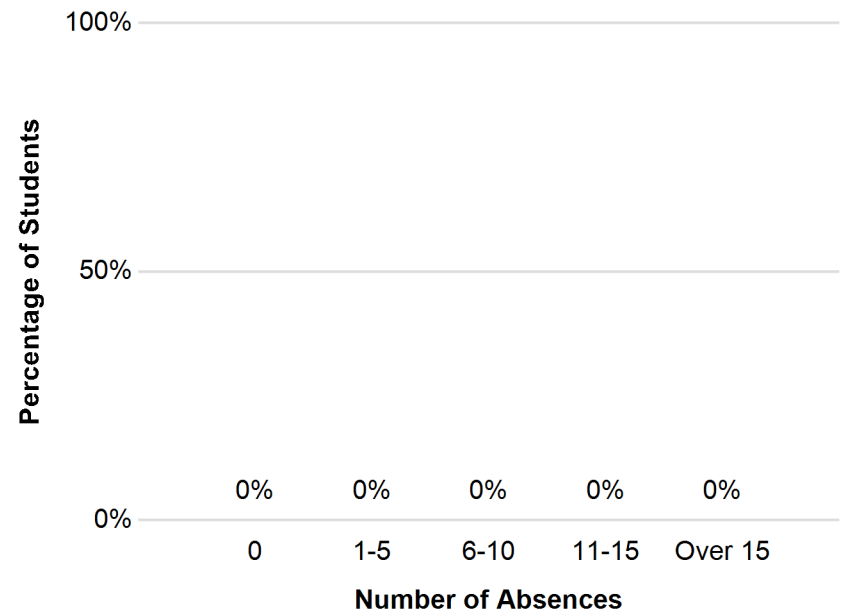

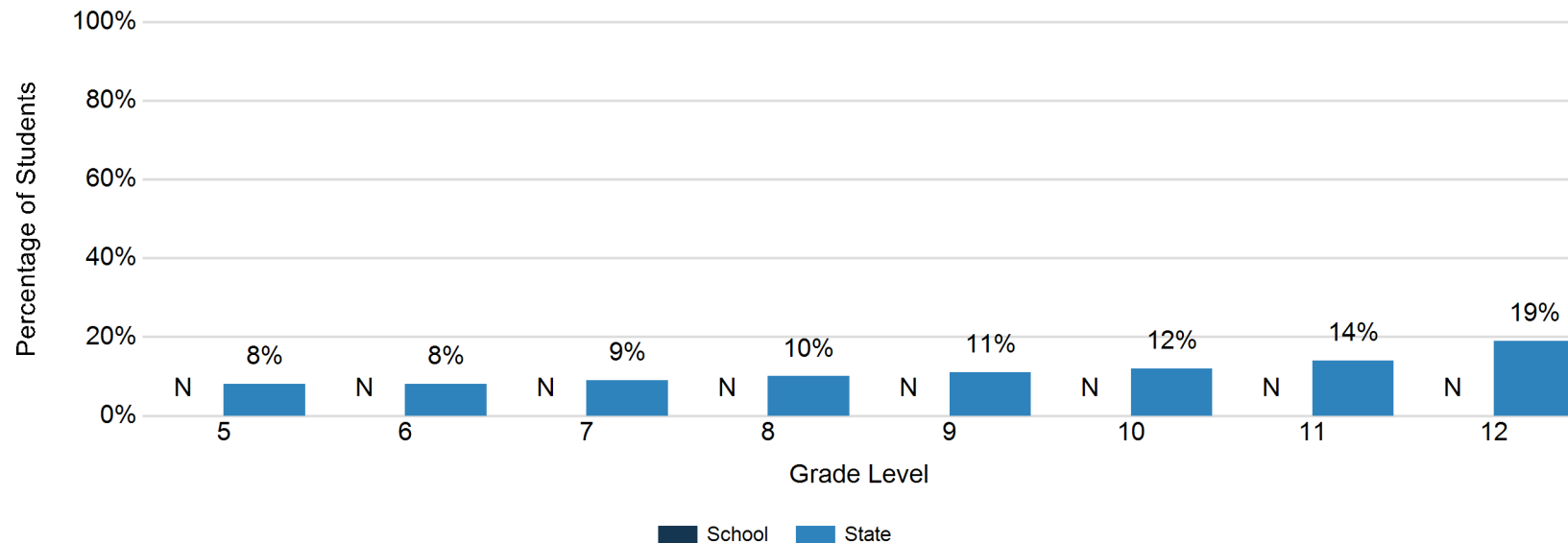

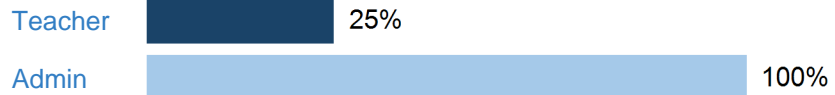

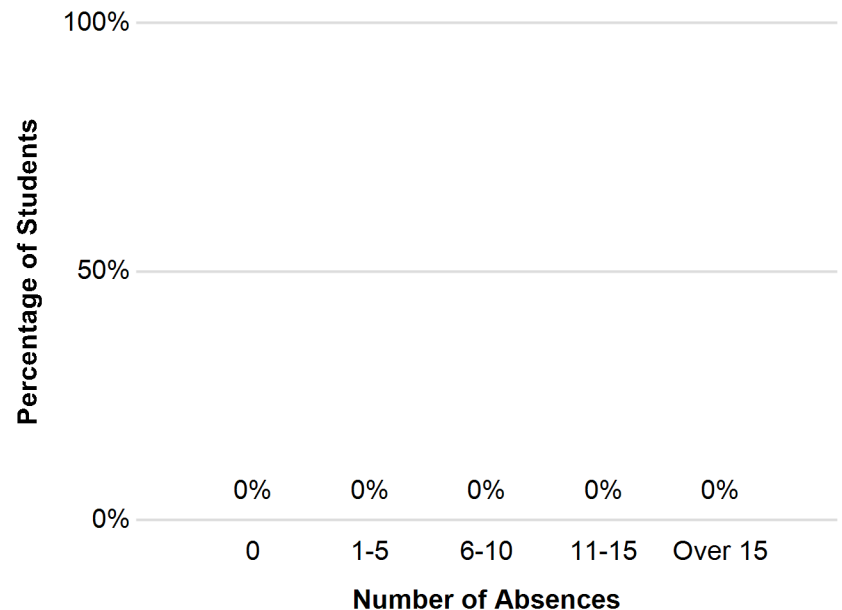

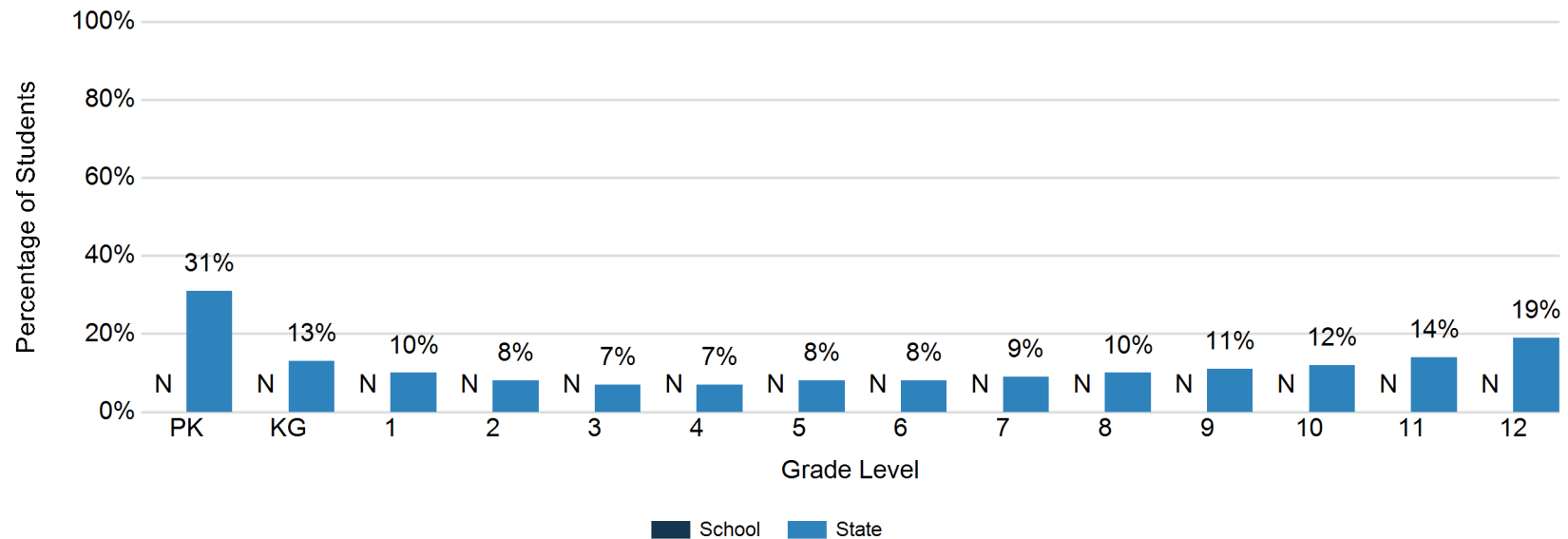
