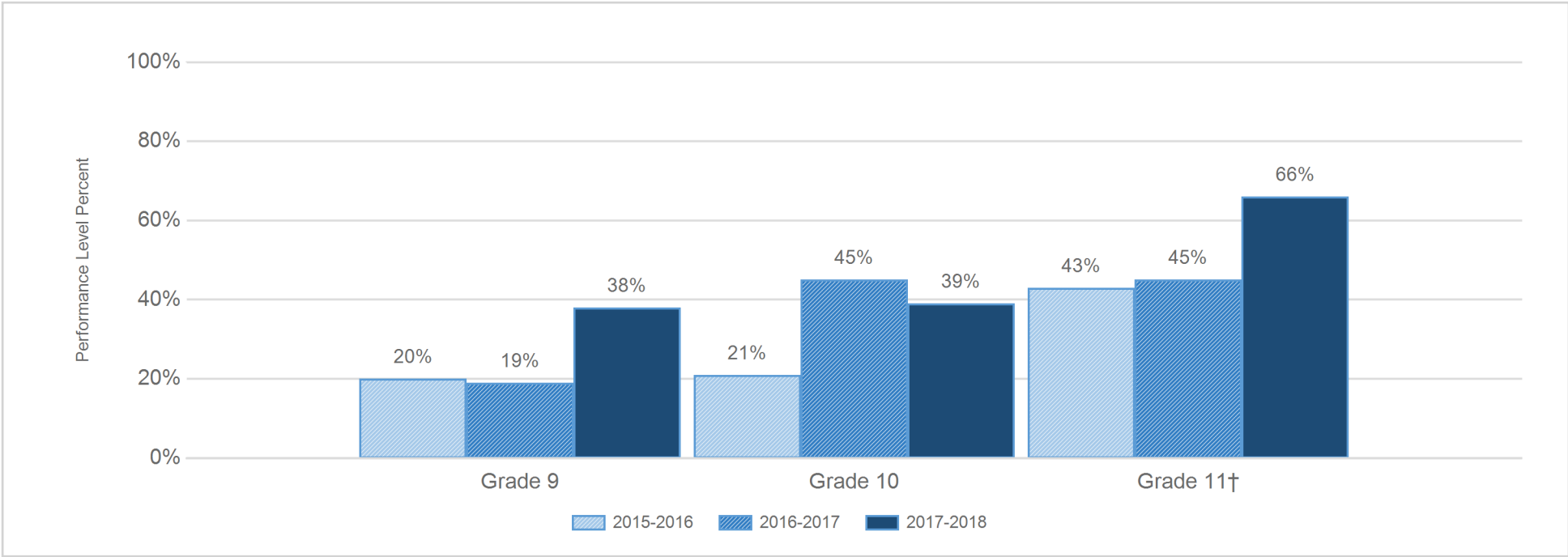

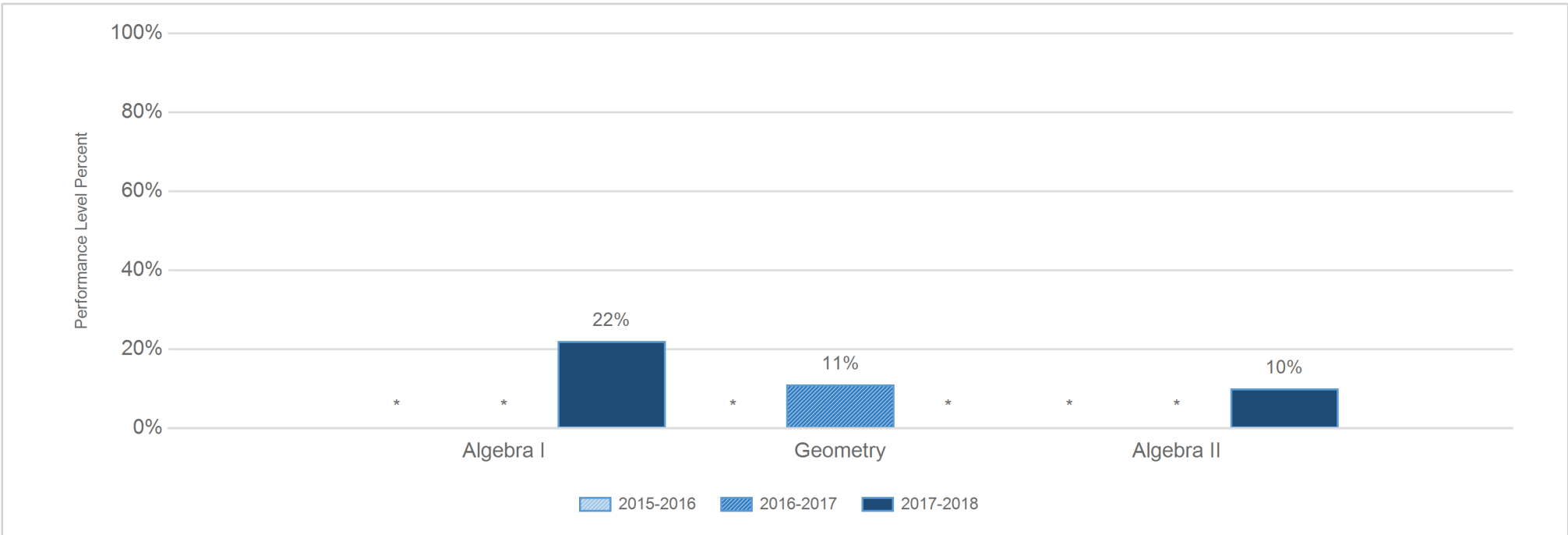

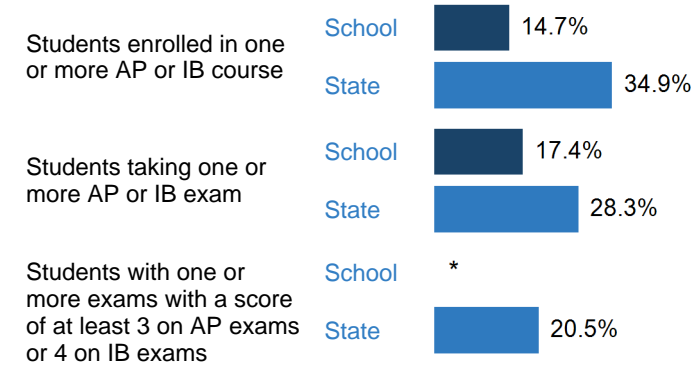

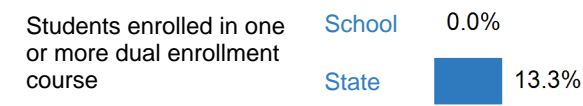

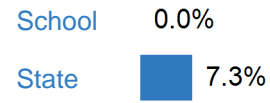

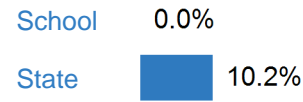

(completed only one course in an approved CTE program)



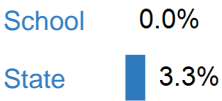

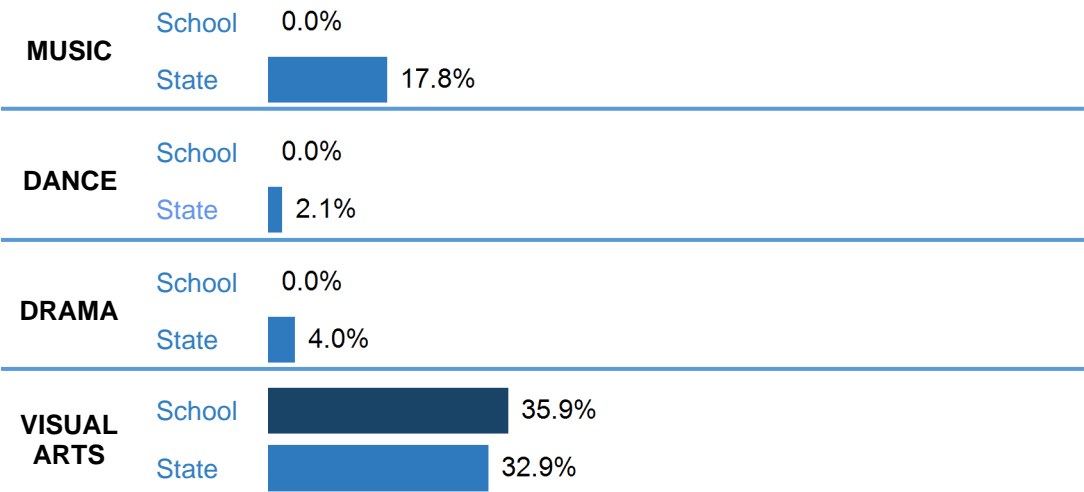

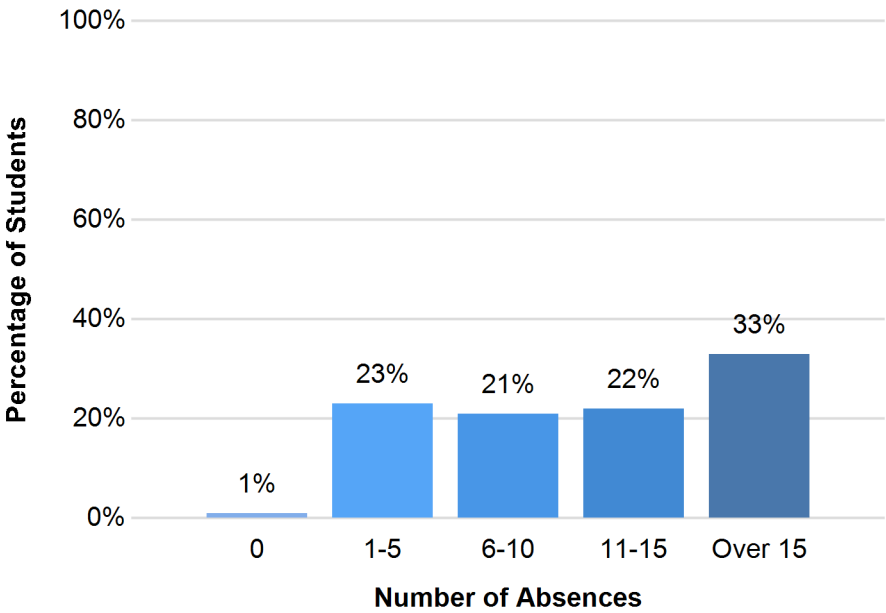

This graph shows the percentage of K-12 students by the number of days they were absent during the school year.





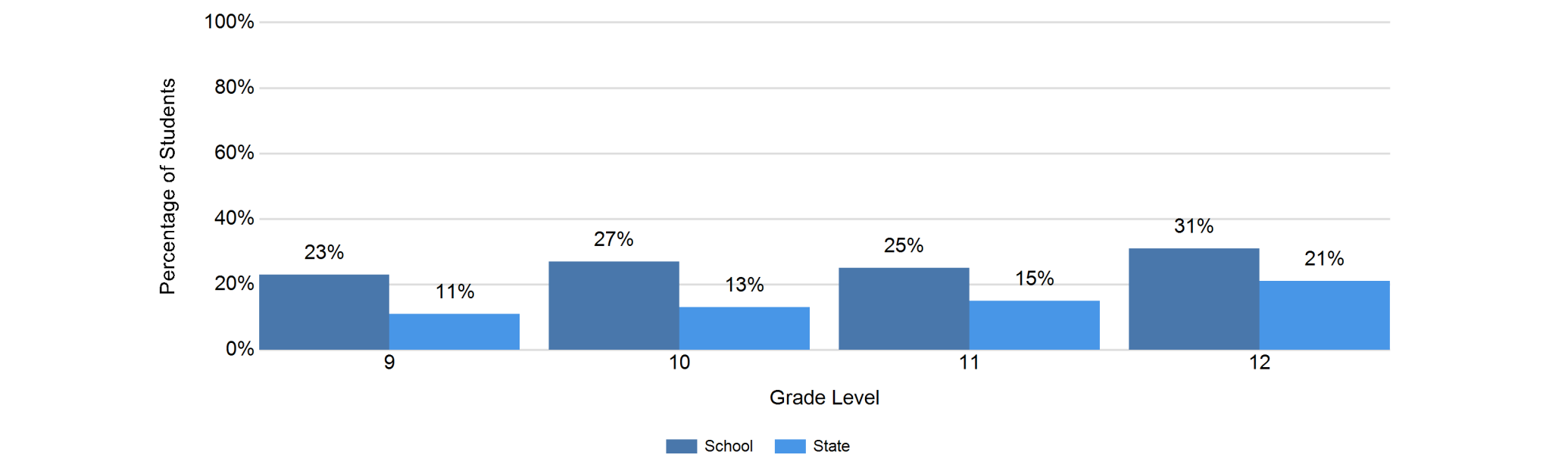

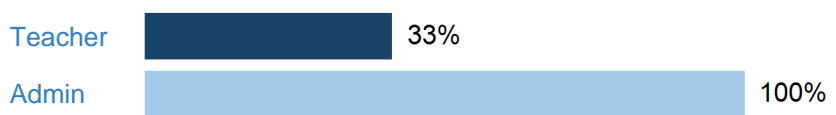
