Governor Chris Christie Takes Action on Pending Legislation

Trenton, NJ – Today, Governor Chris Christie took action on the following legislation:

BILLS SIGNED:

A-2131/S-1946 (Burzichelli, Fuentes, Benson, Lampitt, Quijano/Greenstein, Holzapfel, Madden) - Authorizes release of sex offender registration information to DHS and county welfare agencies

A-2142/S-1172 (Caputo, Johnson, Greenwald, Conaway, Lampitt/Weinberg, Singer) – w/STATEMENT UPON SIGNING - Prohibits minors under 14 years of age from using spray tanning in tanning facilities and prohibits minors under 17 years of age from using tanning beds

A-3049/S-2328 (Diegnan, Burzichelli/Gill) – Allows certain business combinations between resident domestic corporations and interested stockholders

A-3050/S-2327 (Diegnan, Burzichelli/Gill) - Allows corporate shareholder meeting participation by remote communication and clarifies remedies for dissenting shareholders

A-3123/S-2326 (Diegnan/Gill) – Revises law concerning derivative proceedings and shareholder class actions

BILLS VETOED:

A-1271/S-1263 (Coughlin, Lampitt, Tucker, Benson/Vitale, Whelan) - CONDITIONAL - Allows corporation business tax credit and gross income tax credit for certain wages paid to qualified interns in tax years 2013 and 2014

A-2593/S-1397 (Wisniewski, Prieto, Giblin, Russo/Bucco, Oroho) – CONDITIONAL - Requires designated fire command structure in municipal emergency operations plans involving mutual aid responses to fires
