SUBJECT: TEMPORARY UNEMPLOYMENT COMPENSATION (TUC)

In June 1958 Governor Meyner signed into law provision for a Temporary Unemployment Compensation program (TUC). This program provides for extension of payments to claimants who, since October 1, 1957, have exhausted their unemployment benefits. This is a temporary program which terminates April 1, 1959.

During the months of the TUC program all directors of welfare will need to be alert to the possible eligibility of applicants for and recipients of assistance for these extended unemployment benefits.

The following information should be used as a guide in discussing their possible eligibility with unemployed persons:

Qualifications for TUC

A person may be eligible for TUC if he meets the following conditions:

- 1. He is unemployed.
- 2. He complies with the requirements of the Employment Service office for registration and reporting.
- 3. He is able and available for work.
- 4. He makes an active search for work.
- 5. He is not disqualified from receiving benefits for any reason.
- 6. He had established eligibility for unemployment compensation and, after October, 1957, he exhausted these benefits.
- 7. He does not have available benefit rights under any state or any other federal unemployment compensation law.

Exhaustion of Benefits

Generally, an individual has exhausted his unemployment insurance benefits when he has received the maximum amount of benefits allowable to him in his benefit year, or when his benefit year expires before he has drawn all his benefits.

TUC will pay extended benefits not only to claimants who exhausted their benefits between October 1, 1957 and June 29, 1958, but those whose benefits become exhausted prior to April 1, 1959.

When TUC Starts

Payments on claims will be made for weeks of partial or total unemployment beginning on or after June 29, 1958. No payments will be made automatically, but a specific application for TUC must be made. No payments will be made for any week of unemployment which began before June 29, 1958 even though the individual had exhausted his benefits before that date.

If eligibility for TUC is established, the claimant may receive 50 percent of the total benefits to which he was entitled on the last claim he exhausted before he filed his first claim for TUC.

On TUC claims, the serving of a waiting week is NOT required.

Filing of Claim for TUC

Generally, TUC claims are filed in the same manner and in the same local office as are regular unemployment compensation claims. The claimant reports to the appropriate local office each week on the day and at the time assigned to him and completes the required forms.

If the individual last exhausted his benefits in some other state and that state has a TUC program, he may file interstate claims for additional benefits at the local employment service office nearest his residence.

Appeal Rights

Under the TUC program, the individual has the same rights of appeal as under the State unemployment compensation law. Appeals are made through the local Employment Service office or directly to the Arribunal, Board of Review, Division of Employment Security, Trenton 25. New Jersey.
