Attached please find CURRENT PROGRAM STATISTICS for February 2000. Included are TANF-oriented data, and the WFNJ Statistical Summary. Some items of interest include:

- The TANF caseload continues to decline. Since February of 1999 there has been a decrease of 17.9%.
- Food Stamp households decreased by over 15,500 since February 1999.
- For GA, recipient figures reported are for December 1999, which are 6.4% below December 1998.



## Highlights of **CURRENT PROGRAM STATISTICS**

## TANF

(Tables 1 and 5, Graphs 1 and 4)

[The number of single parent families is reduced by the number of companion cases listed for payment on the source table FF-012, to avoid double counting.]

As of the end of February 2000, 51,478 eligible families in New Jersey were receiving TANF cash assistance:

- 50,351 single head of household families
- 1,127 two-parent families.

The largest number of TANF families receiving cash assistance, by county: Essex — 17,677, Hudson — 8,444, Camden — 5,203, Passaic — 3,867 Union — 3,078

The number of TANF cash assistance families in the other 16 counties ranged from:

48 families in Hunterdon County to 2,133 in Mercer County, with ten counties below 1000 families

There were over 28,121 fewer eligible TANF families receiving cash assistance in February 2000 than in February 1998, a decline 35.3 percent.

- Single head families: 25,944 below two years ago in February 1998, a drop of 34.0%.
- Two parent families: declined by 2,177 or 65.9 percent from February 1998.

## FOOD STAMP PROGRAM

(Tables 2 and 6, Graphs 2, 5, and 6)

At the end of February 2000, 140,506 households participated in the Food Stamp Program.

- TANF: 40,071 households with 129,699 persons.
- Other low income: 100,435 households with 184,501 persons.
- Total persons: 314,200, including 151,301 adults and 162,899 children
- By County: 57.6 percent of the households were in: Essex 33,839

Two years ago in February 1998, 177,634 households participated in Food Stamps in New Jersey. Over the next two years the number declined by 37,128, or 20.9 percent, to 140,506 by February 2000.

- TANF(FS) households steadily declined by 39,775 from 79,846 in February 1998 to 40,071 two years later. There were 97,788 Other Low Income households in February 1998 and 2,647 more two years later.
- Total FS Recipients: were 402,068 in February 1998, and declined to 314,200 by February 2000, a drop of 87,868, or 21.9 percent.
- Adult FS Recipients: declined from 190,032 in February 1998 to 151,301 in February 2000, a drop of 38,731 (20.4 percent).
- Recipient FS Children: declined by 49,137 (23.2 percent), from 212,036 in February 1998 to 162,899 in February 2000.

## EMERGENCY ASSISTANCE

(Tables 3, 7 and 9, Graphs 3, 7 and 9)

In February 2000 Emergency Assistance (EA) payments were made for 1,753 eligible TANF families and 307 SSI recipients in New Jersey. For TANF families this included payments for:

- Temporary Rental Assistance (TRA) for 261 families
- Motel placements for 185 families and emergency shelter placements for 370 families
- All other TANF-EA for 937 families (including back rent, back utilities, security deposits, furnishings, clothing and food allowance, or transitional housing)
- 563 families in Essex County, 160 in Passaic County, 152 in Middlesex County, 121 in Mercer.

In the past two years, the average number of EA payments for TANF families was 2,437 in 1998, and 1,861 for the twelve months of 1999. Payments were made to 3.2% more families in February 2000 as compared to February 1999.

- TRA payments were 14.9% of the number in February 2000.
- Motel payments were up from two years ago.; 140 to 185.

## **TANF PARTICIPATION RATES**

The TANF participation rate for February 2000 was 33.4% for the State as a whole. This is an increase of 3.31 percentage points from January 2000.

Participation rates by county:

- Seven counties had a participation rate greater than 40 percent, Monmouth, Morris, Salem,
- Somerset, Sussex, Union, and Warren.

**GENERAL ASSISTANCE** 

There were 23,895 GA recipients in December 1999, up from 23,274 in November.

• There were 14,165 Employable GA and 9,730 Unemployable GA recipients in December 1999.

## **CHILD SUPPORT AND PATERNITY**

For FFY 2000, the total collections of the Child Support and Paternity Program was about \$365,400,000, an increase of over 9 percent over the same period for FFY 1999.



#### **Explanatory Notes**

The Department of Human Services Division of Family Development provides basic income and an opportunity to achieve self-sufficiency for individuals and families served by the Division's programs. The Division provides leadership, direction and supervision to those public agencies responsible for administering those programs and plans for and develops policies to promote self-sufficiency.

**WORK FIRST NEW JERSEY (WFNJ)** - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) of 1996. PRWORA establishes Temporary Assistance to Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, WFNJ/TANF for families with children, and WFNJ/GA (General Assistance) for single adults and couples without dependent children. The emphasis is on achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.

**Employment Directed Activities (EDA)** - From Activities Summary Report (OMEGA report # RM064). Unduplicated count of persons participating in Community Work Experience Program (CWEP), All Other Training, or Job Search.

Number of Persons Employed This Month, Still Receiving TANF – Individuals with open "empl" activity on OMEGA. Ad hoc report.

**Participants Receiving Child Care Services** - From Issuance Disbursement Summary (OMEGA report # RM703). Total number of active participants who show receipt of **Child Care**.

Number of Persons Closed on FAMIS Due to Employment- From FAMIS report # FM463.

**Post TANF and Receiving Child Care** - Persons no longer in receipt of TANF but still receiving child care. From Issuance Disbursement Summary (OMEGA report # RM703).

**MEDICAID ONLY FAMILIES** no longer receive TANF financial assistance but remain eligible for Medicaid under applicable provisions which extend coverage beyond the period of assistance. These are shown separately in these tables because cash assistance and Medicaid have been de-linked.

**FOOD STAMP PROGRAM (FS)** - Authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refer certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

**EMERGENCY ASSISTANCE (EA)** - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or house-hold furnishings by fire, flood or other similar disaster) or if the eligible individual or family is in an imminent or actual state of homelessness.
