Academic Achievement measures the content knowledge students have in language arts literacy and math. For high schools, this includes measures of the school's proficiency rate on both the Language Arts Literacy and Math sections of the New Jersey High School Proficiency Assessment (HSPA). A proficiency rate is calculated by summing the count of students who scored either proficient or advanced proficient on the assessment and dividing by the count of valid test scores.

## College and Career Readiness

This school outperforms $\mathbf{8 4 \%}$ of schools statewide as noted by its statewide percentile ranking and $\mathbf{7 6 \%}$ of schools educating students with similar demographic characteristics as noted in its peer school percentile ranking in the performance area of College and Career Readiness. Additionally, this school is meeting $\mathbf{1 0 0 \%}$ of its performance targets in the area of College and Career Readiness.

## Graduation and Post-Secondary

This school outperforms $\mathbf{8 1} \%$ of schools statewide as noted by its statewide percentile ranking and $\mathbf{4 4 \%}$ of schools educating students with similar demographic characteristics as noted in its peer school percentile ranking in the performance area of Graduation and Post-Secondary. Additionally, this school is meeting $\mathbf{1 0 0 \%}$ of its performance targets in the area of Graduation and Post-Secondary.

College and Career Readiness measures the degree to which students are demonstrating behaviors that are indicative of future attendance and/or success in college and careers. COLLEGE AND CAREER READINESS

## NJ SCHOOL

Students in both elementary and middles schools begin to demonstrate college readiness behaviors long before they even enter high school. Among the behaviors that research has shown to be indicative of success and college and career readiness are regularly attending school and challenging themselves with rigorous course work.
