EXECUTIVE SUMMARY

The New Jersey Wiretapping and Electronic Surveillance Control Act allows certain "consensual" intercepts to occur without the need for a prior court order. Specifically, *N.J.S.A.* 2A:156A-4c permits any person acting at the direction of an investigative or law enforcement officer to intercept a wire, electronic or oral communication where that person is a party to the communication or where one of the parties to the communication consents to the intercept. Because the officer directing the intercept is not a party to the communication, this class of intercepts is collectively designated "third party" consensual intercepts.

Likewise, *N.J.S.A.* 2A:156A-4b permits any investigative and law enforcement officer to intercept wire, electronic or oral communications where the officer himself is a party to the communication or where another officer who is a party to the communication requests or requires that he do so. Because the officer is a party to the communication being recorded, this class of intercepts is collectively referred as "non-third party" consensual intercepts.

The Wiretap Act directs the Attorney General to collect and maintain records of all intercepts falling into either of the above categories, regardless of whether the intercept is carried out by his office, a county prosecutor or local law enforcement agency. The Act further requires that the Attorney General report annually to the Governor and Legislature on the manner in which both classes of intercepts are conducted.

N.J.S.A. 2A:156A-23c provides as follows for third party intercepts:

In addition to reports and records otherwise required by law, the

Attorney General and the county prosecutor shall maintain records of
all interceptions authorized by them pursuant to [N.J.S.A. 2A:156A4c], on forms prescribed by the Attorney General. Such records shall
include the name of the person requesting the authorization, the
reasons for the request, and the results of any authorized intercept.

The Attorney General shall require that copies of such records
maintained by county prosecutors be filed with him periodically and he
shall report annually to the Governor and the Legislature on the
operation of section 4c.

N.J.S.A. 2A:156A-23d similarly provides for non-third party intercepts:

In addition to reports required to be made by applicants pursuant to Federal law, the Attorney General shall receive and maintain records of all interceptions authorized pursuant to [N.J.S.A. 2A:156A-4b] and shall include such information in his annual report to the Governor and the Legislature. It shall be the obligation of all law enforcement agencies in the State to file with the Attorney General on forms prescribed by the Attorney General information pertinent to the operation of section 4b. The information on the forms shall include, but not be limited to (1) the name of the investigative or law enforcement officer making the interception; (2) the law enforcement agency employing the officer involved in the interception; (3) the character of the investigation or activity involved; and (4) the results of such activity.

The report that follows contains all the required information for 2004 concerning the operation of all non-third party and third party consensual intercepts permitted by *N.J.S.A.*2A:156A-4b and c. In accordance with the statutory scheme, this report identifies the law enforcement agencies utilizing consensual intercepts, the character of the investigation or activity for which each intercept was sought and the results of the investigation or activity. In addition to the narrative highlights provided for applications and consensual intercepts for the year 2004, detailed intercept information for the current report year as well as supplemental follow-up data for consensual intercepts reported in previous calendar years are provided in the appendices.

THIRD PARTY CONSENSUAL INTERCEPTS (N.J.S.A. 2A:156A-4c) 2004

Third Party Consensual Intercept Applications

In 2004, 815 third party consensual intercept applications were reported statewide in accordance with *N.J.S.A.* 2A:156A-4c. Of the total applications seeking authorization, 186 were processed through the Attorney General's Office. These applications were submitted by the Division of State Police, the Division of Criminal Justice, and the State Office of Government Integrity. The other 629 reported applications were processed by 20 of the 21 county prosecutors' offices.

- Of the 815 applications reported for consensual intercepts, 812 were authorized. Three applications were withdrawn.
- Of those 812 intercepts authorized, 674 were installed and used. In all, 137 intercepts were never implemented. (Data concerning intercept installation and use was missing for one intercept.)

The type of surveillance conducted is categorized as wire, oral, or electronic communication.

- Of the 812 intercepts authorized and for which type of surveillance was reported: (The type of surveillance conducted for 15 intercepts was not reported.)
 - 331 (41%) involved wire intercepts;
 - 229 (28%) involved oral intercepts;
 - 197 (24%) involved both wire and oral intercepts;
 - 33 (4%) involved wire, oral and electronic communications intercepts;
 - 5 involved electronic communications intercepts;
 - 1 involved oral and electronic communications intercepts; and
 - 1 involved a video communications intercept.

Offense data collected and analyzed consider only the most serious substantive offense investigated. Of those 812 consensual intercepts authorized, over one-third (38%) were authorized in conjunction with criminal investigations involving controlled dangerous substance offenses. A list of intercepts granted by category of most serious offense investigated follows.

2004 Third Party Intercept Outcome

Summary information regarding outcomes is provided below with detailed information in Appendix A.² The information provided concerns intercept and investigation outcomes, arrest and referral actions, defendant indictments resulting from each intercept application, the most serious offense charged, defendant dispositions, and administrative actions.

- At the close of the report year (December 31, 2004), a total of 338 arrests were made and 120 defendants were indicted statewide as a result of 2004 third party consensual intercepts.
- Of those 120 defendants indicted, considering the most serious offense charged, 54 (45%) were indicted for controlled dangerous substance offenses.
- In addition, 19 (16%) defendants were indicted for theft offenses, 15 (13%) were indicted for sexual assault offenses, 9 (7%) were indicted for forgery/fraud offenses, 6 were indicted on charges involving official misconduct, and 6 were indicted for weapons offenses.
- Three defendants were indicted for each of the following offenses: assault/terroristic threats and murder.
 - Two defendants were indicted for each of the following offenses: burglary and perjury.
 - One defendant was indicted for endangering the welfare of a child.

In addition to those 120 defendants indicted, 194 were arrested and awaiting grand jury action at the close of the report year, 18 were referred for prosecution (14 were referred for criminal prosecution, 2 were referred to family court and 2 were referred to municipal court), 4 had charges administratively dismissed, 1 was deceased, and 1 pled guilty to a disorderly persons offense (pre-indictment).

At the close of the report year, 75 of the 120 defendants indicted reached final disposition.

Of those 75 defendants with indictments reaching final disposition, 71 (95%) were convicted through plea, 2 were accepted into a post-indictment diversionary program, 1 had charges dismissed, and 1 was found not guilty at trial.

NON-THIRD PARTY CONSENSUAL INTERCEPTS (N.J.S.A. 2A:156A-4b) 2004

In 2004, 271 non-third party consensual intercepts were reported in accordance with *N.J.S.A.* 2A:156A-4b. Of the total non-third party intercepts reported, 84 were processed by the Attorney General's Office and 187 were processed by county and local law enforcement agencies.

Eight of the 21 counties (Atlantic, Burlington, Camden, Cape May, Gloucester, Hunterdon, Monmouth, and Warren counties) reported non-third party intercepts processed by either county law enforcement agencies or local police departments.

Of the 271 non-third party intercepts reported, 241 were installed and used. Thirty intercepts were never implemented.

The type of surveillance conducted is categorized as wire, oral, or electronic communication.

The type of surveillance implemented for non-third party intercepts which were installed and utilized follows:

- 199 (83%) involved oral intercepts;
 - 17 (7%) involved wire intercepts;
 - 16 (7%) involved both wire and oral intercepts;
 - 5 (2%) involved wire, oral and electronic communications intercepts;
 - 2 involved video communications intercepts;
 - 1 involved an electronic communications intercept;
 - 1 involved both a wire and electronic communications intercept.

Offense data collected for non-third party intercepts and analyzed consider the most serious substantive offense investigated. Offenses investigated were reported for all 271 authorized intercepts. A list of all intercepts by most serious offense, offense category or violation investigated follows.

2004 Non-Third Party Intercept Outcome

Summary information regarding intercept outcomes is provided below with detailed information provided in Appendix B.⁴ The information provided concerns intercept and investigation outcomes, arrest and referral actions, defendant indictments resulting from each intercept application, the most serious offense charged, and defendant dispositions.

- At the close of the report year (December 31, 2004), a total of 36 defendants were indicted statewide as a result of 2004 non-third party consensual intercepts.
 - Of those 36 defendants indicted, considering the most serious offense or offense category charged, 32 (89%) were indicted for controlled dangerous substance violations.
 - In addition, 3 defendants were indicted for theft and 1 defendant was indicted for assault/terroristic threats.
 - In all, 2004 non-third party consensual intercepts resulted in 340 arrests during the report year.
 - In addition to those 36 defendants who were indicted, 250 were referred to municipal court for prosecution, 52 were pending grand jury action at the close of the report year, 1 pled guilty to a disorderly persons offense (pre-indictment), and 1 had charges referred to the United States Attorney's Office for prosecution.
 - At the close of the report year, 25 of the 36 defendants indicted reached final disposition.
 - Of those 25 defendants reaching final disposition, 22 were convicted through guilty pleas, 2 were admitted into post-indictment diversionary programs, and one had indictment charges dismissed.
