1.

TO ALL MUNICIPAL ISSUING AUTHORITIES:

In connection with investigations, disciplinary proceedings and appeal cases, examination of applications filed by retail licensees has been made from time to time by this Department. It appears that certain questions are frequently answered erroneously or inadequately. To attain a maximum of accuracy, certain revisions in the forms of application for retail licenses have been made.

The license certificate forms have been revised so that they now call for the effective date of the license.

It is absolutely necessary that all issuing authorities have a sufficient supply of application forms and license certificates prepared at the earliest possible moment so that they will be available when the time comes for the issuance of new licenses for the next fiscal year, beginning July 1st, 1940.

Following, in the order set forth, are the prescribed forms of applications and license certificates:

- Item 2 New form of application for all municipal retail licenses, except Club Licenses.
 - Item 3 New form of application for Club License.
- Item 4 New form of license certificate for Plenary Retail Consumption License.
- Item 5 New form of license certificate for Plenary Retail Distribution License.
- Item 6 New form of license certificate for Seasonal Retail Consumption License.
- Item 7 New form of license certificate for Limited Retail Distribution License.
 - Item 8 New form of license certificate for Club License.

The application and license certificate forms herein promulgated are effective for the fiscal year commencing July 1st, 1940 and thereafter.

Effective July 1st, 1940, Bulletin 237 is superseded in its entirety.
