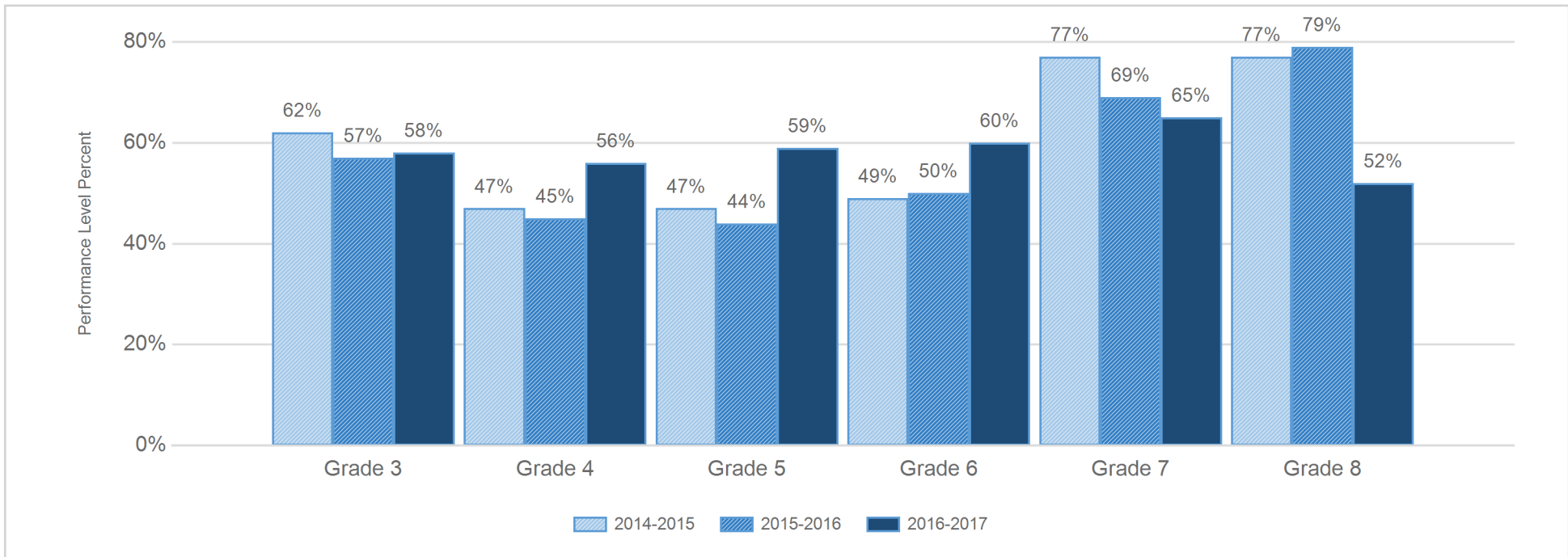

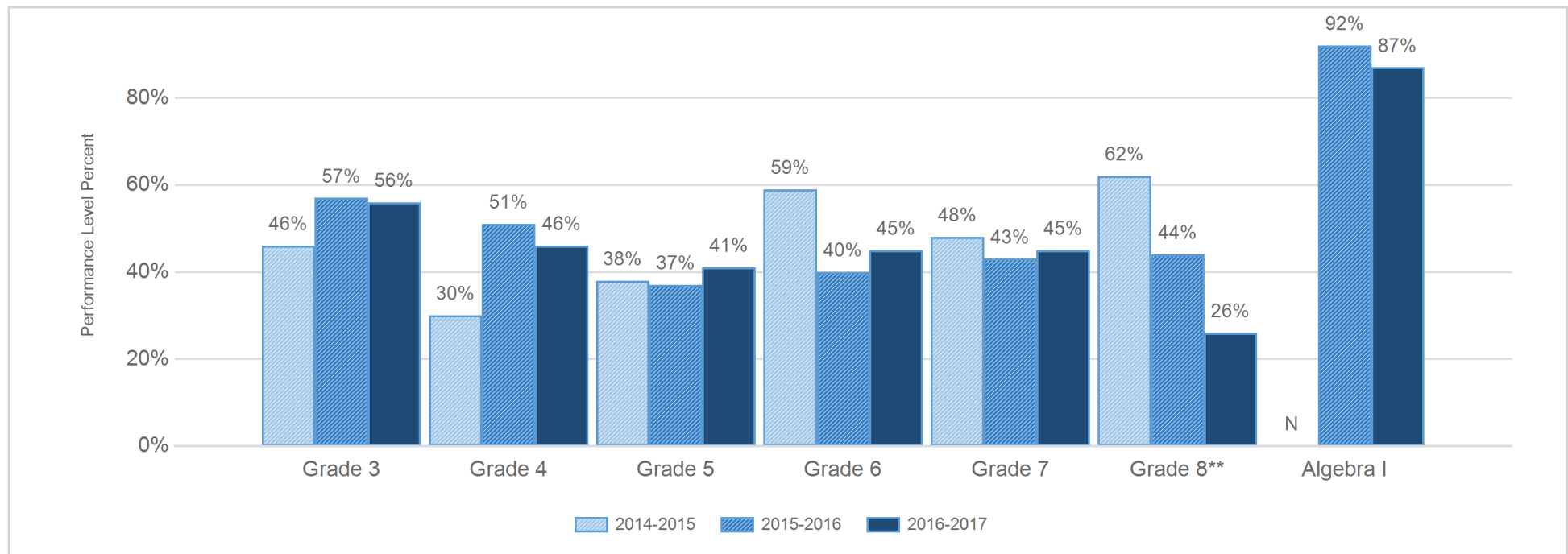

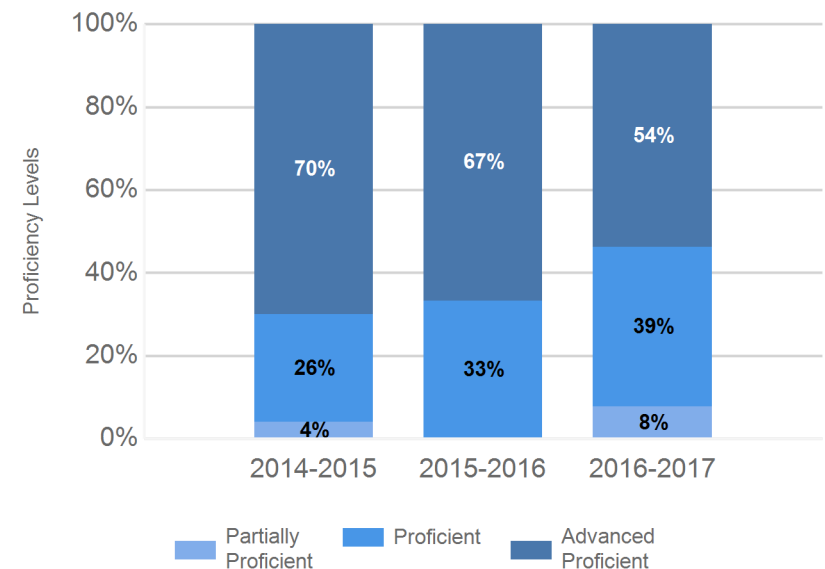

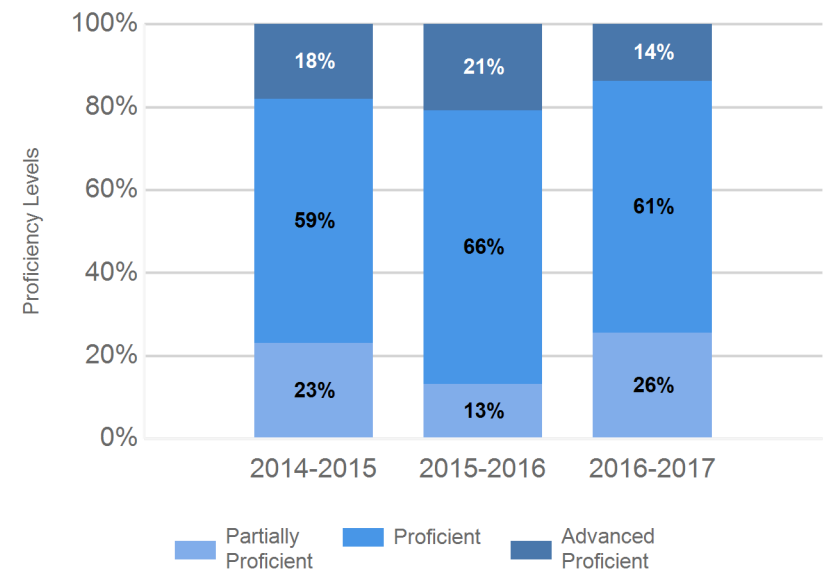

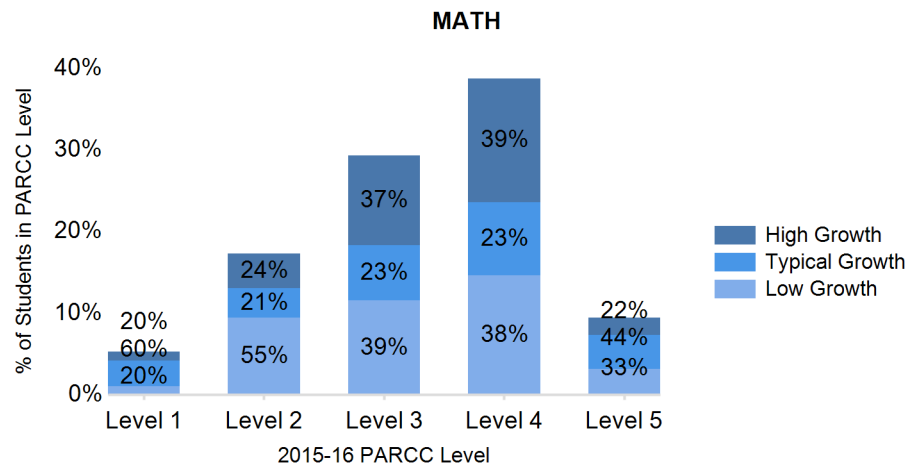
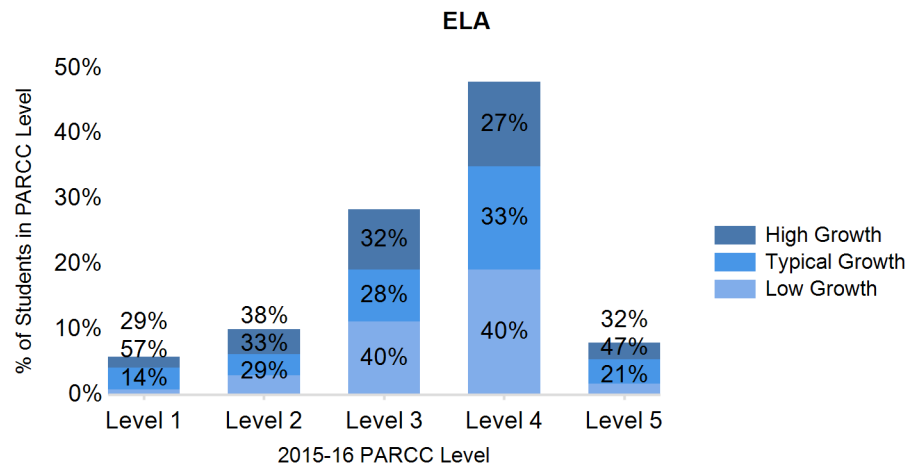

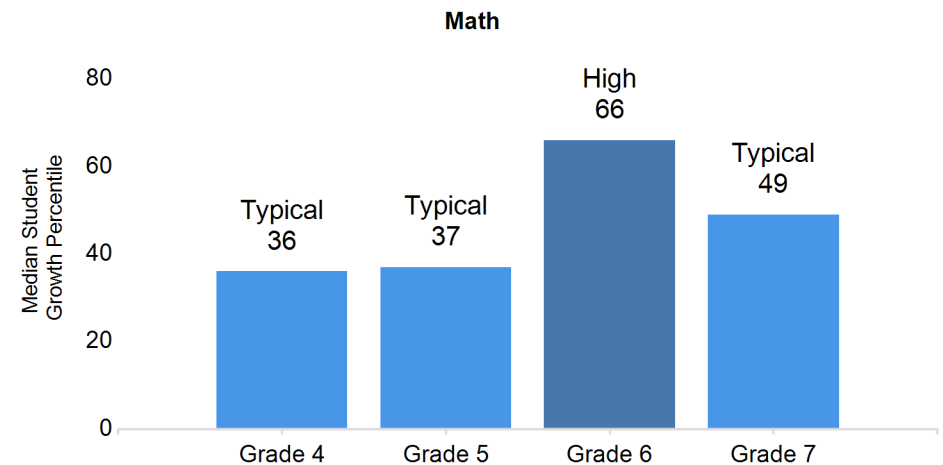
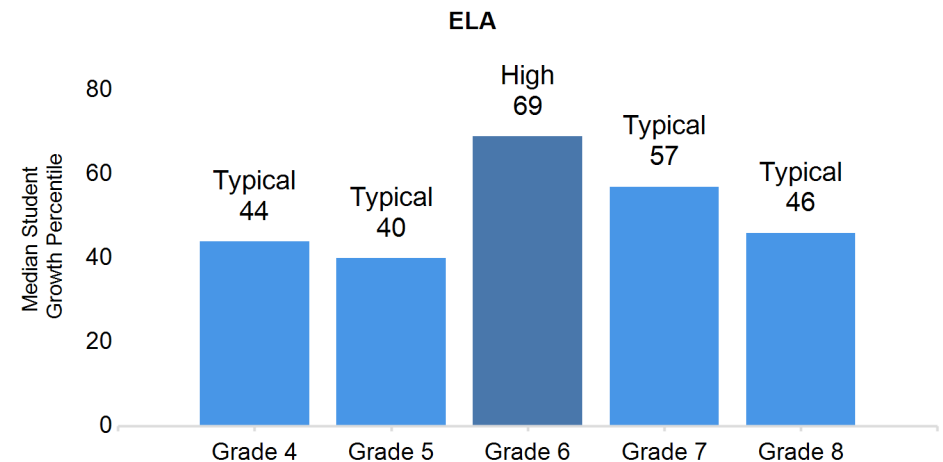

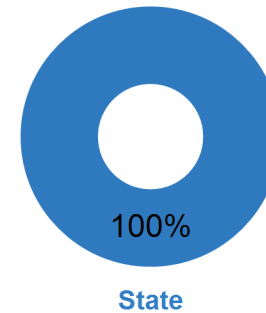

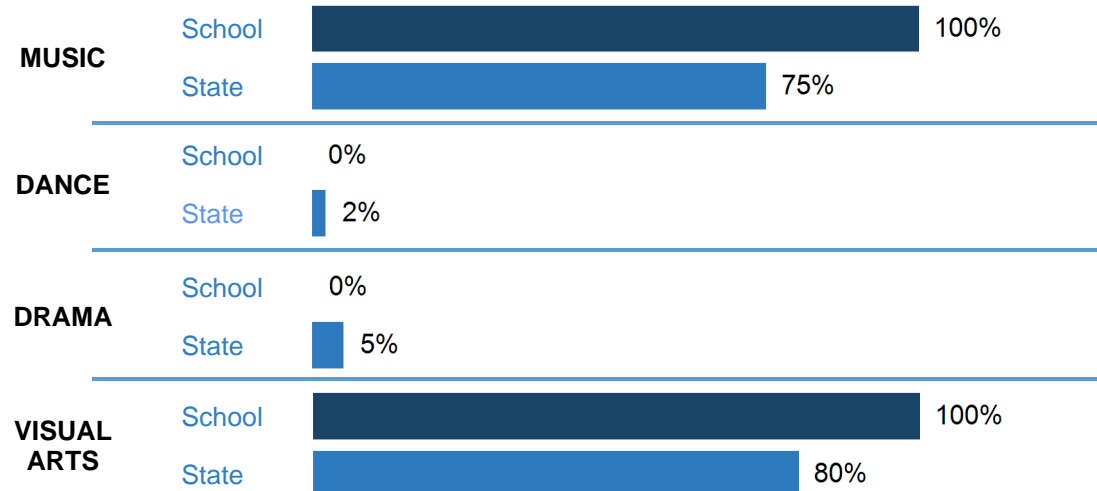

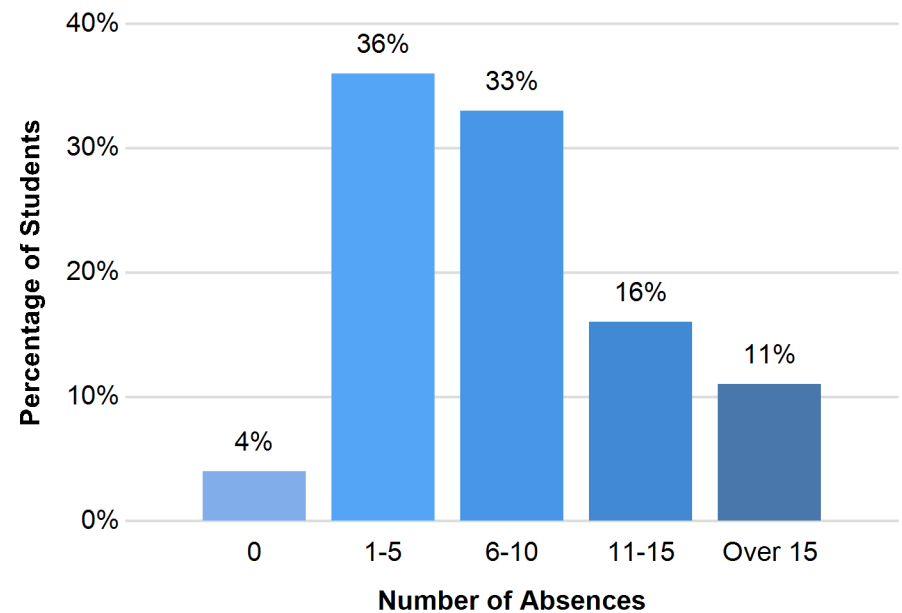

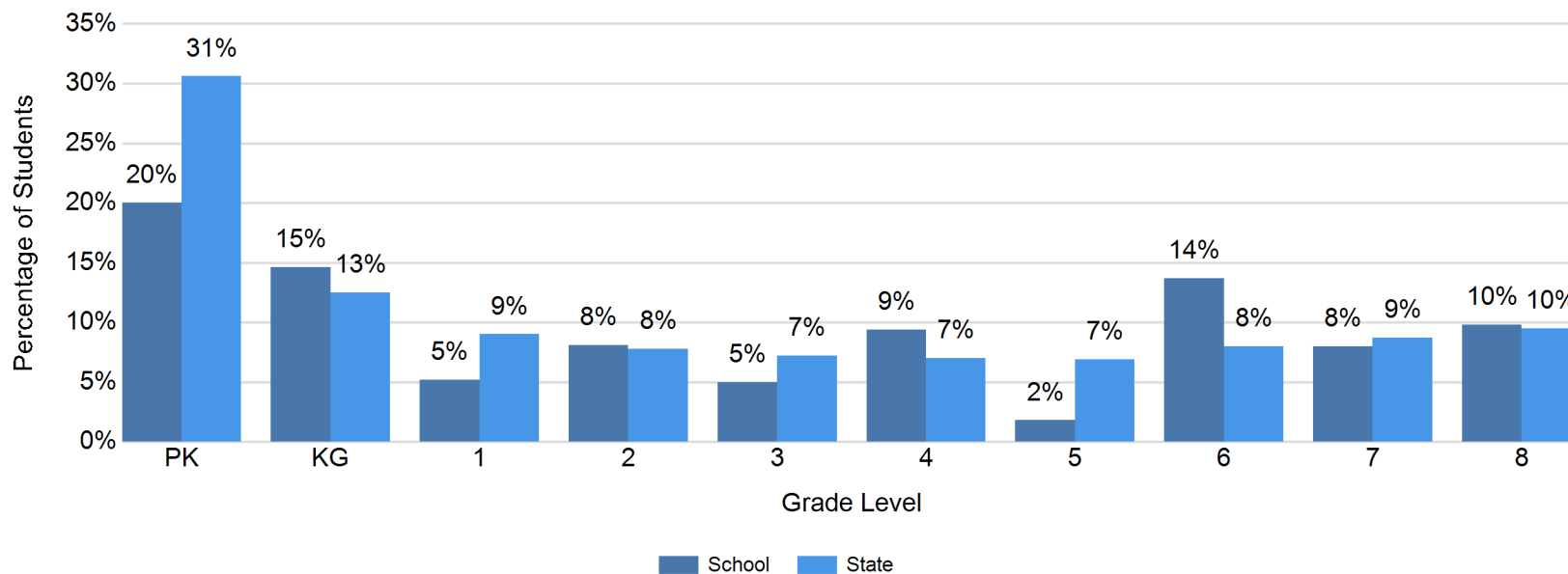
### Days Absent

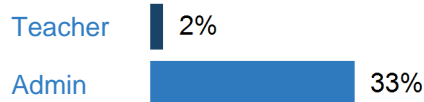
#### Bachelor's Degree
