TRODUCTION

I AM HONORED TO BE STANDING IN FOR GOVERNOR WILLIAM LIVINGSTON WHO S GOVERNOR OF NEW JERSEY DURING THE FALL LEGISLATIVE SESSION OF 1779 ICH WE ARE COMMEMORATING HERE TODAY.

E SUCCEEDED WILLIAM FRANKLIN, THE BASTARD SON OF BENJAMIN FRANKLIN) I NOTE THAT THE LEGISLATURE OF 1779 TOOK A NUMBER OF DECISIVE ACTIONS HAT MEETING.

IT IMPOSED A BOUNTY TO ENCOURAGE THE RETURN OF STRAY HORSES, CATTLE SHEEP TO THEIR OWNERS. IT PLACED AN EMBARGO ON THE EXPORT OF PROVISIONS. AS WHEAT, FLOUR AND RYE TO PREVENT THEIR FALLING INTO THE HANDS OF THE AND ESTABLISHED THE STATE SUPREME COURT.

IT ALSO GRANTED A DIVORCE, RAISED CONSTABLES' FEES, GRANTED AN USIVE BLUBBER SALES FRANCHISE AND APPROPRIATED 3.375 MILLION POUNDS.

ISHED BUSINESS

MEETING HERE IS LARGELY CEREMONIAL, AND TIMED TO CELEBRATE A PAST NEW JERSEY HISTORY.

THIS SESSION CAN BE MEANINGFUL FOR THE FUTURE IF WE DECIDE HERE, AS MENT, THAT WE WILL FINALLY ADDRESS SEVERAL SIGNIFICANT LEGISLATIVE HICH HAVE CONSUMED A GOOD DEAL OF LEGISLATIVE TIME AND STUDY IN PAST TWO YEARS. Acres Statistical And design

INSTITUTIONAL BASIS

WE HAVE USED THIS TIME, NOVEMBER THROUGH JANUARY, PRODUCTIVELY THE PAST. LAST YEAR, FOR INSTANCE, WE PASSED LEGISLATION TO MAINTAIN CONTINUE THE POPULAR PHARMACEUTICAL ASSISTANCE PROGRAM FOR THE AGED.

IN PREVIOUS YEARS, WE TOOK THIS OPPORTUNITY TO APPROVE MANY PORTANT FINANCIAL AND POLICY ACTIONS. IN 1976 THE FALL LEGISLATIVE SSION INCLUDED APPROVAL OF A PRECEDENT - SETTING "SPILL COMPENSATION D CONTROL ACT," AS WELL AS, A SUPPLEMENTAL APPROPRIATION AND OTHER LISURES.

IN THE FALL OF 1977 THE LEGISLATURE APPROVED A PROVISION FOR A GREE HOMESTEAD REBATE AND OTHER MAJOR LEGISLATION.

AND WE KNOW WHAT NOW REMAINS UNDONE.

AUTO INSURANCE REFORM

FOR MOST OF THE YEAR, WE HAVE WORKED -- SOMETIMES QUIETLY AND OTHER TIMES ROBUSTLY -- ON THE ISSUE OF AUTO INSURANCE REFORM.

WE KNOW OF THE PROBLEMS. YOUNG PEOPLE AND OLD ARE PENALIZED --NOT FOR THEIR DRIVING RECORDS BUT BECAUSE OF WHERE THEY LIVE, WHAT KIND OF WORK THEY DO AND HOW OLD THEY ARE. WE CANNOT LET THAT CONTINUE.

THOUSANDS, LITERALLY HUNDREDS OF THOUSANDS, ARE UNFAIRLY PLACED IN THE ASSIGNED RISK PLAN DESPITE WHAT THE INSURANCE INDUSTRY RECOGNIZES AS GOOD DRIVING RECORDS.

THERE, FOR NO REASON OF THEIR OWN MAKING, PEOPLE ARE OFTEN BURDENED WITH INADEQUATE SERVICE AND SOMETIMES WITH HIGHER RATES. WE CANNOT LET THAT CONTINUE.

WE KNOW THE OPTIONS. THEY HAVE BEEN STUDIED, DEBATED AND MRASHED OUT IN LEGISLATIVE COMMITTEES, SPECIAL TASK FORCES, THE MEDIA AND INDEED IN YOUR CAMPAIGNS.

A JOINT UNDERWRITING ASSOCIATION CAN REPLACE THE ANTIQUATED SIGNED RISK, SO THAT ALL GOOD DRIVERS CAN OBTAIN INSURANCE IN VOLUNTARY MARKET. ONLY BAD DRIVERS WOULD BE PENALIZED. a standar a share a s

CLASSIFICATION, TERRITORIES, AND RATING SYSTEMS CAN BE MADE LESS ARBITRARY, AND COSTS CAN BE CUT THROUGH STRONGER ANTI-FRAUD EFFORTS AND THROUGH MEANINGFUL, LONG OVERDUE REFORM IN THE NO-FAULT SYSTEM. THIS WILL RESULT IN SERIOUSLY INJURED VICTIMS OF ACCIDENTS RECEVING J COMPENSATION FROM OUR COURTS WHILE PROVIDING FIRST PARTY BENEFITS AND COMPENSATION FOR MONETARY LOSS TO THESE LESS SERIOUSLY INJURED.

WE MUST ACT IN THE INTEREST OF THE PUBLIC AND NOT SUCCUMB TO THE PRESSURES OF SPECIAL INTEREST LOBBYISTS.

THE CITIZENS OF NEW JERSEY ARE LOOKING TO US FOR ACTION. LET'S GET ON WITH IT.

CIVIL SERVICE REFORM

AGAIN, WITH THE CIVIL SERVICE SYSTEM, WE KNOW THE PROBLEMS. WE KNOW THAT HIGHLY QUALIFIED PEOPLE CAN, AND HAVE, SCORED AS HIGH AS 99 IN CIVIL SERVICE TESTS AND YET HAVE BEEN BYPASSED FOR OTHERS WHO BARELY MAKE THE PASSING GRADE OF 70.

WE KNOW THERE ARE OTHER FAULTS IN THE SYSTEM: THAT THE SO-CALLED MERIT SYSTEM DOES LITTLE TO CORRECT POOR PERFORMANCE AND TO REWARD OUTSTANDING PERFORMANCE.

WE KNOW WHAT CAN AND SHOULD BE DONE. THERE HAS BEEN A CONSULTANT' REPORT, AND AN ADMINISTRATIVE REPORT; A LEGISLATIVE COMMITTEE HEARING HAS HELD FULLY A YEAR AGO. LET'S GET ON WITH THIS, TOO. I BELIEVE THA REFERENCE FOR VETERANS IN THE ASSEMBLY COMMITTEE VERSION OF THE BILL PRESENTS A JUST RECOGNITION OF THE SERVICE THE VETERANS HAVE DELIVERE OUR FELLOW CITIZENS WHILE NOT DESTROYING THE INCENTIVES FOR WOMEN OTHER NON VETERANS TO ASPIRE TO CAREER ADVANCEMENT.

WHAT IS TO BE GAINED BY FURTHER DELAY THAT WOULD RESULT FROM STARTING THE PROCESS OVER AGAIN IN JANUARY?

SUPPLEMENTAL APPROPRIATION

WE ALSO ASK FOR YOUR CONSIDERATION OF A RELATIVELY SMALL SUPPLEMENTAL APPROPRIATION TO COVER THREE AREAS: \$12,5 MILLION NOT INCLUDED IN THE 1979-80 BUDGET FOR SALARIES AND OTHER BENEFITS RESULT FROM NEGOTIATED CONTRACTS, \$10 MILLION TO MEET UNANTICIPATED STATE GOVERNMENT COSTS ESPECIALLY IN FUEL AND UTILITIES, AND TO FUND OTHER NEEDED PROGRAMS FOR OUR LESS PRIVILEDGED YOUTH; AND \$4,5 MILLION FOR PUBLIC TRANSIT SUBSIDIES DUE TO REDUCED FEDERAL SUBSIDIES.

GUBERNATORIAL CAMPAIGN SPENDING CEILINGS

I ALSO ASK THAT YOU PLACE A CEILING ON THE AMOUNT OF MONEY THAT CAN BE SPENT ON GUBERNATORIAL CAMPAIGNS. THE MEASURE NOW BEFORE A SENATE COMMITTEE CALLS FOR A \$900,000 LIMIT ON GUBERNATORIAL PRIMARY CANDIDATES AND \$1.8 MILLION IN THE GENERAL ELECTION. SCI VETO

TODAY, I AM RETURNING FOR YOUR CONSIDERATION THE BILL EXTENDING THE LIFE OF THE STATE COMMISSION OF INVESTIGATION. I ASK THAT YOU RECONSIDERATION CALLING FOR ADVICE AND CONSENT ON THE TWO GOVERNOR'S APPOINTMENTS TO THE COMMISSION, AND THEN RETURN THE BILL TO ME PROMPTLY FORTGAGE RATE

IN ADDITION, WE HAVE TODAY ON THE BOOKS AN OUT-DATED PROCEDURE FOR REGULATING MORTGAGE INTEREST RATES.

AS IT STANDS, THE BANKING COMMISSIONER MUST RETURN TO THE GISLATURE REPEATEDLY FOR APPROVAL TO CHANGE THE MORTGAGE RATE CEILING

TO REFLECT CURRENT MARKET CONDIDTIONS.

THE CEILING OF 10.75 PER CENT SET BY LAW IN NEW JERSEY IS UNREALISTIC AT A TIME WHEN OTHER INTEREST RATES ARE DRAMATICALLY HIGHER.

THE PRIME INTEREST RATE IS ABOUT 15 PER CENT, FOR EXAMPLE. FEDERALLY BACKED MORTGAGES TODAY RUN ABOUT 13 OR 14 PER CENT.

MORTGAGES GRANTED THROUGH THE VETERANS ADMINISTRATION TODAY CARRY A MORTGAGE RATE OF 11 - 1/2 PER CENT, PLUS 1/2 PER CENT FOR INSURANCE AND EIGHT TO 10 "POINTS". EFFECTIVELY, THIS IS ABOUT A 13 PER CENT V.A. MORTGAGE.

HOPEFULLY, THIS HIGH INTEREST SITUATION WILL NOT LAST LONG. BUT IN THE MEANTIME, OUR BANKING COMMISSIONER MUST RESPOND AND ADJUST THE RATE TO ASSIST THOSE PEOPLE WHO CANNOT BUY OR SELL THEIR HOMES BECAUSE MORTGAGES SIMPLY ARE NOT AVAILABLE UNDER THE CEILING WE HAVE SET.

I RECOMMEND THAT THE CEILING BE LIFTED AND THE STATE COMMISSIONER F BANKING HAVE THE AUTHORITY TO EXERCISE HIS AUTHORITY CAREFULLY AND CAUTIOUSLY TO MAKE MORTGAGE MONEY AVAILABLE IN NEW JERSEY.

WE ALSO MUST EXAMINE OPTIONS, BOTH LEGISLATIVELY AND MINISTRATIVELY FOR OTHER TYPES OF FINANCING THAT WILL KEEP THE OPTION HOME OWNERSHIP AVAILABLE TO NEW JERSEY CITIZENS OF MODERATE MEANS. ALC: A DESCRIPTION OF

ADDITIONAL MEASURES

FINALLY, THERE ARE A FEW OTHER MEASURES TO CONSIDER. THE DEPARTMENT OF ENVIRONMENTAL PROTECTION REQUESTS THE APPROPRIATION OF \$52 MILLION FROM THE GREEN ACRES FUNDS PREVIOUSLY APPROVED BY REFERENDUM.

ALSO A HIGH PRIORITY ISSUE IS THE OIL AND CHEMICAL SPILL COMPENSAT FUND TO PARTIALLY ADDRESS THE PROBLEM OF TOXIC WASTES.

CONCLUSION

WE CAN LEAVE A LEGACY OF GOOD GOVERNMENT FOR YEARS TO COME. LET RESOLVE AS OUR FOREFATHERS DID 200 YEARS AGO THAT WE SHOULD NOT FEAR POWERFUL FORCES OF FOREIGN OPPRESSIVE NATIONS. WE CAN LEAD THIS GREAT STATE INTO A NEW ERA OF NATIONAL LEADERSHIP.

IN THE REMAINING FEW WEEKS ALLOTTED TO US, WE CAN -- AND MUST --USE OUR TIME TO THE FULLEST AND RESOLVE THESE PROBLEMS WHICH OUR CITIZEN EXPECT US TO RESOLVE.

THIS IS OUR CHALLENEGE AND THIS IS OUR RESPONSIBILITY.

ACCOMPLISHMENTS OF THE SEVENTIES

NEW JERSEY IS A BETTER PLACE AT THE END OF THE SEVENTIES THAN IT WAS TEN YEARS AGO. IT TOOK SOME DOING, WITH HELP FROM EVERYBODY: THE LEGISLATURE, THE PEOPLE, AND THE GOVERNOR.

AS DO THE NETS,

AS WILL A HOCKEY TEAM, CIRCUS, AND OTHER POPULAR ATTRACTIONS IN THE NEW ARENA.

THE GLAMOUR OF ATLANTIC CITY GROWS EACH DAY.

OUT-OF-STATE TOURISTS ATTRACTED FIRST TO ATLANTIC CITY HAVE A CHANCE TO SEE THE REST OF NEW JERSEY AND REALIZE WHY WE TAKE A BACK SEAT TO NO ONE, OR TO NO PLACE.

WE NOW SEE NEW JERSEY WORKING CLOSELY WITH A PRESIDENT WHO HAS SHOWN CONCERN FOR OUR CITIES AND WHO HAS HELPED US WITH HOUSING, SEWAGE TREATMENT PLANTS, MASS TRANSIT FUNDING, CANCER PROGRAMS, AND ENERGY ALTERNATIVES.

WE HAVE WORKED WITH PRESIDENT CARTER AND PRESIDENT CARTER HAS WORKED WITH US.

I AM OPTIMISTIC ABOUT NEW JERSEY.

AND TOGETHER WE FACE A NEW DECADE, WITH NEW CHALLENGES, AND STILL DISTANT HORIZONS.

OUR ABILITY TO MEET OUR FUTURE GOALS IS THREATENED MOST CRITICALLY BY THE RELATED PROBLEMS OF INFLATION AND ENERGY.

WE HAVE UNKNOWN QUANTITIES OF TOXIC WASTE DANGEROUSLY INSULTING OUR ENVIRONMENT, AND WE HAVE BEGUN THE HUNT AND THE PROCESS OF CLEANING UP AND SEEKING OUT THE RESPONSIBLE CULPRITS.

NO CRIME ON OUR BOOKS IS MORE DASTARDLY THAN THE POISONING OF OUR SOIL, OR OUR AIR, OR OUR WATERS.

WE HAVE IN OUR STATE A CORPS OF SENIOR CITIZENS WHO CAN, AND SHOULD BE, A VITAL AND USEFUL PART OF OUR COMMUNITY --RECYCLED TEENAGERS, ONE TOLD ME HE WANTED TO BE CALLED.

OUR SENIORS ARE ENTITLED TO BE PROTECTED FROM THE RAVAGES OF INFLATION IN HOUSING, ENERGY COSTS, AND TRANSPORTATION. YOU HAVE CREATED A PHARMACEUTICAL ASSISTANCE PROGRAM FOR THE AGED, A UTILITY "LIFELINE" CREDIT PROGRAM, A SPECIAL HOMESTEAD REBATE, AND OTHER PROGRAMS.

NOW COMMISSIONER GAMBACCINI MUST FIND A WAY TO ALLOW OUR SENIORS TO USE HIS SOON-TO-BE-ACQUIRED NEW BUSES FARE FREE.

OUR STREETS MUST BE MADE SAFER IN THE EIGHTIES. A SPEEDY TRIAL AND SWIFT PUNISHMENT FOR SERIOUS CRIMES ARE BOTH RIGHTS AND DUTIES OF OUR SOCIETY. A REAL PROPERTY AND A REAL PROPERTY.

THE ATTORNEY GENERAL AND THE CHIEF JUSTICE HAVE DEVELOPED AN INNOVATIVE SPEEDY TRIAL PROGRAM WHICH WE WILL IMPLEMENT THIS YEAR WITH THE AID OF SOPHISTICATED COMPUTER TECHNOLOGY TO INSURE THE PROMPT ADMINISTRATION OF JUSTICE.

IF WE CAN GUARANTEE FAIR AND SPEEDY TRIALS, AND CERTAIN PUNISHMENT FOR THE CRIMINAL, WE WILL GO FAR TOWARD OUR GOALS OF MAKING OUR CITIES, TOWNS AND HOMES SAFE AND SECURE FOR THE NEW DECADE.

I AM CONFIDENT THAT NEW JERSEY'S YOUNG PEOPLE WILL CONTINUE TO WARRANT OUR PRIDE DURING THE 1980'S, BUT THOSE WHO <u>UNDERSTAND</u> THEIR OBLIGATIONS TO SOCIETY AND STILL CONTINUE TO COMMIT VIOLENT CRIMES MUST BE DEALT WITH FIRMLY.

I SUPPORT THE ATTORNEY GENERAL'S EFFORTS TO TREAT AS ADULT OFFENDERS THE FEW JUVENILES WHO ARE INCAPABLE OF BEING DETERRED FROM REPEATED ACTS OF VIOLENCE.

THE BEST MINDS IN LAW ENFORCEMENT WITH FULL CITIZENS' COOPERATION HAVE GOT TO MAKE FREEDOM FROM FEAR A FUNDAMENTAL RIGHT OF NEW JERSEY CITIZENS AND CITIZENS MUST BE MADE PART OF THE LAW ENFORCEMENT EFFORT.

GOOD POLICE MORALE AND DECENT POLICE WAGES ARE CORNERSTONES OF ANY PROGRAM. AND POLICE MUST FACE THEIR RESPONSIBILITY TO MERIT PUBLIC RESPECT.

WE START WITH A GOOD NEW CRIMINAL CODE AND A PAROLE REFORM LAW. I NEED YOUR HELP IN FIGHTING THOSE PEOPLE WHO DO NOT THINK WE NEED MORE PRISON SPACES.

NO JUDGE IN NEW JERSEY SHOULD EVER HAVE TO LET ANYONE OUT OF JAIL JUST BECAUSE WE DON'T HAVE THE ROOM TO KEEP HIM IN.

IN THE 1980'S, WE MUST BE ABLE TO GET WHERE WE WANT TO GO IN NEW JERSEY.

OUR PREDECESSORS BELIEVED THAT PEOPLE FROM NEW JERSEY ONLY WANTED TO GO TO NEW YORK AND PHILADELPHIA, AND OUR TRANSPORTATION SYSTEM WAS SO DESIGNED.

IN BERGEN COUNTY TODAY, THE FASTEST WAY TO GO BY BUS FROM ONE COMMUNITY TO ANOTHER IS THROUGH NEW YORK CITY.

WE ARE GOING TO REDESIGN OUR TRANSIT SYSTEM SO THAT PEOPLE CAN GO FROM NEW JERSEY TO NEW JERSEY FOR A CHANGE.

LET'S LOOK IN THIS DECADE AT THE IRRATIONAL BURDEN WE HAVE PLACED ON THE MUNICIPALITIES, ESPECIALLY OUR URBAN AREAS.

IN NEWARK, WE'VE TAKEN TWO-THIRDS OF THE LAND OFF THE TAX ROLLS, MADE THE CITY RESPONSIBLE FOR ITS WELFARE LOAD AND CAPPED ITS SPENDING.

I SUGGEST WE LOOK TO ALL OUR STATE AID FORMULAS AND MAKE THEM RATIONALLY CORRESPOND TO <u>NEED</u>, AND I SUGGEST THAT THE WELFARE BURDEN BELONGS TO ALL OF US, NOT JUST TO THOSE OF US WHO OWN PROPERTY IN A CITY. AND OUR CAP LAWS SHOULD PROMOTE EFFICIENCY IN OUR COMMUNITIES BUT NOT CHOKE THEM TO DEATH.

EXECUTIVE AND LEGISLATIVE INITIATIVES:

HERE ARE SOME INITIATIVES FOR THE EIGHTIES:

-- A NEW STATE OFFICE BUILDING IN NEWARK.

-- ACTION ON THE HUDSON WATERFRONT STUDY COMMISSION'S RECOMMENDATIONS WHICH ARE DUE SHORTLY.

-- CAREFUL AND ORDERLY DEVELOPMENT OF THE MEADOWLANDS CONSISTENT WITH THE NEEDS OF OUR OLDER CITIES.

-- CONSIDERATION OF A COMMUNITY DEVELOPMENT BOND ISSUE OR OTHER EFFORTS TO ASSIST FINANCIALLY IN DOWNTOWN DEVELOPMENTS.

TO HELP MAKE NEW JERSEY MORE APPEALING AND ENTERTAINING, WE NEED TO:

-- EXPAND THE JURISDICTION OF THE SPORTS AND EXPOSITION AUTHORITY TO UNDERTAKE MORE VARIED PROJECTS.

-- MAKE A FINAL JUDGMENT ON REBUILDING THE GARDEN STATE RACETRACK.

-- IMPROVE ENTERTAINMENT AND CULTURAL FACILITIES, INCLUDING WINTERIZATION OF THE GARDEN STATE ARTS CENTER.

-- PROMOTE A MOVIE AND TELEVISION PRODUCTION COMPLEX.

TO MEET THE SPECIAL NEEDS OF SOUTHERN NEW JERSEY, WE MUST:

-- IMPROVE STATE AND LOCAL EFFORTS TO MEET THE NEEDS

FOR HOUSING, TRANSPORTATION, AND OTHER FACILITIES IN ATLANTIC CITY. -- FINALIZE DECISIONS CONCERNING EXPANSION OF THE PATCO HIGH

SPEED LINE.

-- PROMOTE THE REDEVELOPMENT OF NAFEC AS AN INTERNATIONAL AIRPORT,

-- SOLVE PROBLEMS SUCH AS TRANSPORTATION IN ATLANTIC CITY ON A REGIONAL, NOT A LOCAL, BASIS.

IN ORDER TO MAKE NEW JERSEY GOVERNMENT MORE EFFECTIVE AND EFFICIENT, I RECOMMEND:

-- SPENDING CAPS ON INDEPENDENT MUNICIPAL AUTHORITIES AND OTHER INDEPENDENT AGENCIES SPENDING TAXPAYERS' MONEY.

-- LEGISLATION TO STRENGTHEN THE CREDIT RATING OF LOCAL SCHOOL DISTRICTS AS WE ALREADY HAVE WITH THE MUNICIPAL QUALIFIED BOND ACT.

-- CONTINUED CONSOLIDATION AND ELIMINATION OF EXCESS BOARDS, COMMISSIONS AND AUTHORITIES.

-- REORGANIZATION OF THE STATE ECONOMIC DEVELOPMENT PROGRAM, TO TARGET THAT PROGRAM TO AREAS OF UNEMPLOYMENT AND REHABILITATION NEED.

I URGE THAT NUCLEAR GENERATING PLANTS WHICH HAVE BEEN FOUND TO BE SAFE SHOULD BE ALLOWED TO OPERATE. WHERE ENVIRONMENTALLY POSSIBLE, MORE COAL SHOULD BE USED IN ELECTRIC GENERATING.

FURTHER, WE MUST TAKE ACTION PROMPTLY TO DIVERT MUCH OF THE GROWTH IN THE UTILITIES GROSS RECEIPTS TAX FOR STATEWIDE USES. WE HAVE DELAYED LONG ENOUGH IN TAKING THAT STEP.

THE SENATE HAS APPROVED A REASONABLE PLAN FOR REVISING THE UTILITIES GROSS RECEIPTS TAX.

I LOOK FOR EARLY ACTION BY BOTH HOUSES ON SUCH A PROPOSAL, SO MUNICIPALITIES CAN ADEQUATELY PLAN THEIR BUDGETS FOR THIS YEAR.

ALSO I AM DISAPPOINTED THAT WE HAVE NOT COME TO FINAL AGREEMENT ON A MEANINGFUL AUTO INSURANCE REFORM PROGRAM. THIS CAN AND SHOULD BE ACCOMPLISHED NOW ON A PRIORITY BASIS.

PEOPLE ARE PAYING HIGHER PREMIUMS; FEWER AND FEWER COMPANIES ARE WRITING POLICIES, AS WE LET THE SITUATION GO FROM WORSE TO "WORSER."

I DON'T BELIEVE THE LEGISLATIVE EFFORT THIS PAST WEEK ADEQUATELY ADDRESSED THE PROBLEM, AND I WILL NOT APPROVE LEGISLATION WHICH PRETENDS A SOLUTION WHICH IT DOES NOT REALLY ACCOMPLISH.

IN OTHER WORDS, IT DOESN'T DO THE JOB.

THE OUTGOING LEGISLATURE MADE AN EFFORT TO ADDRESS A VERY REAL SHORTFALL IN THE UPCOMING STATE BUDGET. I HAVE SIGNED THE CORPORATE TAX INCREASE.

THE ACTION TAKEN SO FAR, HOWEVER, IS NOT ADEQUATE TO MEET THE NEEDS OF OUR STATE AND WE FACE TOUGH DECISIONS IN THE UPCOMING BUDGET PROCESS.

I WILL ADDRESS THAT ISSUE IN THE BUDGET MESSAGE AT THE END OF THIS MONTH.

IN THE PAST, NEW JERSEY HAD A REPUTATION FOR FAILING TO COME TO GRIPS WITH ITS PROBLEMS.

THE STATE GOVERNMENT AND THE LEGISLATURE PROCRASTINATED AND FOUND EXCUSES FOR INACTION WHILE THE STATE LACKED ADEQUATE HOSPITALS, COLLEGES, AND OTHER FACILITIES.

THE STATE'S SENSE OF IDENTITY - AND OUR CONFIDENCE IN OURSELVES -SUFFERED AS WE SAW OUR RESIDENTS AND OUR CHILDREN GO OUT-OF-STATE FOR ESSENTIAL SERVICES.

YET IN THE LAST FEW YEARS WE HAVE DEALT WITH - AND TO A GREAT EXTENT - SOLVED PROBLEMS OF BASIC FISCAL REFORM, ENVIRONMENTAL PROTECTION, CRIMINAL LAW REVISION, WORKMEN'S COMPENSATION AND OTHER ISSUES WHICH FOR TOO LONG HAD BEEN DEFERRED.

I BELIEVE THAT THE DEBATE WHICH WE HAVE JUST EXPERIENCED IN THE CLOSING HOURS OF THE LAST LEGISLATURE SESSION NOW GIVES US A CRITICAL CHUICE. The state of the second second second second

THIS LEGISLATURE MUST CHOOSE WHETHER YOU WISH TO RETURN TO THE YEARS OF INACTION ON ESSENTIAL PROBLEMS WHILE WE ARGUE ABOUT FINANCES, OR DEAL WITH THESE ISSUES PROMPTLY AND DECISIVELY.

WE HAVE WORK TO DO ON PROBLEMS MORE IMPORTANT THAN TAXES.

NEW JERSEY HAS A CONTINUING CONCERN FOR THE POOR, THE ILL, AND THE YOUNG WHO HAVE NOT YET SHARED IN THE BENEFITS OF OUR SOCIETY. WE INITIATED THE LIFELINE PROGRAM IN 1979 WITH THE USE OF CASINO REVENUES TO HELP SENIOR CITIZENS AND HANDICAPPED CITIZENS STAY WARM IN THE WINTER.

IN 1980, I WILL SUPPORT A STATE CONSTITUTIONAL AMENDEMENT WHICH WILL ALLOW MORE FLEXIBLE USE OF CASINO REVENUES SO THAT THE FULL RANGE OF LEGITIMATE NEEDS OF SENIOR CITIZENS AND THE HANDICAPPED CAN BE ADDRESSED IN THE NEW DECADE.

AND FINALLY, NEW JERSEY NEEDS A TELEVISION STATION, WE NEED A VHF TELEVISION STATION IN THIS STATE.

THE CAVALIER ATTITUDE OF THE FCC ON THIS ISSUE BORDERS ON ARROGANCE. NEW JERSEY SHOULD BE SERVED BY A NEW JERSEY VHF TELEVISION STATION. PERIOD.

AND AS DIZZY DEAN ONCE SAID, "IT AIN'T BRAGGING, IF YOU DONE IT."
