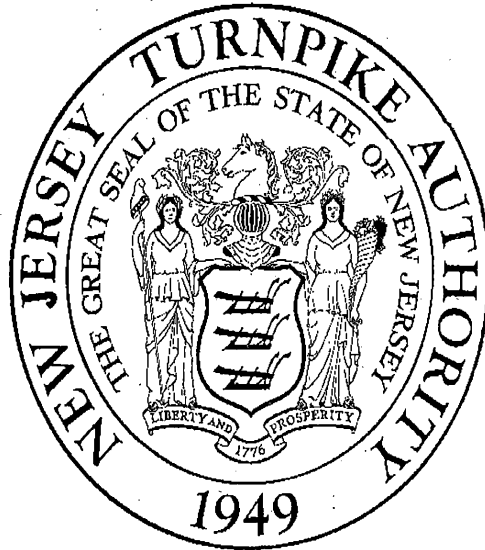

The property consists of 9,381 SF and is currently vacant and not within the vicinity of the Garden State Parkway travel lanes. Ocean County has formally requested to acquire the property as part of its geometric improvements project at the intersection of Double Trouble Road at GSP Ramps SBX 77 and SBE 77. The improvements are intended to alleviate vehicular accidents and improve safety. An Administrative Determination of Value has been prepared and the property has been certified by the various departments as surplus to the Authority's needs. Authorization of this item will allow the property to be disposed of pursuant to the Authority's regulations for the conveyance of surplus property, N.J.A.C. 19:9-2.6, and the Authority's By-Laws.

Following extensive discovery, negotiation, and mediation, the parties have reached an amicable settlement in the total amount of \$900,000.00, \$450,000.00 of which shall be paid by the Authority to fully resolve plaintiff's claims and avoid the cost and uncertainties of continued litigation.

Plaintiffs have undergone various medical treatment including surgical intervention and medical experts were retained to determine plaintiffs' severity of injury and the likelihood it would impair their quality of life. After engaging in mandated court settlement conference, the parties have reached an amicable settlement in the total amount of \$665,000.00 to fully resolve the plaintiffs' claims on a global basis and avoid the cost and uncertainties of continued litigation.

The Authority would like to dedicate the above referenced property to the County of Ocean. The property is approximately 782 feet long and 12 feet wide consisting of 9,381 SF (0.215 Acres). It is currently vacant and not within the vicinity of the Garden State Parkway travel lanes. The proposed dedication is a part of Block 23.07, Lot 2. Ocean County has formally made a motion to acquire the property as part of its geometric improvements project at the intersection of Double Trouble Road at GSP Ramps SBX77 and SBE 77. The improvements are intended to alleviate vehicular accidents and improve safety for local road traffic as well as Garden State Parkway patrons.

In accordance with the Authority's regulations for the sale of surplus property, N.J.A.C. 19:9-2.6, the Law Department has circulated information regarding the Property to the Chief Engineer, the Director of Operations, the Chief Information Officer (ITS), and the Authority's Engineering Consultant for review. Each has reviewed information regarding the Property, and all have certified that the Authority does not require the Property and does not see any future use of the Property by the Authority. An Administrative Determination of Value has been prepared for the parcel.

Accordingly, it is recommended that authorization be given to declare the Property surplus to the Authority's needs. It is further recommended that the Executive Director be authorized to take any steps necessary to dedicate the property to the County of Ocean, in accordance with the Authority's regulations for the conveyance of surplus property, N.J.A.C. 19:9-2.6, and the Authority's By-Laws. It is further recommended that the Authority's Commissioners authorize the Executive Director to execute any other documents and take any other actions as are deemed necessary to effectuate the intent of this authorization.

To fill the vacancy created by the employee retirement and comply with the Plan, it is requested that the Authority's Deputy Chief Financial Officer Erwin Luna, be appointed to the Committee to fill the vacancy.

This matter arises from a motor vehicle accident that occurred on April 7, 2021, in the city of Trenton, involving a State Trooper assigned to Troop D. At the time, the Trooper was operating a vehicle owned by the Authority but had been temporarily assigned to a different unit on the above date.

The Trooper was in pursuit of another vehicle and collided with plaintiff's vehicle, causing the plaintiff to sustain injuries. Since the incident, the plaintiff has undergone significant medical treatment, reports a substantial impact on quality of life, and is currently unable to work. Because the Trooper was not assigned to the Authority at the time of the accident the Authority and Office of the Attorney General entered into a mutual agreement that if the matter was to be resolved via settlement the parties would share that responsibility equally.

The parties participated in a court ordered settlement conference, resulting in a settlement in principle of \$900,000.00. Following settlement discussion and an assessment of the risks, costs, and uncertainties inherent in continued litigation, it is recommended that the Board authorize settlement authority in the amount of \$450,000.00, representing the Authority's half of the settlement. While the Authority maintains defenses regarding liability and damages, this settlement mitigates potential litigation exposure and avoids the additional expenses and resource commitment associated with continued litigation and trial.

As such, the Law Department requests the Board of Commissioners approve this settlement pursuant to the terms set forth above and authorize the Executive Director to execute any and all documents and take all necessary steps to fulfill the intent and purpose of this settlement.

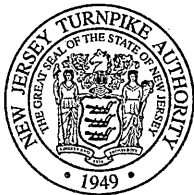

Following mediation, the parties agreed to a global settlement in the amount of \$900,000.00, to be divided evenly between the two (2) plaintiffs, subject to approval by the Board of Commissioners. While the Authority maintains defenses regarding liability, this settlement mitigates potential litigation exposure and avoids the additional expenses and resource commitment associated with continued litigation and trial.

RE: Authorization to Enter into a Memorandum of Understanding with the Department of Law and Public Safety, New Jersey State Police Regarding the Installation, Maintenance and Data Sharing of Automatic License Plate Readers on the Garden State Parkway and New Jersey Turnpike

On October 21, 2022, the Office of the Attorney General issued Attorney General Law Enforcement Directive No. 2022-12 (the "Directive") updating guidelines for the State of New Jersey ("State") on use of automated license plate recognition ("ALPR") technology and the data it generates.

As defined by the Directive, ALPR is technology that uses optical character recognition on images to read vehicle registration plates to create vehicle location data. ALPR devices may be placed at a stationary location (permanent or portable) or be mobile and affixed to a police vehicle. The vehicle location data captured by an ALPR device is (1) used to alert law enforcement to vehicles they have a legitimate and specific reason to locate, and (2) stored so that law enforcement may perform searches to further subsequent investigations. The Directive includes several major revisions to the State Policy in the areas of oversight, sharing and standardization of data, retention period, release of ALPR data, audits, and training.

Throughout the State, the New Jersey State Police ("NJSP") and partner law enforcement agencies are strategically installing ALPR to help make transit and travel in the State safer for all the State's citizens and visitors. NJSP may cooperate with any other State or local authority regarding criminal justice efforts pursuant to N.J.S.A. 53:2-1. Coordination with other agencies is governed by the Directive.

The New Jersey Turnpike Authority ("NJTA") is the owner and operator of the New Jersey Turnpike and Garden State Parkway (the "Roadway") and has an interest in providing safe transit and travel for all persons traveling on the Roadway.

Accordingly, NJTA and NJSP intend to cooperate to jointly identify certain locations along the Roadway and other portions of NJTA property as strategic locations to install ALPR, and wish to memorialize that cooperative effort via a Memorandum of Understanding (the "MOU").

The principal terms of the MOU are as follows:


- 1) NJTA will allow NJSP law enforcement access and use of NJTA ALPR data, specifically deployed pursuant to the terms of the Directive;
- 2) NJSP will provide preferred locations for ALPR installation to NJTA. NJTA will investigate each potential installation site and, if a site is approved by NJTA at its sole discretion, NJTA will allow for installation of an ALPR;
- 3) NJTA reserves the right to remove any ALPR (a) based on its planning and/or engineering needs or (b) as a result of an emergency such as a knockdown or accident;
- 4) NJTA will provide NJSP with law enforcement access and use of all ALPR data captured from NJTA-owned equipment. Any ALPR data shared pursuant to this Agreement shall be used and shared through NJ Statewide Networked ALPR Program and only as permitted by the Directive;
- 5) NJSP will utilize ALPR for purposes of toll evasion enforcement through both Troop D and other law enforcement agencies with whom ALPR data is shared;
- 6) The Term of this Agreement shall commence upon execution of the MOU and shall remain in effect through December 31, 2033.

In view of the foregoing, the Board is respectfully requested to authorize and direct the Executive Director (i) to execute an MOU by and among NJTA and NJSP in a form substantially in accord with the above terms, and (ii) to take any other actions as may be necessary to implement the MOU. A copy of the MOU, when executed, will be provided to the Board.

RE: Authorization for the Executive Director to Renew the Authority's Public Officials and Employment Practices Liability Insurance Program for one (1) additional year (April 15, 2026 to April 15, 2027)

Amount: not to exceed: \$550,000

The Authority maintains Public Officials and Employment Practices Liability insurance with total limits of \$30 million, the policies for which will expire on April 15, 2026. Willis Towers Watson, the broker of record for this coverage, was tasked with providing three (3) competitive quotations for coverage as expiring. After review by the Authority and BGIA, the Authority's insurance and risk management consultant, it is recommended that the policies be renewed using the most favorable combination of quotations, considering price and quality of coverage, as follows: the primary \$10 million limit with Chubb; the second \$10 million limit excess of the initial \$10 million with Fair American; and the final \$10 million excess of \$20 million with Ironshore, the combination of which will provide a total of \$30 million in limits. As the premiums for each layer are still being negotiated, final premium amounts and mandatory surcharges are not yet finalized but will not exceed \$550,000. All renewal layers will include Terrorism Risk Insurance Act (TRIA) coverage.

It is therefore requested that the Commissioners authorize the Executive Director to renew the insurance policies and coverage as outlined above. It is further requested that the Commissioners authorize the Executive Director to take all such actions and to execute all such documents after review and with the recommendation of the Law Department to effectuate the authority set forth above.





This contract will provide for the elimination of at-grade median barrier openings from Milepost 1.5 to Milepost 39.9, and construction of U-Turn bridges at Mileposts 6.40 and 19.00 in Salem, Gloucester, and Burlington Counties, New Jersey. The work also includes bridge reconstruction at Structure Nos. 38.68 and 38.90, median barrier reconstruction, drainage, and roadway improvements. It is therefore recommended that Contract No. T100.723-1 be awarded to the low bidder, South State, Inc. of Bridgeton, New Jersey in the amount of \$43,570,090.80. Bids for this work were procured, and the authorization being sought is to award this fair and open contract to the lowest responsible bidder, in accordance with N.J.S.A. 27:23-6.1, N.J.A.C. 19:9-2.2, and Executive Order No. 37 (Corzine 2006).

The General Consultant assigned to this contract, HNTB Corporation, concurs with this recommendation.

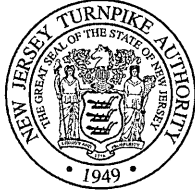

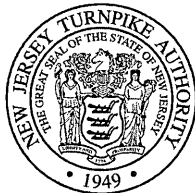

This contract, managed by the Operations Department, will provide for repairs of drainage structures and underground facilities within the Authority right-of-way on the New Jersey Turnpike from Milepost 0 to 122 and on the Garden State Parkway from Milepost 0 to 172.4. The immediate and scheduled repairs will be as directed by the Engineer, by work orders, for a period of two years with an option for two one-year extensions at the sole discretion of the Authority.

Six bid proposals were received on February 20, 2026, for the above publicly advertised contract, as shown on the attached bid summary sheet. The low bid proposal from Joseph M. Sanzari, Inc. of 2.50% is significantly lower than the Engineer's Estimate of 10.00%. These percentages represent a weighted average mark-up on the Contractor's time and materials cost of performing the work. Operations Department representatives confirmed with the low bidder that they can perform the contract with its percentage. Joseph M. Sanzari, Inc. has previously performed work for the Authority and is considered competent to complete this contract.

It is therefore recommended that Contract No. A200.910 be awarded to the low bidder, Joseph M. Sanzari, Inc., of Hackensack, New Jersey in the amount not to exceed \$10,000,000.00. Bids for this work were procured, and the authorization being sought is to award this fair and open contract to the lowest responsible bidder, in accordance with N.J.S.A. 27:23-6.1, N.J.A.C. 19:9-2.2, and Executive Order No. 37 (Corzine 2006).

The General Consultant, HNTB Corporation, concurs with this recommendation.

In accordance with the New Jersey No Net Loss Reforestation Act (N.J.S.A. 13:1L-14.1 et seq.), the Authority is required to provide mitigation for the deforestation at this location. After substantial review and analysis, the Authority and the NJDEP have determined that mitigation in the form of monetary compensation is acceptable.

It is therefore recommended that the Executive Director be authorized to execute any and all documents necessary to effectuate the payment to NJDEP not to exceed the amount of \$498,300.00 for the purposes set forth above. The New Jersey Turnpike Authority issued a request for qualifications ("RFQ") for one or more firms to provide the following real estate professional services: 1) Real Estate Consultants; 2) Certified and Licensed Appraisers; 3) Licensed Professional Planners; and 4) Relocation Consultants. The intent of the RFQ was to develop a pool of qualified real estate professionals from which the Authority could draw for diverse real estate services. Standard rates and fees were set forth in the RFQ.

On December 2, 2025, the RFQ was advertised in the Asbury Park Press, nj.com and posted on the Authority's and the State's websites. In addition, the 43 firms listed in the Authority's database for the referenced services were notified of the procurement. On January 12, 2026, qualifications or responses were received from 13 firms for the following services:

An Evaluation Committee (the "Committee"), which was approved by the Executive Director, consisted of personnel from the Authority's Engineering and Law Departments. One non-voting member from the Procurement and Materials Management Department also served on the Committee. The Committee reviewed the proposals based on the criteria set forth in the RFQ and detailed its recommendations in an Evaluation Report. As set forth in the Evaluation Report, the Committee recommends that the following contracts be awarded:

Real Estate Consultants

The Authority utilizes Real Estate Consultants to participate in negotiations regarding real estate acquisitions and sales, to provide consultation and advice regarding various Authority matters related to real estate acquisitions, appraisals, sales, eminent domain proceedings, and tax appeals, and to assist the Authority generally in managing the right-of-way acquisition for its various roadway improvement projects. Two (2) proposals were received for Real Estate Consultants.

Based on the Authority's expected needs for the next several years, the Committee recommends that contracts for Real Estate Consultant services be awarded to both proposers CW Solutions, Inc. and Greystone Select Incorporated d/b/a Greystone Real Estate Advisory Group. The proposals from those two (2) firms provided concise, responsive proposals and clearly set forth their approach to providing quality services.

Certified and Licensed Appraisers

The Authority utilizes certified and licensed appraisers to provide appraisal services and draft appraisal reports. In particular, the Authority may require assistance from certified and licensed appraisers during condemnation proceedings and property tax appeals. Throughout the term of the contract, the Authority anticipates a large volume of appraisal work that will be spread geographically throughout the State of New Jersey. Nine (9) proposals were received for Certified and Licensed Appraisers.

In light of the need for several Certified and Licensed Appraisers to meet the substantial needs of the Authority, the Committee recommends that a contract for Certified and Licensed Appraiser services be awarded to the top six (6) firms. Steven W. Bartelt Real Estate Appraisal Consultants, Sterling DiSanto & Associates, LLC., Greystone Select Incorporated d/b/a Greystone Real Estate Advisory Group, Meehan Valuation, Wade Appraisal, LLC., and Molinari & Klauder, Inc.

The amount of work anticipated by the Authority due to the five (5) year capital improvement project initiated in 2021, and the other projects involving right of way, clearly justify having a large number of appraisers on call due to the potential for conflicts and for any other issues that may arise.

Licensed Professional Planners

The Authority utilizes Licensed Professional Planners to provide professional planning reports, oral testimony and/or advisory services as required in conjunction with various Authority projects. Three (3) proposals were received for Licensed Professional Planners.

The Committee has determined that based on the anticipated planning needs of the Authority and the projected amount of condemnation proceedings that may arise due to the five (5) year capital improvement project initiated in 2021, it would be prudent to contract with several Licensed Professional Planners to ensure that all the Authority's needs in the planning area are met. Therefore, the Committee recommends that a contract as a Licensed and Professional Planner be awarded to each of the three (3) firms, Clarke Caton Hintz, PC, Johnson, Mirmiran & Thompson Inc., and Topology NJ, LLC. All three (3) firms demonstrated their capacity to perform the Services based upon their relevant experience and project teams.

Relocation Consultants

The Authority utilizes Relocation Consultants to participate in the planning and development of relocation programs, to manage and coordinate the relocation process, and to provide consultation and advice regarding various Authority matters related to relocation needs, housing sales, household goods movement needs, temporary housing, and any other relocation needs that may arise. One (1) proposal was received for Relocation Consultants.

Based on the Authority's relocation needs, the Committee recommends that a contract for Relocation Consultant services be awarded to Johnson, Mirmiran & Thompson Inc. This firm has very strong experience and demonstrated a quality approach to providing services.

The procurement process for this professional services contract was conducted in accordance with *N.J.S.A. 27:23-6.1* of the Authority's enabling legislation, *N.J.A.C. 19:9-2.9* promulgated pursuant thereto, and Executive Order No. 37 (Corzine 2006) and having no objection to same.

Accordingly, authorization is requested to award contracts to each of the firms as stated above in an aggregate amount not to exceed \$1,250,000.00 for all of the Authority's Real Estate Professional Services. Each firm shall be compensated at the rates set forth in the RFQ. It is requested that the Executive Director be authorized to execute any and all documents that may be deemed necessary and appropriate to further the intent and purpose of the authorizations stated herein.

The New Jersey Turnpike Authority ("Authority") is the lead agency of the New Jersey E-ZPass Group, whose members operate and maintain its independent toll collection and host systems that interface with the New Jersey E-ZPass System. The New Jersey E-ZPass Group consists of the Authority, the South Jersey Transportation Authority, the Delaware River Port Authority, the Delaware River and Bay Authority, the Delaware River Joint Toll Bridge Commission, the Burlington County Bridge Commission, and the Cape May County Bridge Commission.

At the September 29, 2015, Board of Commissioner's Meeting, the Authority awarded Agenda Item No. 398-09-2015, "New Jersey E-ZPass Customer Service Center, Violations Processing, and Financial Back Office Services Contract, to Xerox State & Local Solutions" (now doing business as Conduent State and Local Solutions, Inc. ("Conduent")), in the amount of \$325,600,000. The procurement process for this professional services contract was conducted in accordance with N.J.S.A. 27:23-6.1 of the Authority's enabling legislation, N.J.A.C. 19:9-2.9 promulgated pursuant thereto, and Executive Order No. 37 (Corzine 2006).

Figure 1 - New Jersey Turnpike Vehicle Mileage Traveled and Total Crash Rate by Month

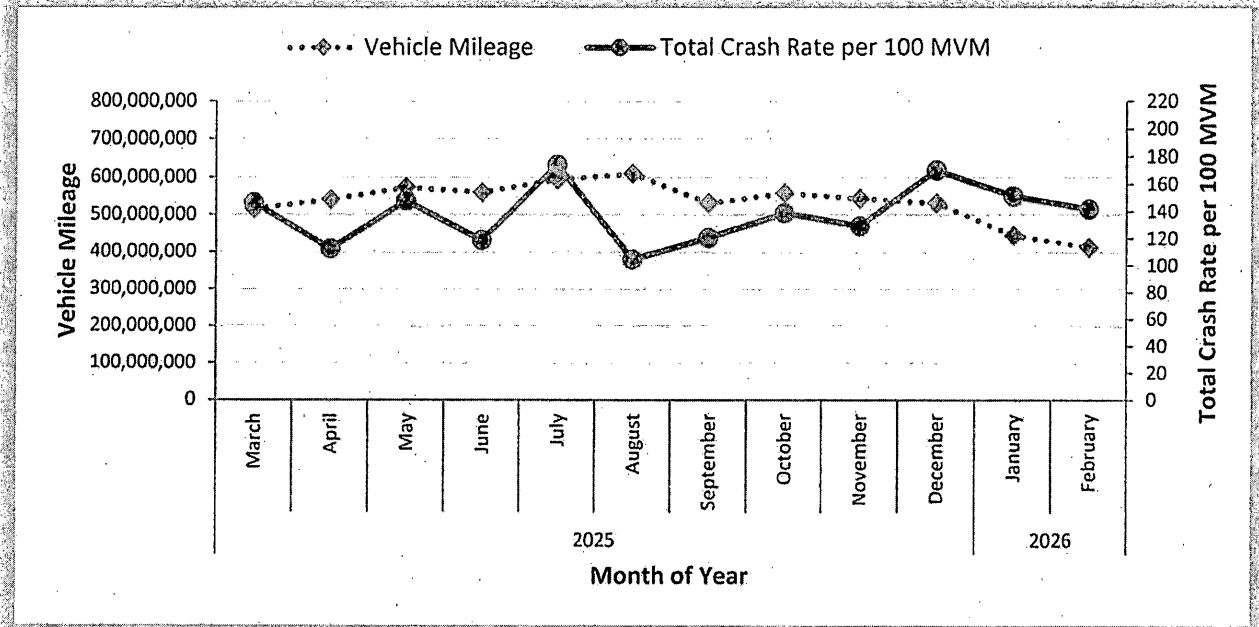
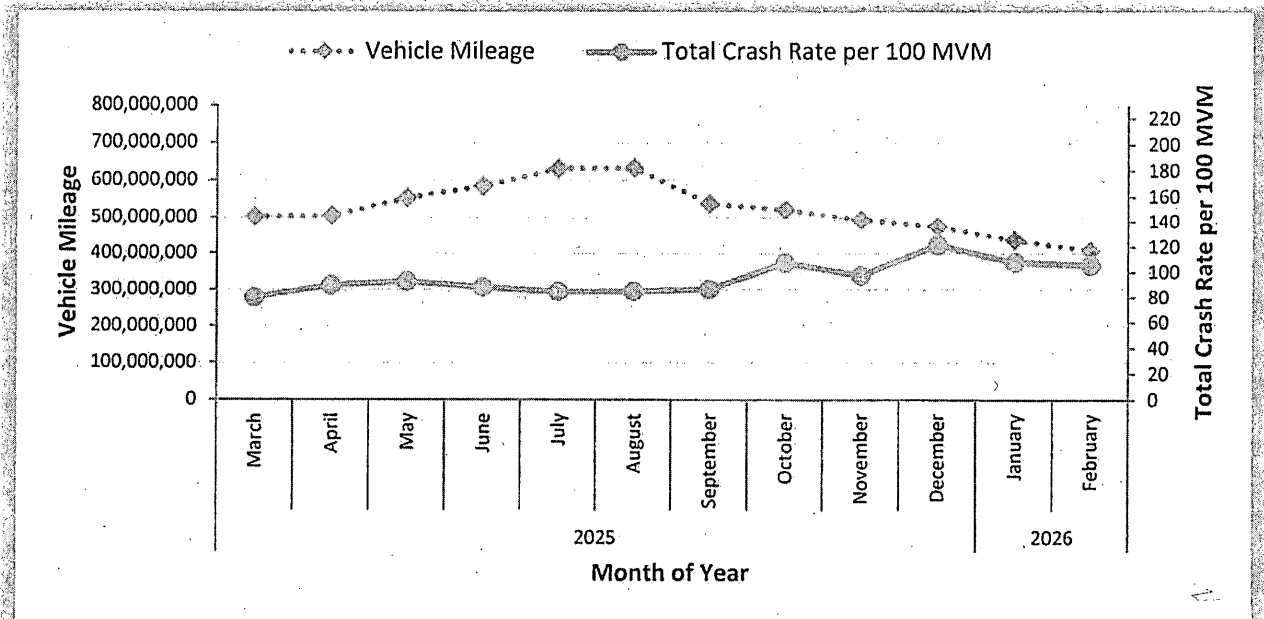


Figure 2 - Garden State Parkway Vehicle Mileage Traveled and Total Crash Rate by Month

Figure 3 - New Jersey Turnpike Injury and Property-Damage-Only Crashes by Month

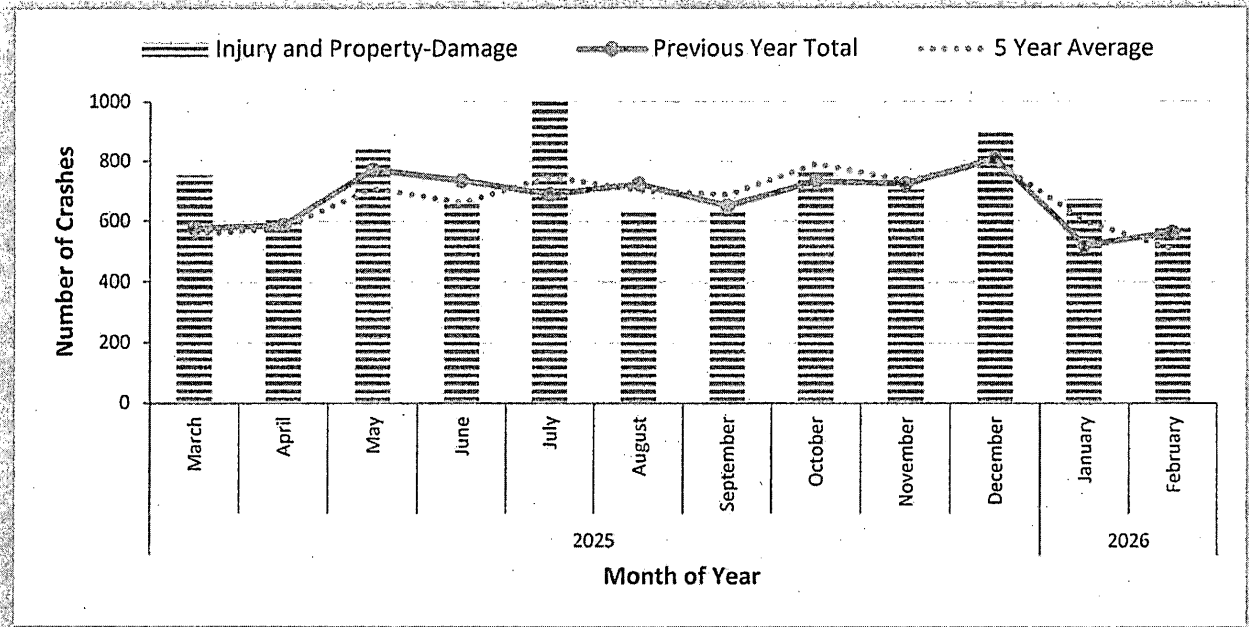
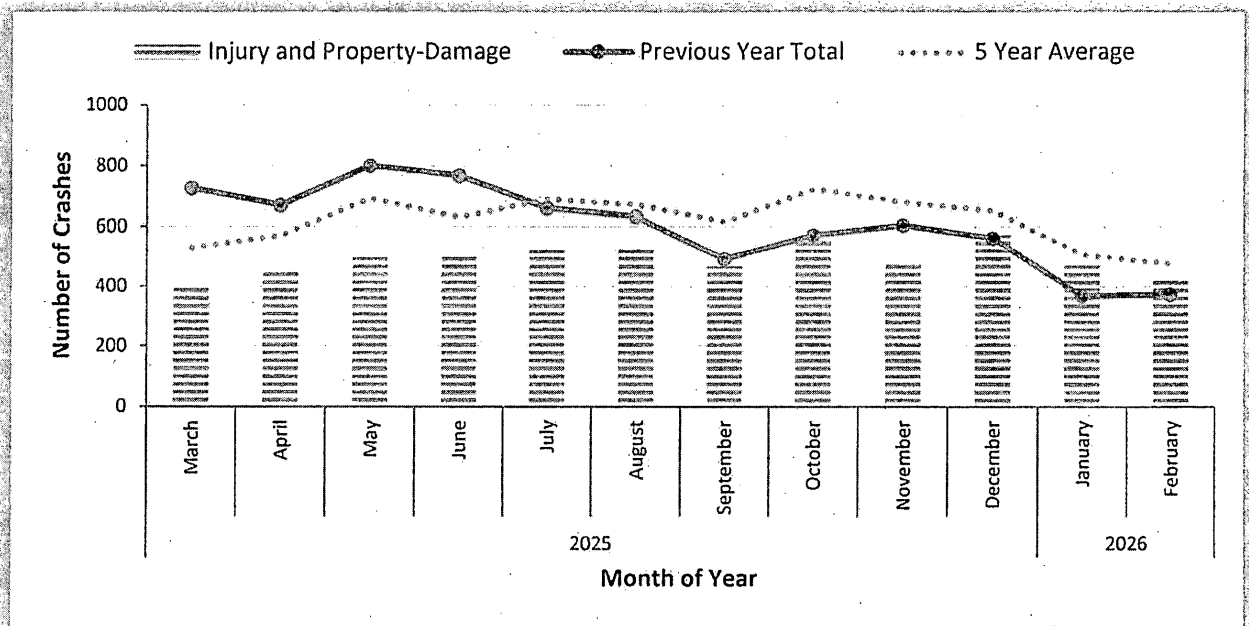


Figure 4 - Garden State Parkway Injury and Property-Damage-Only Crashes by Month

The following un-audited results are for the two months ended February 28, 2026.¹ Based upon these results, revenues will be sufficient to satisfy the requirements of the Authority's Bond Resolution. For the twelve months ending December 31, 2026, the Authority is projected to have a debt service coverage ratio of 2.02 and a total requirements coverage ratio of 1.54.

The Authority's total revenue for the two months ended February 28, 2026, was \$401,374,000, which is \$4,226,000, or 1.0% below the 2026 year-to-date budget. Toll revenue was \$331,961,000, which is \$11,439,000, or 3.3%, below the 2026 year-to-date budget. Toll revenue was below budget due to the impact of five snow-related weather events, including two declared State of Emergencies. Gas prices averaged \$0.21/gallon lower in 2026 compared to the same period in 2025, and when compared to January 2026, gas prices in February increased \$0.06/gallon. Investment income was \$3,224,000, or 22.9%, above budget due to higher invested balances. Fees were \$2,479,000, or 9.5% above the budget, due to a change in projected trends.

For the two months ended February 28, 2026, toll transactions on the New Jersey Turnpike decreased 3.2% and toll revenue decreased 0.7% compared to the same period in 2025. The decrease in toll transactions and revenue is primarily attributable to severe winter weather. The 2026 traffic and toll revenue budgets are based on the Authority's traffic engineering consultant's (CDM Smith) New Jersey Turnpike System 2025 Draw Down Letter dated April 29, 2025. CDM Smith projected a 0.5% increase in traffic and a 2.6% increase in revenue as compared to the prior year. The actual results for the two months ended February 28, 2026, were below both CDM Smith's traffic and toll revenue projections. Through February 2026, the E-ZPass usage rate on the New Jersey Turnpike was 93.9%, an increase from 93.6% for the same period in 2025.

For the two months ended February 28, 2026, toll transactions on the Garden State Parkway decreased 2.5%, while toll revenue increased 0.8% when compared to the same period in 2025. The decrease in toll transactions is primarily attributable to severe winter weather. The increase in toll revenue was driven mainly by the 3% annual toll rate indexing, which went into effect on January 1, 2026. CDM Smith projected a 2.3% increase in traffic and a 4.6% increase in revenue as compared to the prior year; however, actual results for the two months fell short of both traffic and revenue projections. Through February 2026, the E-ZPass usage rate on the Garden State Parkway was 92.5%, an increase from 91.9% for the same period in 2025.

Operating expenses for the two months ended February 28, 2026, was approximately \$123,902,000, which is \$8,974,000 or 6.8% below the year-to-date budget. The Authority's operating expenses through February were below budget, mainly due to lower salaries from existing vacancies. This was partially offset by higher costs for state police troopers. The Authority spent a total of \$44,956,000 on snow and severe weather costs in 2026, with \$12,337,000 spent from the operating expense budget and an additional \$32,619,000 spent from the General Reserve Fund. All snow and severe weather costs are considered operating expenses and paid from the Revenue Fund, except for extraordinary weather events, which are charged to the General Reserve Fund. New Jersey had two declared State of Emergency events as of February 2026. When excluding snow/severe weather costs and its budget, operating expenses for the two months are 6.6% below budget for 2026.

Debt Service includes interest and principal payments on the Authority's outstanding bonds and is funded primarily through revenue and to a much lesser extent bond proceeds (capitalized interest). For the two months ended February 28, 2026, Debt Service totaled \$171,376,000, which meets the budget. Debt service through February included \$102,708,000 in interest payments and \$68,668,000 in principal payments. Net debt service (funded from revenue, net of capitalized interest) was \$160,875,000 for the two months and meets the budget. The 2026 annual debt service budget includes approximately \$965,250,000 of debt service funded from revenue (net debt service), and the remaining \$104,677,000 of debt service funded from bond proceeds (capitalized interest), for a total debt service budget of \$1,069,927,000.

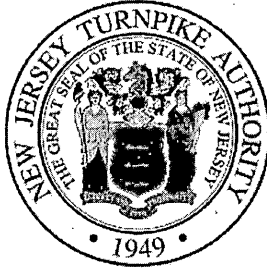

**Financial Summary
For the Two Months Ended February 28, 2026**

The General Reserve Fund includes all contractual payments subordinate to bondholders and expenditures for any other corporate purpose. The General Reserve Fund spending totaled \$134,665,000 for the two months ended February 28, 2026, which was \$17,236,000, or 14.7% above the year-to-date budget due to State of Emergency snow events in January and February 2026. Spending consisted primarily of \$82,474,000 for the New State Transportation Funding Agreement, \$32,620,000 for Extraordinary Events, and \$3,667,000 for Transportation Trust Fund. Also included are \$8,382,000 in transfers to the Supplemental Capital program.

The Capital Budget, which is funded by revenue, consists of the Maintenance Reserve Fund, Special Project Reserve Fund, and the Supplemental Capital Program. For the two months ended February 28, 2026, total expenditures were approximately \$22,939,000, which was 44.3% of the 2026 year-to-date spending budget. Expenditures included \$2,811,000 for TPK Bridge Repairs along Mileposts 0-92 PHM, \$1,430,000 for Major Sign and Safety OPS (2024), and \$1,134,000 for TPK Pavement Resurfacing across Various Locations (2024). In addition to these expenditures, there are open commitments totaling approximately \$403,451,000.

The Construction Fund, which is funded from bond proceeds, consists of the 2026-2030 Capital Improvement Program and the 2019 Capital Improvement Program. For the two months ended February 28, 2026, total expenditures were approximately \$31,727,000, which was 31.2% of the 2026 year-to-date spending budget. Total expenditures include \$4,146,000 for TPK Interchange 17 Ramp Bridge Replacements, \$3,196,000 for Roadway Improvements along Mileposts 97.1-98; 102-104.5, and \$2,606,000 for TPK Deck Rehabilitation along Mileposts E113.0-E115.21. In addition to these expenditures, there are open commitments totaling approximately \$1,721,023,000.

WHEREAS, Mr. O'Connor used the vast knowledge and skill he acquired during that distinguished career and the lessons he learned along the way to the benefit of customers of the New Jersey Turnpike Authority and, indeed, all New Jersey residents; and

WHEREAS Mr. O'Connor kept safety at the center of every decision he made as Chair of the Turnpike Authority and demonstrated his commitment to that cause by leading the Target Zero Commission, a body with the ambitious goal of eliminating roadway fatalities and serious injuries by 2040; and
