# Affordable New Jersey Communities for Homeowners and Renters (ANCHOR)

This program provides property tax relief to New Jersey residents who owned or rented their principal residence (main home) on October 1, 2019, and met the 2019 gross income limits. (Homeowners \$250,000 and Renters/Tenants \$150,000)

Filing deadline was February 28, 2023.

**We are currently issuing 2019 ANCHOR benefits.** ANCHOR benefits will be paid in the form of a direct deposit or check, not as credits to property tax bills.

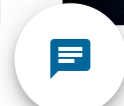
