# SETTLEMENT OF CLAIM – JOSEPH REDMOND V. PORT AUTHORITY TRANS-HUDSON CORPORATION, ET AL.

It was recommended that the Board authorize Counsel, for and on behalf of Port Authority Trans-Hudson Corporation (PATH), to enter into an agreement with plaintiff Joseph Redmond (Plaintiff) to provide for the settlement of a claim for personal injuries sustained by paying Plaintiff a sum of \$150,000, and waiving a medical lien in the sum of \$25,244.54 and a wage lien in the amount of \$30,506.20, for a total settlement value of \$205,750.74.

On May 5, 1999, Plaintiff, then a PATH Tower Operator, was attacked at the Journal Square Transportation Center while entering the building through a door on the plaza that led to the employee locker room, when he was confronted by an unknown man wielding a knife. The man demanded money from Plaintiff, and while running away, Plaintiff lost his balance and fell down the stairs, landing on his left side. Following the incident, an inspection by the maintenance staff and Port Authority Police revealed that paper had been stuffed in the bar mechanism of the door, thereby jamming the door's locking mechanism.

Plaintiff was diagnosed as having suffered a medial meniscal tear of the left knee. Arthroscopic surgery of the left knee was performed on September 17, 1999 to repair this injury. Arthroscopic acromioplasty of Plaintiff's left shoulder was performed on February 24, 2000. Plaintiff also underwent therapy with a psychiatrist for resulting nightmares, stress and emotional upset. On January 10, 2000, the Office of Medical Services determined that Plaintiff was unable to perform the duties of a Tower Operator. As a result, he retired and began receiving a Railroad Retirement Board pension.

Pursuant to the foregoing report, the following resolution was adopted with Directors Blakeman, Coscia, Pocino, Sartor, Silverman, Sinagra, Song and Steiner voting in favor; none against:

**RESOLVED**, that Counsel be and he hereby is authorized, for and on behalf of Port Authority Trans-Hudson Corporation (PATH), to enter into an agreement with plaintiff Joseph Redmond to provide for the settlement of a lawsuit for injuries sustained entitled <u>Joseph Redmond v. Port Authority Trans-Hudson Corporation</u>, et al. by paying plaintiff the sum of \$150,000 and waiving wage and medical liens totaling \$55,750.74. In exchange, PATH and the Port Authority will receive a general release from liability and a stipulation of dismissal of the action, with prejudice.
