**DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS
SEPTEMBER 2011**

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Statistics.

WFNJ/TANF

- As of the end of September, the TANF caseload had increased by 1,154 cases, from 40,257 in September 2010 to 41,411 in September 2011, a 2.9% increase.
- The counties with the highest family caseload percentage increase since September 2010 include Ocean (17.2%), Passaic (15.4%), and Atlantic (14.0%).
- The counties with caseloads that decreased since September 2010 were Hunterdon (-4.9%), Cumberland (-5.1%), and Monmouth (-9.7%).
- Of the WFNJ/TANF cases, 9,111 or 22.0% were child-only in September 2011.
- The counties with the most child-only cases were Essex (1,564), Hudson (1,178), and Camden (1,122).
- Essex (23,084), Hudson (12,082), Camden (11,878), and Passaic (11,878) counties had the greatest number of persons receiving TANF in September 2011.

NJ SNAP (formerly FOOD STAMPS)

- In September 2011, there were 400,614 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 65,038, or 19.4%, since September 2010.
- There were 821,915 persons receiving NJ SNAP benefits as of September 2011, an increase of 137,387 or 20.1% since September 2010.
- The three counties having the highest caseload increase since September 2010 are Sussex (37.4%), Atlantic (35.2%), and Passaic (27.9%).

EMERGENCY ASSISTANCE

- There were 7,158 families receiving Emergency Assistance (EA) in September 2011, an increase of 768 or 12.0% since September 2010.
- In September 2011, EA payments were made for 1,530 SSI recipients.

GENERAL ASSISTANCE

GA Emergency Assistance

- There were 7,423 Emergency Assistance payments made to GA cases in September 2011, a decrease of 970 or 11.6% since September 2010.
- The three counties that show an annual percent increase in emergency assistance payments are Monmouth (207.8%), Passaic (41.0%), and Ocean (17.8%).

GA Program

- The total numbers of cases receiving GA has decreased from 53,899 to 48,291 since September 2010, a decrease of 10.4%.
- There were 34,050 Employable GA and 14,241 Unemployable GA cases in September 2011.
- Cape May (7.0%), Ocean (2.5%), and Gloucester (2.2%) counties showed the highest percent increase for GA cases since September 2010.

CHILD SUPPORT SERVICES (Quarterly Report)

- The total collection for the Child Support Services Program was about \$305 million from July 2010 to September 2011, an increase of 2.2 percent over the same period for FFY 2010.
- Total distributions increased over 2.3% from September 2010.


WORK FIRST NEW JERSEY (WFNJ)

- During the report month of September 2011, there were 4,251 families in which at least one member was employed and an additional 540 families whose WFNJ assistance cases were closed due to employment - related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (1,048), Hudson (503), and Camden (445).
- There were 3,257 former TANF cases receiving post-TANF support in the form of child care assistance.





Ending With SEPTEMBER 2011**






SEPTEMBER 2009 THROUGH SEPTEMBER 2011 (STATEWIDE)**





SEPTEMBER 2011 By County








ACRONYMS

CASS: Consolidated Assistance and Support System

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is in an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
