



What They're Saying:
Governor Christie's Fairness Formula "is a win-win for students and for taxpayers"

Mike Proto, Communications Director for Americans For Prosperity: "The governor's new approach is a win-win for students and for taxpayers. Instead of a system which today sends 60% of school aid dollars - more than \$9 billion - to just 31 of New Jersey's 577 school districts, the governor's plan values every student the same by giving each the same amount in aid." George Kneisser, Executive Director of NJ Citizens for Property Tax Reform: "Our organization is in full support of your plan to distribute school aid equally across all of New Jersey, on a per student basis. The existing system of relying on property taxes is inherently unfair and is causing homeowners to lose their homes through tax liens or in the case of many adult communities, leave New Jersey because of high property taxes. How can someone ask struggling homeowners to keep paying, through their property taxes, for other kids' education, when they can't even afford to pay their own property taxes? Instead of focusing on the needs of the ones who are constantly receiving enormous amounts of aid, the critics of your plan should instead focus on the struggle and suffering of the homeowners. Their claim of depriving poor kids is just pure bogus." (Statement, 6/28/16)

Somerset County Freeholder Brian Levine: "The bottom line is that, with Governor Christie's Fairness Formula, more money comes to the deserving school children in Franklin from the State of New Jersey and my overburdened taxpayers get to put over \$1,200 back into their pockets. As a CPA, I appreciate the analysis- Franklin students will receive an additional \$35 million from the State and my residents pocket the savings.
