Messrs. Ahern III, Getz, Goheen were present. Messrs. Bartle, Browne, Buttermark, Chadwick, Leeds and Onofrio were not present.

Mr. Babb reminded the Council that lease renewals begin on October 15 of each year. As per the leasing regulations, N.J.A.C. 7:25-24.8, shellfish leases must be renewed annually by December 31st for the following year. If illness or extenuating circumstances had prevented a lessee from renewing their lease(s) by December 31st, the Council may extend the payment deadline by one month provided the request was made at the January meeting. On a motion by Mr. Maxwell and a second by Mr. Johnson, the Council granted a 30 day extension to Messrs. Ahern III, Getz and Goheen to renew their leases.

## Old Business:

Atlantic Coast Section – Leasing Committee Update

Mr. Babb discussed that the Atlantic Coast Shellfisheries Council's Leasing Committee met on January 7, 2015. Mr. Babb stated that it was a productive meeting. Two subcommittees were formed (Regulation and Policy committees).

# 8. <u>New Business</u>:

## NJDEP's Bureau of Marine Water Monitoring (BMWM)

Water Classification Changes

Mr. Friedman discussed the 2015 Shellfish Water Classification changes. A Public Notice was posted on January 9, 2015 of the Suspension of Harvest from Shellfish Beds Dangerous to Health in the Navesink River, Upper Barnegat Bay and Ludlam Bay.

#### N.J.A.C. 7:12

Mr. Friedman stated that the BMWM had been working to resolve outstanding issues and proposed changes to the Shellfish Growing Water Classification rules at N.J.A.C. 7:12. The primary goals of the potential rule amendments were to rectify deficiencies identified by the U.S. Food and Drug Administration's 2014 Annual Program Evaluation Report of New Jersey's Shellfish Program.

#### 2015 Vibrio Season

Mr. Friedman discussed New Jersey's Vp Management Plan. The changes for the 2015 Vp season would be a shift in the timeframes for harvest (no reduction in hours).

7 hr. harvest June 1st – June 14th

6 hr. harvest June 15th- July 14th

7 hr. harvest July 15th – July 31st

7.5 hr. harvest August 1st- August 31st

## Lease Staking

Mr. Prichard stated that an adjacent lease was not properly staked. Mr. Prichard explained that recreational clammers were encroaching on his lease. The Council recommended that Mr. Prichard contact Marine Enforcement regarding this issue.

## 2012 Barnegat Bay Hard Clam Stock Assessment

Ms. Dacanay from the Bureau of Shellfisheries stated that the results of the 2012 hard clam stock assessment of Barnegat Bay indicated that there was an approximate 25% decline in the 2012 stock compared to the 1985/86 stock estimate. Ms. Dacanay would provide a more detailed presentation at the next Council meeting.
