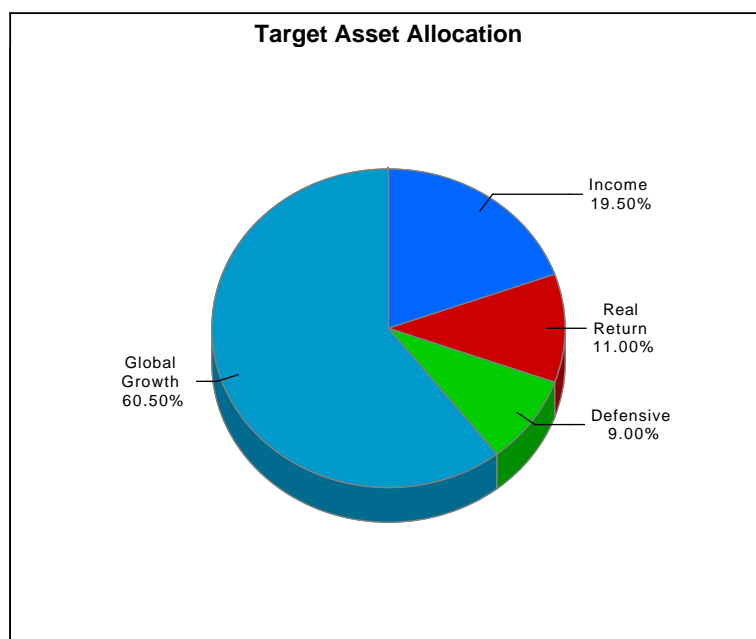
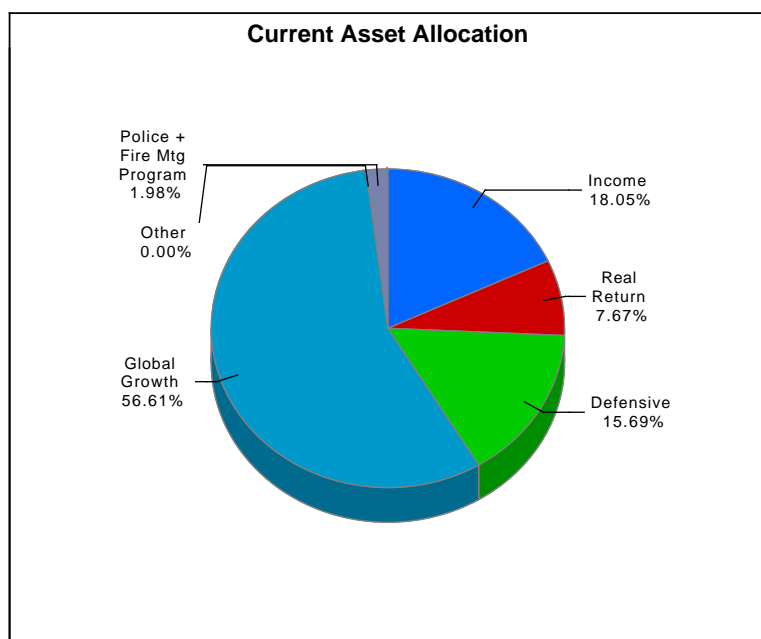

As of February 29, 2024**

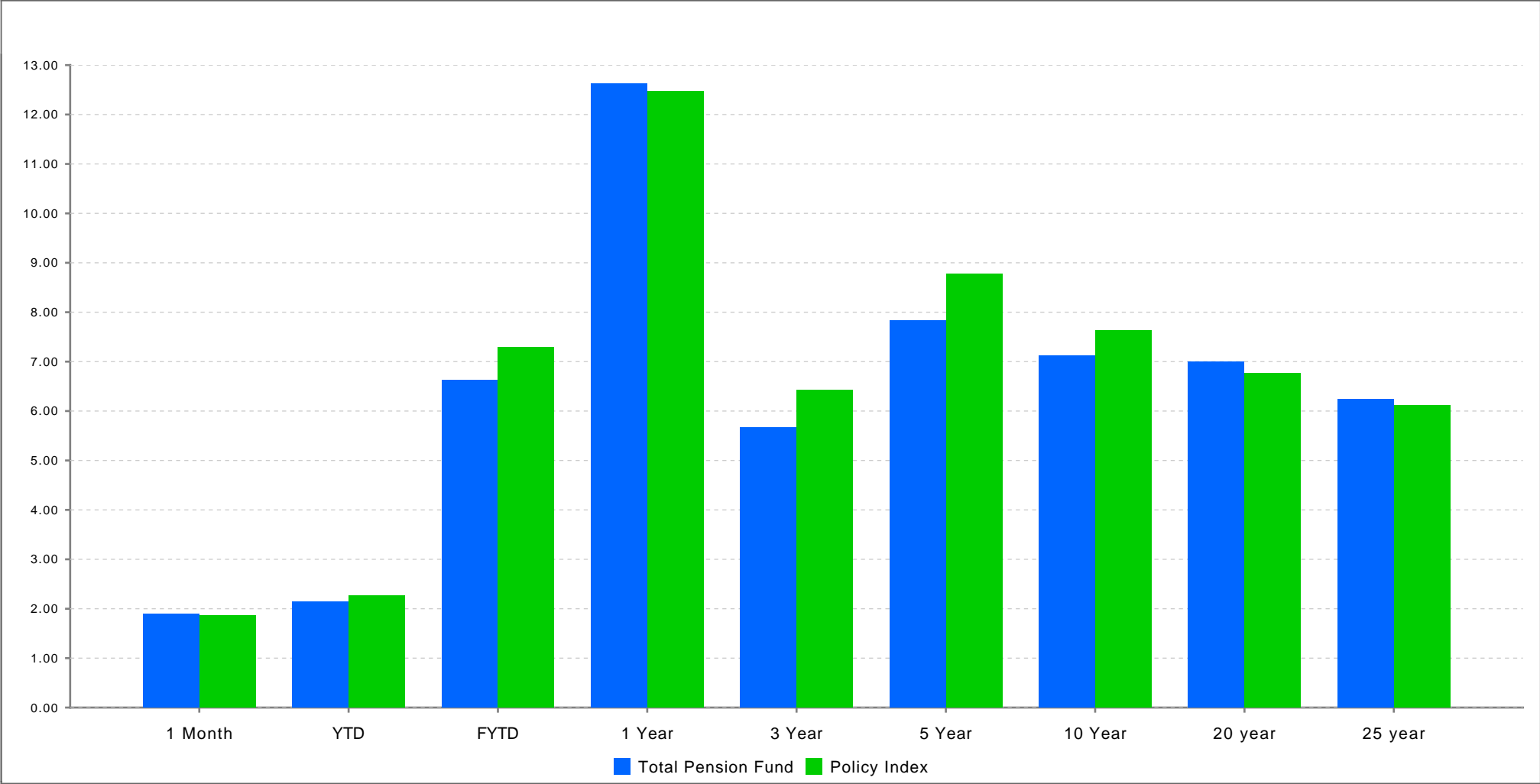

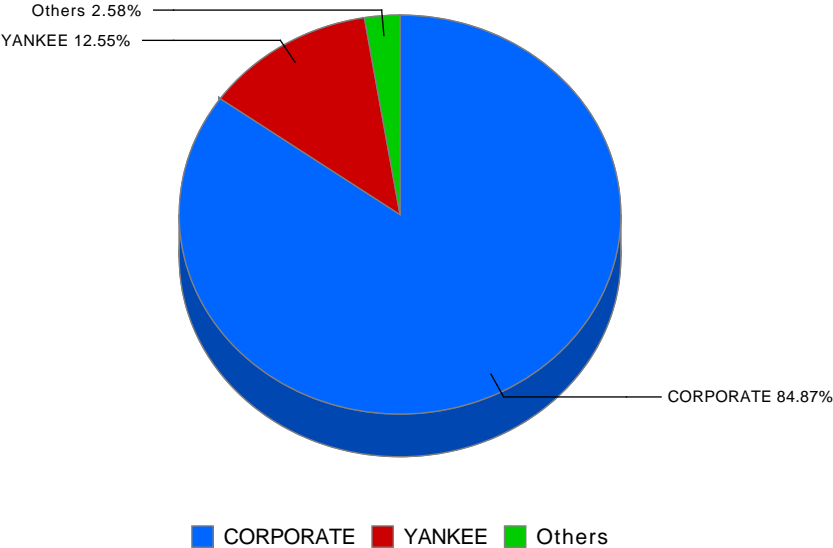
