


Project Priority List ("SFY2023 3rd Amended Transportation Bank PPL")

The New Jersey Infrastructure Bank (the "I-Bank") and the New Jersey Department of Transportation (the "NJDOT") are pleased to present the **SFY2023** <u>3<sup>rd</sup></u> **Amended** Transportation Financing Program Project Priority List (the "PPL") to the New Jersey State Legislature pursuant to the New Jersey Infrastructure Trust Act N.J.S.A. 58:11 B-1 et seq. ("the Act"). The New Jersey Transportation Infrastructure Financing Program (the "Transportation Bank") is a joint financing program between the I-Bank and the NJDOT. The PPL is a compilation of all eligible projects for which an application has been submitted to the Transportation Bank for financing on or before December 31, 2022, and which have not already received long-term financing. The Act authorizes the I-Bank to amend the PPL four times during the State fiscal year. The PPL for SFY2023 was originally submitted to the Legislature in January 2022, in preparation for the upcoming program year. This submission serves as the third such amendment.

The Act established the Transportation Bank to make low interest loans for local transportation infrastructure projects with a mission of reducing the cost of financing critical transportation projects for New Jersey counties and municipalities.

The SFY2023 <u>3rd</u> **Amended** Transportation Bank PPL, set forth in Appendix A, consists of **27 projects** with an estimated value of \$135.4 million. As of January 14, 2023, 16 of these projects totaling \$68.6 million have been allocated funds and are currently undergoing engineering design or construction activities. The new funding allocations for this 3rd quarter of SFY2023 are limited to projects that demonstrate a high likelihood of awarding construction within 12 months, on or before December 31, 2023. Four (4) projects met this requirement and received funding allocations in early January 2023 with an estimated value of \$14.3 million for a total allocation amount of **\$82.9 million**. Lastly, seven (7) projects totaling \$52.6 million have submitted applications and are awaiting allocation.




